

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds.

BORDER CROSSING

Government regulations require that to be brought into Canada, a dog must have a current Rabies Certificate dated at least 30 days prior to entry.

EVENT REGISTRATION NUMBER

(Foreign Born/Foreign Owned Dog)

For the purpose of entering CKC events to obtain Championship status and Obedience Titles and Degrees, individual registration is no longer required for foreign born, foreign owned dogs. Foreign exhibitors may apply for an ERN (Event Registration Number). This number MUST be applied for within 30 days of obtaining points, scores or awards to avoid cancellation. Exhibitors may submit a photocopy of the dog's foreign Registration Certificate and the appropriate fee along with a letter of request to the CKC. This ERN number replaces a CKC Individual Registration Number for entering CKC events ONLY.

Exhibitors eligible for trophies must notify the Trials Chair prior to showing. All prizes will be awarded for qualifying scores only. The exhibitor or a representative must be present when prizes are awarded.

Both trials – The Victoria City Kennel Club offers Rosettes to 1st, 2nd, 3rd and 4th place qualifiers in each class.

ENTRY FEES

CLASS FEES:

\$25.00 per dog per trial (GST incl.)
\$10.00 for Exhibition Only (GST incl.)

LISTING FEES:

\$ 8.40 (GST incl.) for each trial for dogs eligible for but not possessing individual registration with the Canadian Kennel Club. (Sec. 6.1.4)

The club must reject an incomplete entry form and promptly return it to whomever submitted it, be it the owner, lessee or authorized agent. (Sec. 6.2.2)

The entry of a dog at a trial must be accompanied by the entry fees. (Sec. 6.3.2)

Tendering of a dishonoured cheque in payment of entry fees shall be considered non-payment and is an offence punishable by disciplinary action and cancellation of awards. (Sec. 6.3.3)

Conditional entries or entries accompanied by post-dated cheques will not be accepted.

FEMALES IN SEASON

When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10 day period preceding the trial, must reach the trial secretary on or before the date of the trial. The entry fee, service charge and listing fee will be refunded. (Sec. 6.5.2)

CLASSIFICATIONS

The following CLASSES will be offered in both trials: RALLY NOVICE A & B, RALLY ADVANCED A & B, RALLY EXCELLENT A & B and EXHIBITION ONLY.

Judging order will be determined at the close of entries.

JUDGING SCHEDULES

Detailed Judging Schedules will be sent to entrants after the closing date.

Wherever possible, entry confirmations and judging schedules will be sent by email.

DISCIPLINE

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a trial held under the CKC Rally Obedience Trial Rules and Regulations, is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. (Sec. 17.7)

RULES AND REGULATIONS

It is the responsibility of each competitor to be familiar with and abide by the Canadian Kennel Club Rally Obedience Trial Rules and Regulations effective January 1, 2007.

INDOOR CRATING

There will be limited room for crates in the building for Rally Obedience competitors only.

RULES GOVERNING ALL RALLY OBEDIENCE TRIALS

1. Dogs must be kept under control at all times and on leash at all times within the building with the exception of the rally obedience ring. No dogs will be allowed within the trial precincts during the trials unless officially entered with the exception of Certified Assistance Dogs.
2. Collars other than those specified in these rules are not allowed within the ring. Collars used in rally must be the same as those accepted for use in obedience trials. (Sec 8.16.1)
3. The Victoria City Kennel Club will use all reasonable care to ensure the safety of the dogs exhibited but will not be responsible for or assume any liability for loss or injury to any dog or exhibitor. If for any reason beyond the control of the Club it is impossible to open or complete the trials no refund of entry fees will be made.
4. Dogs must be judged in catalogue order to the extent that it is practical to do so. Judges are not required to wait for dogs. (Sec. 8.6)
5. To be eligible to enter in the Rally Novice A, Rally Advanced A, or Rally Excellent A class a dog must not have previously earned a CKC Novice Obedience title. The handler of any dog in these classes must be the owner, co-owner or a member of their immediate families. (Secs. 9.1.1, 10.1.1, 11.1.1)
6. A dog which has earned a comparable CKC rally obedience title is not eligible for entry in the respective Rally Novice A, Rally Advanced A, or Rally Excellent A classes. Such dogs must be entered in the "B" classes if eligible. (Secs. 9.2.1, 10.2.1, 11.2.1)
7. Every dog entered in an approved rally obedience trial must be registered with the CKC or be eligible for registration with the CKC, or must have one of the following: a) an Event Registration number, or b) a Performance Event number, or c) a Miscellaneous Class Certification number (MCN) if it belongs to a CKC listed breed. (Sec 6.1.1)
8. Please keep the building and grounds clean. Please pick up after your dog.

The PRECINCTS of these trials will be the RCMP Building.
