\$10.50 Listing Fee* for EACH TRIAL. *This is only paid if the entered dog is eligible for but does not possess individual registration with the Canadian Kennel Club.

No "Day of" Entries

ONLINE AND PAPER ENTRIES AVAILABLE

The entry of a dog at a trial must be accompanied by the entry fee. Conditional entries or entries accompanied by post-dated cheques will not be accepted.

The club must reject an incomplete entry form and promptly return it to whoever submitted it, be it the owner, lessee or authorized agent.

Tendering of a dishonoured cheque in payment of entry fees shall be considered non-payment and is an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club.

Payment of Fees: Make cheques payable to FPO&TC or send e-transfer to FPOTCRally@gmail.com Information for e-transfer payment will be given after your entry has been submitted.

<u>ATTENTION: FOREIGN EXHIBITORS:</u> Please purchase Bank Drafts of Money Orders Payable in CANADIAN DOLLARS. Personal cheques must be payable in US dollars. Please do not mark them payable in "Canadian Funds" or "at par" as such items are not readily cleared through banks.

Rules & Regulations: It is the responsibility of each competitor to be familiar with and abide by the Canadian Kennel Club Obedience Trial Rules and Regulations Effective January 1, 2018.

Discipline: Forbidden Plateau Obedience & Tracking Club reserves the right to remove any person from these trials. The Trial Chair shall have full control of this event which will be governed by the Canadian Kennel Club rules. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer or competitor at a trial held under the CKC Rally Obedience Trial Rules and Regulations, is not subject to indignities of any kind. The Rally Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Females in Season: When a bitch comes into season after entry of the bitch has been submitted to the trial secretary, a veterinarian's certificate, certifying that the bitch was in season within the 10 day period preceding the trial must reach the Trial Secretary on or before the date of the Trial. The entry fee, service charge and listing fee will be refunded.

Non-Member Participation Fee: Canadian Resident non-CKC members competing with a wholly owned dog cannot win an award or title unless they pay a non-member participation fee or a membership fee to the CKC. The Canadian Resident Non-member Participation Fee is \$62.40 plus GST. These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

Move Ups: A dog that has fulfilled the requirements for a title in accordance with the CKC Obedience Trial Rules, may be moved to the next level of competition. The transfer must be submitted to the Trial Secretary on the appropriate move-up form by the owner or handler ONE HOUR PRIOR TO THE COMMENCMENT OF THE TRIAL, schedule permitting.

RALLY OBEDIENCE CLASSES

No dog may be entered in both the "A" and "B" Class at the same level in any one trial.

Rally Novice A

Dogs competing in this class may not have earned the R.N. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through it CKC C.D.X. title shall be eligible to enter this class. The handler of any doge in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Novice B

Any dog may compete in this class until a qualifying score in the Rally Advanced Class is earned. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Intermediate

This class shall be for dogs that have earned the R.N. title. A dog completing the R.I. or any other obedience or rally titles may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Advanced A

This class shall be for dogs that have earned the R.N. title but have not earned the R.A. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Advanced B

This class will be for dogs that have earned the R.N. title. A dog completing the R.A. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Excellent A

This class shall be for dogs that have earned the R.A. title, but have not earned the R.E. title or any CKC Obedience title other than P.C.D.. No handler who has exhibited a dog through its CKC C.D.X. title shall be eligible to enter this class. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families. A person may enter more than one dog in this class.

Rally Excellent B

This class will be for dogs that have earned the R.A. title. A dog completing the R.E. title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rally Master

This class will be for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

Rules Governing These Trials

- Dogs must be kept under control at all times and on leash at all times within the building with the
 exception of the rally obedience ring. Only dogs entered in the regular classes or for exhibition only
 are allowed within the precincts of these trials.
- 2. Collars other than those specified in these rules are not allowed within the venue. Violation of this rule may result in removal of the dog from further competition at the trial.
- 3. Forbidden Plateau Obedience & Tracking Club will use all reasonable care to ensure the safety of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, loss or other misfortune to dogs, exhibitors or patrons. The welfare of an exhibitor's child is to be the responsibility of the exhibitor. It is distinctly understood that exhibitors will exercise control and restraint over their children during these trials.
- 4. If for any reason beyond the control of the Club it is impossible to open or complete the trials no refund of entry fees will be made.
- 5. Judges are not required to wait for dogs. It is the responsibility of each handler to be ready with his dog at ringside when required, without waiting to be called.
- 6. Eligibility to enter specific rally obedience classes is detailed in the Rally Obedience Trial Rules and Regulations. Entrants should review these requirements before entering the trials to ensure they are entered in the correct class. FPO&TC will not be held responsible for incorrect entries.
- 7. Every dog entered in an approved rally obedience trial must be one of the following: registered with the CKC; have an Event Registration, Performance Event or Canine Companion number; eligible for registration with the CKC; or, have a Miscellaneous Certification number if it belongs to a CKC listed breed.
- 8. Please keep the building and grounds clean. Please pick up after your dog.
- 9. Forbidden Plateau Obedience & Tracking Club will be offering Rosettes to the Highest Qualifying Score in each class.

The VENUE and PRECINCTS of these trials will be the Union Bay Hall Crates are allowed in designated areas only
