Directions to Lindsay Central Exhibition Fairgrounds: The entrance to the Lindsay Central Exhibition Fairgrounds is located at 354 Angeline Street South in Lindsay, Ontario.

From Highway 401: Go east or west on Highway 401 to Highway 35/115 exit. Take Highway 35/115 north to the Highway 35 exit, to Lindsay. Turn left (west) onto Highway 7, just south of Lindsay. Turn right onto Angeline Street/County Rd. 4 (first traffic light). Turn right into the Fairgrounds
