CONDITIONS AND INFORMATION

PLEASE NOTE:

- On SATURDAY, we plan to run the Official OPEN stakes to completion in the morning. Singles will run after the completion of the official stake. Roll call for Singles will be the same as for the Official classes. The conformation part of the show will commence one half hour after the completion of the Singles runs.
- On SUNDAY, Roll call for Singles will **not** be **before** 12.30 p.m. Please see the cover page for the close of Post Entry and Roll Call times.
- **Rolling Inspection** – Check in for Inspection as you arrive, with your dog(s). Inspection ends ½ hour after entries close each day (Roll Call). It is your responsibility to take your dog for inspection prior to Roll Call.
- **<<PLEASE SEE LAST PAGE FOR AN INVITATION TO A BBQ ON THE FIELD AFTER THE SHOW ON SATURDAY>>**. Please let Show Secretary or Ed and Ivy Molloy (780-922-5218) know if you plan to attend.
- The field is a mown hay field, flat on the west side, sloping towards the road.
- All hounds will be run in trios or braces, twice, unless excused, dismissed or disqualified.
- Hounds not present at roll call will be scratched, and their entry fee will NOT be refunded. No exceptions will be made.
- All handlers MUST use a slip lead when releasing their hounds.
- Hounds may wear muzzles and/or catch collars at the owner/agent's discretion.
- Bitches in season and lame hounds will be excused and will have their entry fee returned if notice is given to the secretary **prior** to roll call. A Veterinarian certificate may be required.
- The Chairman may excuse any hound from competition for any reason deemed justifiable.
- A \$10.00 fine, payable to ALCA, will be levied for any hound loose on the field at any time between Roll Call and the completion of Best in Field or Regular classes.
- There is limited shade and no water available, so come PREPARED.
- Best in Field will be offered only on Sunday, September 6, 2015. Breed Winners from both Saturday and Sunday will be eligible to compete.
- There will be limited overnight camping. Please contact Ed Molloy to reserve your spot. (780-922-5218).
- There will be a concession with home cooking and baking available on the field.

EQUIPMENT AND FIELD CONDITIONS

An electric drag will be used for the Regular Classes and Singles.

A continuous loop may be used for the Puppy and Veteran stakes.

Attention all Foreign Exhibitors!

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). This ERN does not register a dog with the CKC for breeding purposes as defined in the Animal Pedigree Act but rather enables foreign-born and foreign-owned dogs to be awarded titles by the CKC. Each dog must have its own number. To obtain an ERN mail or Fax a copy of the dog's registration certificate with payment in the amount of \$58.85 Canadian funds, payable to the CKC. This ERN must be applied for within 30 days of the first day of entering a CKC event to avoid cancellation of Awards. Non-Member Participation Fee

24-12-3. Non-member participation fee

- a) An **annual** non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) The Premium List must carry a note stating that “ these fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.”

It is in your best interest to acquire a Basic CKC membership at \$50 + GST to cover all your dogs as opposed to the Non-Member Participation Fee of \$55+GST per dog.

CERTIFICATION RUNS

ALCA will hold Certification runs **by appointment only** Friday evening. Cost is \$15.00. Please make your own arrangements for a suitable dog to run yours with. Call Ed at 780 922-5218 to make the arrangements.

CKC definition:

7.1.1 (a) A hound must be tested with another dog, not a kennelmate, preferably of the same breed, and certified running clean by a licensed judge. Hounds must be a minimum of 11 months old prior to being certified, and must run a normal course of 600 yards (548.4 m) in order to be certified.

ELIGIBLE COURSING ENTRIES

To be eligible for this trial, your dog **MUST** be a purebred of one of these following breeds:

AFGHAN, BASENJI, BORZOI, DEERHOUND (SCOTTISH), GREYHOUND, IBIZAN, IRISH WOLFHOUND, ITALIAN GREYHOUND, PHARAOH, SALUKI OR WHIPPET.

All entrants must be registered or be eligible for registration with the Canadian Kennel Club.

Altered or neutered hounds **may** compete. Hounds presently disqualified under C.K.C., CSFA, ASFA or AKC rules are not eligible. **Hounds must pre-qualify prior to entering their first trial in Canada.**

ELIGIBLE CONFORMATION ENTRIES

Open to any AFGHAN, BASENJI, BORZOI, GREYHOUND, IBIZAN HOUND, PHARAOH HOUND, SALUKI, SCOTTISH DEERHOUND, WHIPPET, IRISH WOLFHOUND, ITALIAN GREYHOUND that has earned a qualifying score in the preceding lure course, except those with breed standard disqualifications. A hound excused, dismissed, disqualified, scratched, or not scored in the lure trial is not eligible to compete in the conformation show.

All entrants must be registered or eligible for registration with the CKC.

Altered and neutered dogs may compete in the ALTERED class only.

NOTE:

If your dog is **NOT** certified to compete in coursing events prior to the closing date of the show and you pre-enter, you must bring the signed CKC Hound Certification Form with you to the Trial. If the dog is **NOT** certified by the start of the Trial on September 5, 2015, your dog will not be able to compete and there will be **NO** refund of any entry fees.

COURSING STAKES OFFERED

BREED AND MIXED. STAKES

Mixed Stake is for multiple breeds with entries of 3 or less upon ALL owner's agreement.

LURE TRIAL OFFICIAL CLASSES OFFERED

OPEN - Offered for all eligible hounds one year of age or older on the day of the trial, including Field Champions of Record.

LURE TRIAL UNOFFICIAL CLASSES OFFERED

Best In Field: Offered on Sunday September 6, 2015 only, to include all Best of Breed or Mixed Stake winners from both Saturday and Sunday.

UNOFFICIAL CLASSES

Singles Competition

Is your dog DQ'd, declared ineligible or not ready for running in competition, but you would like your dog judged? This is the place to be! Dogs will be run individually and scored. They will run as indicated previously. A random draw will determine the order of running of dogs in this stake. Dogs must wear a blanket. No points are awarded and all ties will be settled by a coin toss. A ribbon will be awarded to 1st to NBQ. Your dog will be only given TWO opportunities to chase the lure each time it comes to the line. Handlers will not be able to run/walk the course with their hounds.

Entries will be limited to 10 on Saturday, September 5, 2015 and 15 on Sunday, September 6, 2015.

Puppies and Veterans, run singly (Sunday after completion of Singles).

Entry must be received by 12.00 p.m. Sunday.

Kennel, Club and Breeder Stakes

Entry must be received by 9.00 a.m. Sunday, September 6, 2015.

FIRST TIME ENTERED HOUNDS

Effective July 1 1998, hounds entering their first trial in Canada must be tested with another hound, preferably not a kennel mate, and certified running clean by a licensed judge. The CKC Hound Certification Form (included with this premium list) must be completed and **submitted with the entry at the hound's first trial.**

Hounds with the following titles are exempt: ASFA FCh or VFCh, AKC FC, SC or DC, but are still required to submit the Hound Certification Form with their name and exempt titles circled.

ROLL CALL TIMES AND RUNNING ORDERS – NOTE the CHANGE

We are offering a Rolling inspection between the time you arrive and Roll Call for both the official classes and singles.

Official Class Coursing ONLY Post Entry closes at 8.30 a.m. on **Saturday and Sunday**. Roll Call at 9:00 a.m.

Singles Post Entry closes at 8.30 a.m. on **Saturday** and **12.00 p.m. Sunday**. Roll Call is with official stakes on Saturday, and not before 12.00 p.m. on Sunday.

Breed running order will be posted at Roll Call.

Puppy Stakes and Veterans will be run **AFTER SINGLES** on Sunday.

Best in Field will be run on Sunday only. It includes all Best of Breed and Stake winners from both Saturday and Sunday. It will be run **BEFORE SINGLES**.

PRIZES

Field Trial

Rosettes and a Trophy will be awarded to **BOB** and **BIF**.

Rosettes will be awarded to **First** through **NBQ** placements.

A Qualifying Ribbon will be offered for each **qualifying score** earned by a hound which has not previously earned the Novice Courser Title. Please let the Field Trial Secretary know if your hound qualifies.

A Rosette will be awarded to the highest scoring **Singles** run dog.

A Ribbon will be awarded to **2nd** to **NBQ** for the **Singles** run.

A Rosette will be offered for the winner of each of the **Kennel, Breeder** and **Club** stakes.

A Rosette will be awarded for **Highest Weekend Aggregate Score for a Hound competing in its First Trial** (Total of qualifying scores for the weekend, adjusted for judge's averages).

A Rosette will be awarded for Best Puppy in field. Ribbons for 1st to NBQ in each age group will be awarded.

2015 Aggregate Award: A large Rosette & Trophy will be awarded for High Point Aggregate. This will be awarded to the hound entered and qualifying in **all** five ALCA trials for 2015. Award will be determined by total qualifying scores adjusted for judges' average.

Ribbons and trophies not collected on the field will not be mailed. They will be considered a donation back to the club.

Extract from CKC Field Trial Rules and Regulations for Lure Coursing

Chapter 9.5 Placements and Awards

9.5.1 Hounds which are not to be scored are not to be added to a course.

9.5.2 Championship points in regular stakes shall be awarded on the basis of the following:

First Place:

Four times the number of hounds competing in the stake with a maximum of 40 points.

Second Place:

Three times the number of hounds competing in the stake with a maximum of 30 points.

Third Place:

Twice the number of hounds competing in the stake with a maximum of 20 points.

Fourth Place:

Points equal to the number of hounds competing in the stake to a maximum of 10 points.

Next Best Qualified Dog (NBQ):

No points awarded.

Qualifying Score (QS)

No points awarded.

9.5.3 A hound shall not receive a placement or be awarded points if it does not score at least 50 per cent of the total possible combined scores. Hounds which do not receive placements under this provision will, nevertheless, be considered as having been in competition for the purpose of awarding points. If a hound is excused in the preliminary run, that hound will not count as having been in competition when computing championship points. Hounds that are dismissed or declared ineligible shall count as having been in competition when computing championship points.

ATTENTION

It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteers or any participant at the event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on the receipt of a report indicating that this has occurred.

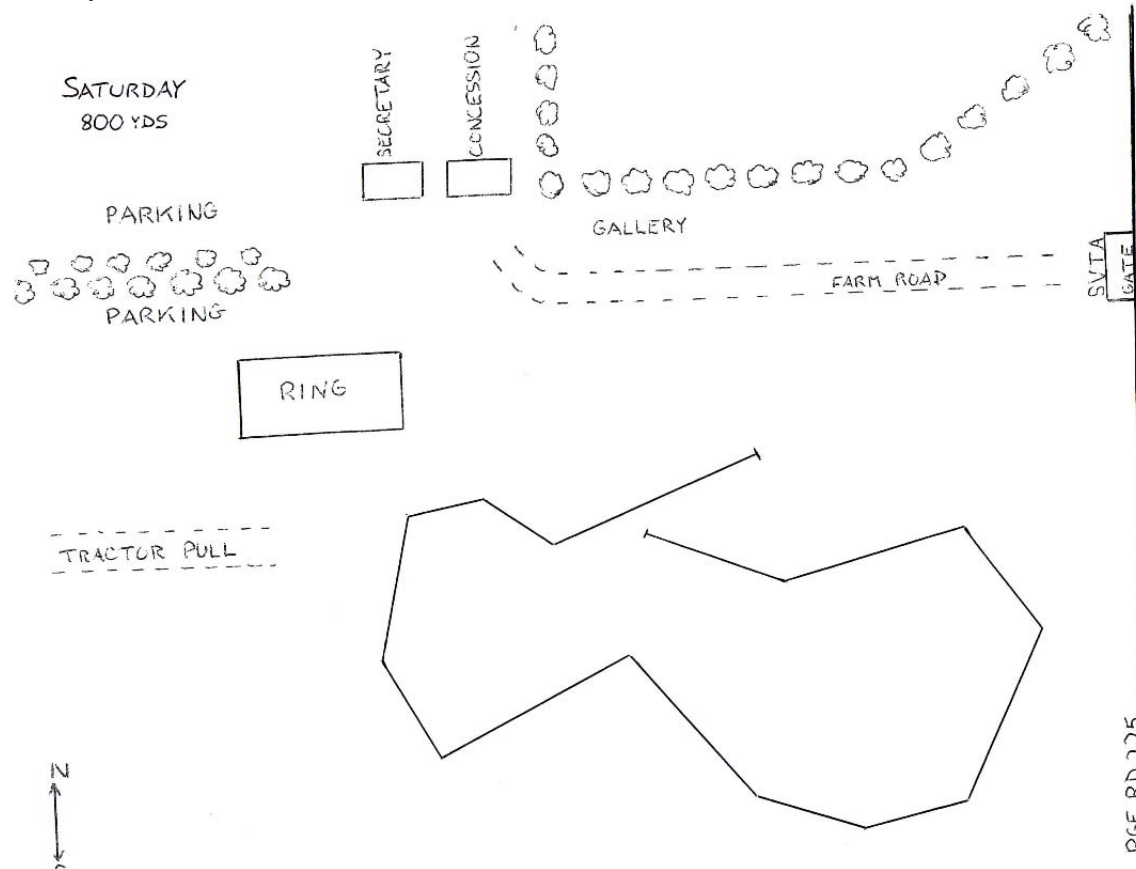
9.7.3 Course plans which have been altered from those published in the premium list must be posted on the field in a prominent location. A test run must be announced and made immediately before or after roll call. Any person who, after seeing the test run with the course plan alterations, decides not to run his hound has the option of withdrawing his entry and having the entry fee refunded.

NOTE: NO refunds will be offered prior to the running of the test dog. NO refunds will be offered for the puppy or veteran run prior to course setup.

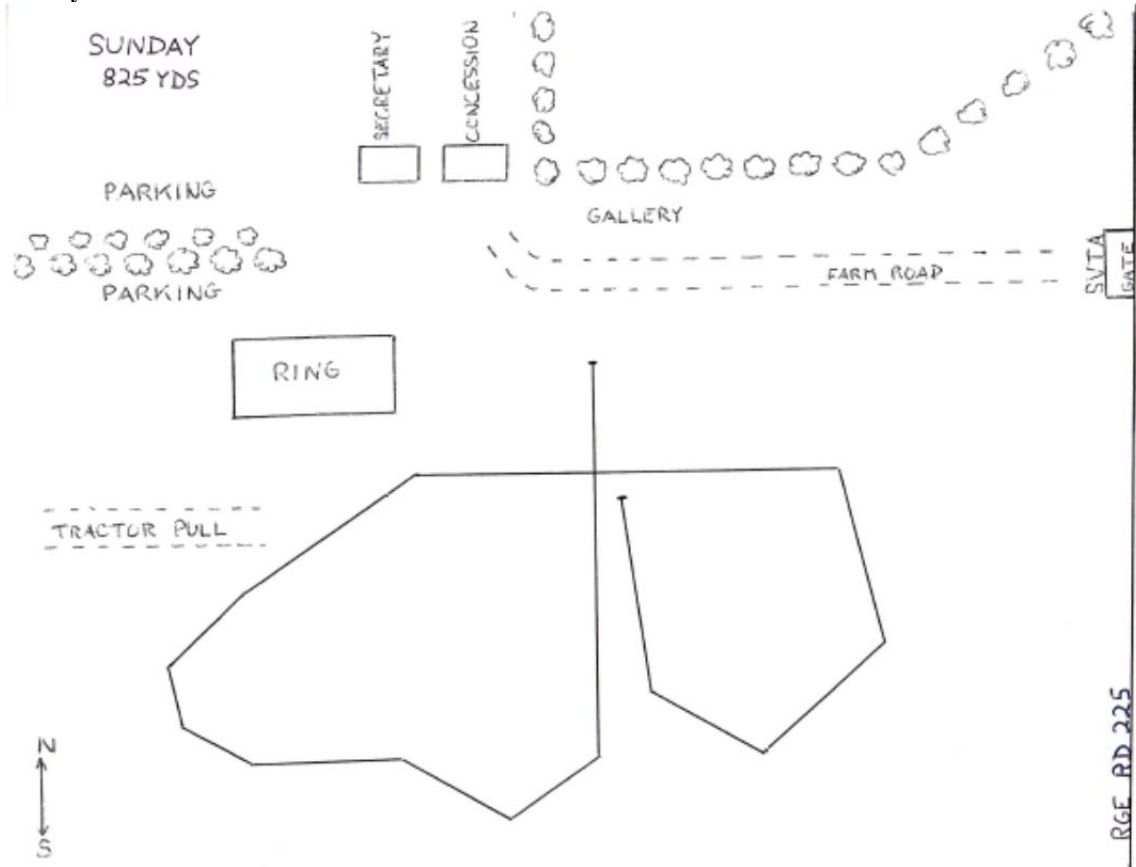
COURSE LAYOUTS
