#### NON-MEMBER PARTICIPATION FEE

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non-member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number.

In order to protect the Awards and Titles earned, the "non-member" will have a choice to (a) either become a CKC member; or (b) pay the "non-member" participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled.

Please Note: These fees only apply to dogs wholly owned by "Non-CKC" members and are not applicable to CKC members.

NO POST DATED CHEQUES ACCEPTED. ALL NSF cheques are subject to a charge of \$25.00. N.S.F. cheques are considered Non-Payment of entry fees and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the shows/trials.

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted, however, they are to be payable in Canadian Funds. If you send a cheque in US Funds it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable In Canadian Funds", they will not be cleared by the banks. To simplify the process, we urge you to purchase bank drafts or money orders payable in Canadian Funds. Your understanding and cooperation is appreciated. Thank you.

**INCOMPLETE ENTRIES WILL BE RETURNED.** Agents and handlers please note that the **full name and address of owners MUST be filled in** and to whom ID's are to be returned. (Section 13.1.2 Dog Show Rules)

#### CONFORMATION CLASSES

Junior Puppy A dog 6 months up to 9 months on the day of the show. Senior Puppy A dog 9 months and up to 12 months on the day of the show.

12-18 Months A dog between 12 months and up to 18 months on the day of the show.

Canadian Bred A dog which was born in Canada.

Bred by Exhibitor A dog owned and handled by the breeder.

Open Class A dog 6 months of age or older Specials Only Dogs who are Canadian Champions.

Exhibition Only Dogs 6 months of age and over not in competition. Dogs 3 months of

Age and under 6 months on the day of the show may be entered in

Exhibition Only providing that the owner of the puppies has also entered a dog in one of the Regular official classes. No exhibitor may enter more than 2

puppies.

Champion & Championship Points ~ Chapter 1 Section 1 ~ A dog awarded Winners at a Championship Show held under these Dog Show Rules shall be credited with a number of Championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

A class dog awarded Best In Show at an All Breed Championship Show will be credited with five points inclusive of any points won at the Breed or Group level. In no case may a dog earn more than five points at a single show. **NOTE: In counting the number of eligible dogs in competition a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall <u>NOT</u> be included in the calculation of Championship points.** 

## CONFORMATION MOVING UP TO SPECIALS

A dog individually registered in the records of the CKC and has completed the requirement for a Championship in accordance with CKC Rules, after the closing date and time for the show, may be transferred from one of the Regular Classes to "specials Only", providing the request is submitted to the Show Secretary in WRITING and on the appropriate form at least one hour prior to the opening of the show, by the owner or handler. When one or more Championship shows are held on the same day, in the same venue, the request for moving a Class dog to Specials must be made a minimum one hour prior to the scheduled start of the show for which the dog is being moved up.

## BITCHES IN SEASON REFUND

Bitches coming into season MAY NOT compete in Obedience. Entry fees will be refunded ONLY if the Trial Secretary receives a Veterinarian's Certificate PRIOR to the commencement of the Trial.

## OBEDIENCE TRIAL MOVE UP

A dog that is individually registered in the records of the CKC and has fulfilled the requirements for a title in accordance with Section 9.4.2 and 10.4.2 of the Obedience Rules may be moved up to the next level of Obedience Competition providing the transfer was submitted to the Trial Secretary in WRITING, by the owner or handler, one hour prior to the opening of the first trial. When one or more trials are held on the same day in the same venue, the request for moving the dog up must be made a minimum of one hour prior to the scheduled start of the trial for which the dog is being moved up, TRIAL SCHEDULE PERMITTING.

## **EVENT REGISTRATION NUMBER (ERN)**

All dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will require and Events Registration Number (ERN). To obtain an ERN simply do the following:

 send a photocopy of the dog's Registration Certificate reflecting current ownership, for example AKC Registration Certificate with a written request for

an ERN.

2. Include with the above a cheque or money order in the amount currently

required payable to the Canadian Kennel Club.

3. Ensure that you provide the CKC with your full return address to enable the

ERN to be sent to you

4. Faxed requests will be accepted. Please indicate your VISA/MasterCard

number and expiry date, the card holders name and signature.

This Event Registration Number **MUST** be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "LISTED", however, failure to apply for an ERN within 30 days will result in cancellation of any wins, awards or scores.

## GENERAL INFORMATON

- The Show Superintendent will be in complete charge of these events, which are governed by CKC rules
- 2. The Building will be open at 5:30 P.M. Friday 27 Sept 2013 for set up. The building will open daily at 7:00 a.m. & close at 10:00 p.m.
- 3. To comply with CITY OF MIRAMICHI & TOWN OF SUNNY CORNER regulations NO SMOKING WILL BE PERMITTED WITHIN THE CONFINES OF THE BUILDING.
- 4. Dogs should be on standby at their respective areas 30 minutes prior to commencement of judging. Judges are not required to wait for late arrivals and will adhere as closely as possible to the Judging Schedule. There will be no PA system used to call dogs to the ring. It is the responsibility of the owner/handler to advise that a dog is absent.
- 5. No "Puppy or Dog For Sale" signs will be permitted in the building.
- 6. The Miramichi Kennel Club will use all care and diligence for the welfare of the dogs and the exhibitors, but will not be responsible for, nor assume liability, in the event of an accident or any misfortune to either dog, exhibitor or patron.
- 7. If because of riot, civil disturbance or other acts beyond the control of the management, it is impossible to open or complete the show, no refund or return of entry fees will be made.
