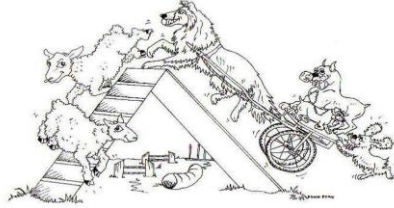

## **ENTRY INFORMATION**

**PLEASE NOTE: This is a limited trial.**

**Entry fee is \$45.00 for Test or Trial classes.** Pre-Entries close on Tuesday, May 7, 2019 at 8 pm at the home of the Trial Secretary or when the limit of 40 entries (HCT, JHD, and HTAD combined) has been reached. After May 7th, entries will be accepted on a first come, first served basis up to and including 7:30 a.m. on the day of the trial, (if there are still openings), at a cost of **\$50.00** per run.

**ENTRY REQUIREMENTS:** Every dog entered in an AHBA approved herding test or trial must be on the list of breeds accepted by AHBA (breeds are listed on the AHBA website). All dogs must be at least 6 months of age for test classes and at least 9 months of age for trial classes.

**ENTRY FEES: - Pre-entry \$45.00 per entry – Test or Trial Classes.  
After May 7, 2019 \$50.00 per run subject to availability**

If you are sending entries by courier or ExpressPost, please make sure that you do not require a signature.

**ATTENTION US EXHIBITORS:** Please note that fees are due and payable in Canadian Dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however; they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry fee and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks and we will not accept them as an entry. To simplify the process we urge that you purchase a bank draft or money order payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you.

No entry will be accepted unless accompanied by the appropriate fee. Post dated cheques will not be accepted and will be returned. E-mailed entry forms will be accepted (scanned not pictures) and must be paid by e-transfer. Phone or fax entries will not be accepted.

## RULES

1. We will use care and diligence for the welfare of all dogs and exhibitors, but will not be responsible for, nor assume liability in the event of an accident or misfortune, however caused, to dogs, exhibitors or property.
2. Dogs must be kept under control at all times & must be kept on leash or crated except when competing.
3. The AHBA shall not be responsible to any member, person, partnership, club or corporation for any loss, damage or injury arising at or by reason of any herding test/trial held under any rules adopted by the AHBA.
4. Exhibitors will be responsible for picking up after their dogs.
5. Dogs may be shown on a plain buckle collar, quick release collar or no collar,
6. Exhibitors must sign the waiver form before being allowed to compete.
7. Events will be held rain or shine. Dress for the weather. Water will be available for dogs to cool off in. There is limited shade. Exhibitors are advised to bring their own shade, crates, etc
8. Exhibitors are solely responsible for the conduct or actions of their dogs while they are on the trial grounds. **All dogs must be kept on leash or in crates except when competing.**
9. **You must use a separate entry form for each dog and for each class. If all classes are shown on the same entry form, or there is more than one dog on the entry form, then the entry will be returned.**
10. **STOCK:** Sheep - St Croix x Khatadin. Groups will be mixed sheep  
Ducks – Rouen or Khaki  
Test runs will have 3 sheep. HTAD Trial runs will have 5 head of stock.
11. **HTAD Tie Breakers:**
  1. Best Gather Score
  2. Best Re-Pen Score
12. **Start time:** Handlers' Meeting at 7:45 am – 1<sup>st</sup> dog at 8 am
13. Judges will take a lunch break, at their discretion.

# HERDING TRIAL ARENA DOG COURSE

This Trial will use HTAD Course #3

---

## DIRECTIONS TO TEE CREEK

### FROM TORONTO:

Take QEW Fort Erie thru Niagara Falls. After McLeod Rd., the next exit is Lyons Creek Road. Take the West exit (go right) onto Lyons Creek Rd. Just as you are speeding up, there is a road on your left, (in other words make a right and then a quick left) onto Willodell Road. You are almost there! Go down Willodell Rd. approximately 2 miles. After you cross over Schisler Rd. (still on Willodell), we are the second place on the right. There is a large cover-all building up on the hill. Take the 2<sup>nd</sup> driveway or last driveway past the house, going back to the training center.

### FROM BUFFALO:

Take the QEW Niagara from the Peace Bridge. Take the Lyons Creek exit off of QEW. At the stop sign, turn left onto Lyons Creek Rd. Just over the overpass there is a road on your left. This is Willodell Rd. Turn LEFT onto Willodell. You are almost there! Go down Willodell Rd. approximately 2 miles. After you cross over Schisler Rd., (still on Willodell) we are the 2<sup>nd</sup> place on your right. Take the last driveway past the house and follow the driveway back to the training center.
