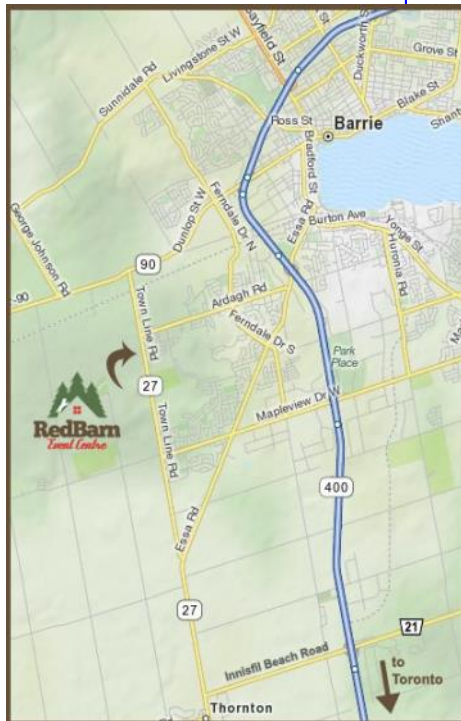

Directions to
The Red Barn Event Centre:

From the 400: Take the Essa Road exit. Turn west on Essa (sign says Essa Road South). Turn right at Ardagh Road. Follow Ardagh to County Road 27. Go South on County Road 27.(aka Town Line Road) Property is on the west side of the road down a long driveway. There is a private residence at the front of the property.

From CR 27 South: Follow CR 27 northbound through Thorton. Continue north. After 5 minutes, look for signs on your right that show you have to turn LEFT to stay on CR 27. When you see that sign, turn left, continue on CR 27. When you come down the big hill look for our white flags on the west (left) side of the road. If you get to lights at Ardagh, you’ve gone too far.

CKC Non-Member Participation	<p>Non-Member Participation Fee—\$59.40 + HST</p> <p>A non-member participation fee will be charged to a resident of Canada Who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.</p> <p>In order for the title to be awarded, the non member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.</p>

This fee will be charged for any entries that are not received in hardcopy.</p>

General Information	<p>Trial Secretary and Superintendent is in full charge of the Trials. The show precincts shall consist of the entire trial building..</p> <p>Food and toys are not permitted in the course area and handlers are not permitted to use whistles, clickers, flexis, prong collars or other instruments or devices inside the building.</p> <p>Bitches in season are also NOT permitted anywhere at the trial venue.</p> <p>Dogs must be ON LEASH at all times when outside the ring, in the building as well as on the trial grounds. PLEASE STOOP TO SCOOP!</p>
Event Information	<p>Agility ring is indoors on Top Agility rubber flooring</p> <p>Agility handlers in all classes will be able to walk their course, without their dog prior to the start of the class. Handlers must be ready at the start line when called or risk forfeiting their run. If a dog is not at ringside after it has been called 3 times, it will be marked absent. Please advise us ASAP if you have a conflict and we will accommodate your needs.</p>
Obstacles	<p>Obstacle familiarization will be NOT available. Obstacles shall meet the specifications in the CKC Agility Rules and Regulations effective January 1, 2014.</p>
Eligibility	<p>To be eligible to compete in the <u>agility trials</u>, a dog must be 18 months of age. ALL dogs may be registered or be eligible for registration with the CKC, have an ERN or CKC Miscellaneous Certificate or Performance Event Number (PEN) or CKC Mixed Breed Number to compete in agility. Spayed bitches, debarked dogs, and neutered males are eligible to participate.</p>
Bitches in Season	<p>Bitches in season <u>may not compete</u> and may not be anywhere on the grounds. When a bitch comes into season after the entry has closed a Veterinarian's certificate, certifying the bitch was in season within the 10-day period preceding the trial must reach the secretary on or before the start of the trial. A full refund of entry fees and listing fees will be given. However, if a credit card was used, the processing fee will not be refunded.</p>
Ribbons/Trophies	<p>Ribbons will be given for 1st through 4th qualifying scores in all Jump Heights in Agility trials .</p> <p>***NEW***To prevent an increase in entry fees, New Title Rosettes will be available at a cost of \$7.00. Tabs with the title name are still no charge.</p>
