**INFORMATION FOR EXHIBITORS**

1. Dogs without an individual registration number (RN) or event registration number (ERN) and entered with a Temporary Competition Number (TCN) are required to pay a \$10.50 listing fee (GST included)
2. A non-member participation fee, for awards and titles, will be charged to Canadian non-members of CKC. Exhibitors have the choice to become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in cancellation of awards and titles
3. Female dogs in season are not eligible for entry
4. Scratched entries will forfeit \$10.00 per entry when trial secretary is notified at least 24hrs prior to the starting time of test. 'No shows' or scratches within 24hrs of event start time will forfeit full entry. Female dogs in heat will be provided a full refund
5. If a dog is not present within 15min of being called to the line it may be disqualified
6. CKC Rosettes will be awarded to all qualifying dogs in each event
7. In hunt tests, gunners, throwers or handlers shall not wear distinctively white or light clothing
8. There shall be no training of dogs on the test grounds starting 24 hours prior to event and ending upon event completion
9. Draws for running order will take place at 7pm on Sunday July 9, 2023

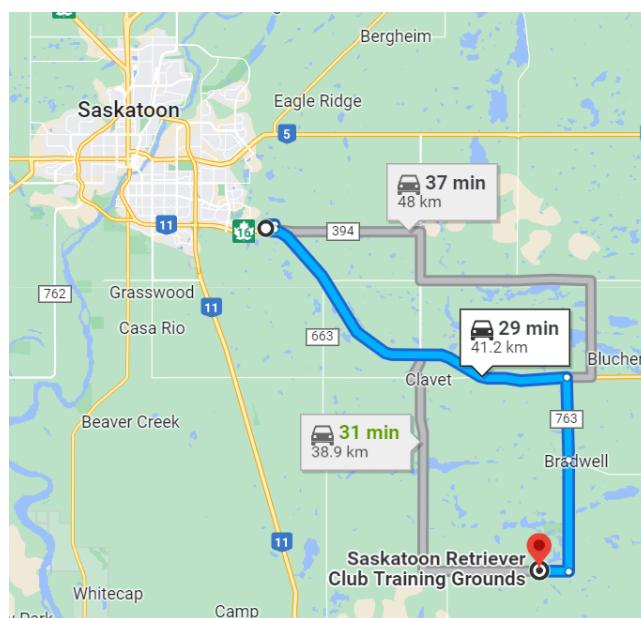
10. The catalogue with running order will be posted online (DogShow.ca, Canuck Dog and SRC website) by the evening of Friday July 14, 2023. Hard copies of the running list will be available at the SRC clubhouse throughout the event.
11. Local birds including but not limited to ducks, pheasants, chukars or guinea hens may be used. Live pigeons may be used for upland hunting test in Master Hunt Tests

## NOTICE TO EXHIBITORS

1. **Rule 3.8.1 of the Hunt Test rules and regulations** states “any person at a hunt test held under these rules shall not be subjected to any indignities of any kind during the progress of the hunt test. It shall be the duty and obligation of the club holding the hunt test to see that this rule is effectively carried out
2. The Saskatoon Retriever Club will not be responsible for any loss or damage to any dog or to any equipment, whether the result of an accident or otherwise. Furthermore, the Saskatoon Retriever Club will assume no liability in the event of an accident or other misfortune to event participants, bystanders, club members, workers or other individuals using the property for any purpose
3. **Release and indemnification of Landowners and the Saskatoon Retriever Club**  
By entering this event, each participant agrees to assume all risks and hazards incidental to participation in the event and agrees to release, save harmless and indemnify the owner(s) of the property upon which the event is held, together with their officers, agents, employees and representatives from all claims, actions, costs, expenses and demands in respect to death, injury, loss or damage to the person, dog or property of the participant howsoever caused, arising out of or in connection with the participant’s use or entry upon the property. It is understood that this agreement is binding upon the participant and all his heirs, executors and assigns.

2. Turn south on HWY763 and continue for 13km
3. Turn west on unnamed road (see Saskatoon Retriever Club sign) and continue for 2km
