# Day of Trial Entries must be received by 1 hour before the start of the trial, subject to availability

6.1.6 Subject to the provisions stated in these rules, no dog may be entered in any class for which it is not eligible at the time entries for the trial close. The entry of a dog that is improperly entered in a class for which it is not eligible cannot be altered to another class after entries close except as provided in section 6.9.6.

#### 6.9 Moving Up

- 6.9.1 A dog that is registered in the records of the CKC with an eligible number according to these rules and has fulfilled the requirements for a title in accordance with these rules may be moved to the next level of competition if the schedule permits. The transfer must be on the appropriate move-up form and submitted to the Trial Secretary by the owner or handler at least 15 minutes before the start of the class.
- 6.9.2 When move ups are permitted, clubs are exempt from the requirements of Section 4.3.4 and 4.3.5.
- 6.9.3 The Trial Secretary shall amend the judge's book and the marked catalogue, which is to be sent to the CKC with the requests attached to the appropriate entry forms.
- 6.9.4 If it is established by the CKC that a dog moved up to the next level has not completed the requirements for the lower level before moving up, then all qualifying ribbons and/or awards earned by the dog incorrectly entered shall be forfeited and cancelled by the CKC and the owner may be subject to disciplinary action.
- 6.9.5 In order for a dog to be eligible to move up, the dog must be individually registered with the CKC, have a Performance Event Number (PEN), or an Event Registration Number (ERN) before entries close. The addition of a CKC number after close of entries does not make the dog eligible and will result in referral to the Discipline Committee.
- 6.9.6 Exhibitors incorrectly entered in the A class are permitted to move the dog to the corresponding B or C class up to one hour before the start of the trial. Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial.
- 6.9.7 Exhibitors entered in the Open H classes are permitted to move to the Open 18 classes and vice versa up to one hour before the start of the trial.
- 6.9.8 Exhibitors incorrectly entered in the Novice B class are permitted to move the dog to the Novice C class up to one hour before the start of the trial I

9 Pre-Novice,

8 Novice,

7 Open,

6 Utility dogs per hour.

Please allow for **absentees** as these will affect the judging schedule. Judging will not begin prior to the hour scheduled; however, it may be later at the judge's discretion. It is the responsibility of the exhibitor to resolve any scheduling conflicts with the judge.

#### Obedience

Junior Pre-Novice - This class is for handlers 7 years of age on the date of the competition up to the date of their 11th birthday who have not achieved 500 score points in any Pre-Novice competition.

**Junior Novice** - This class is for handlers 7 years of age on the date of the competition up to the date of their 11th birthday who have achieved 500 score points in any Pre-Novice competition or for any junior of relevant age who wishes to compete in this class.

**Junior Open** - This class is for handlers 7 years of age on the date of the competition up to the date of their 11<sup>th</sup> birthday.

Intermediate Pre-Novice - This class is for handlers 11 years of age on the date of the competition up to the date of their 15th birthday who have not achieved 500 score points in any Pre-Novice competition.

Intermediate Novice - This class is for handlers 11 years of age on the date of the competition up to the date of their 15th birthday who have achieved 500 score points in any Pre-Novice competition or for any junior of relevant age who wishes to compete in this class.

Intermediate Open - This class is for handlers 11 years of age on the date of the competition up to the date of their  $15^{th}$  birthday.

Senior Pre-Novice - This class is for handlers 15 years of age on the date of the competition up to the date of their 18th birthday who have not achieved 500 score points in any Pre-Novice competition.

Senior Novice - This class is for handlers 15 years of age on the date of the competition up to the date of their 18th birthday who have achieved 500 score points in any Pre-Novice competition or for any junior of relevant age who wishes to compete in this class.

**Senior Open** - This class is for handlers 15 years of age on the date of the competition up to the date of their 18th birthday.

#### Conformation

**Pee Wee Class** - This class is for handlers 4 years of age on the date of the competition up to the date of their 7<sup>th</sup> birthday. This class is optional and non-competitive. No placements are to be awarded; only participant ribbons, rosettes and token trophies may be presented.

**Junior Novice Class** - This class is for handlers 7 years of age on the date of the competition up to the date of their 11th birthday who have not won 6 first places in the same class with competition.

**Junior Open Class** - This class is for handlers 7 years of age on the date of the competition up to the date of their 11<sup>th</sup> birthday who have won 6 first places in the same class with competition.

Intermediate Novice Class – This class is for handlers 11 years of age on the date of the competition up to the date of their 15th birthday who have not won 6 first places in the same class with competition.

Intermediate Open Class – This class is for handlers 11 years of age on the date of the competition up to the date of their 15<sup>th</sup> birthday who have won 6 first places with competition and for any handler who has progressed through Junior Open level and feels that he has enough experience to compete at this level.

Senior Novice Class - This class is for handlers 15 years of age on the competition up to the date of their 18th birthday who have not won 6 first places with competition in this class. Handlers from the Intermediate levels progress to this class.

Senior Open Class - This class is for handlers 15 years of age on the competition up to the date of their 18th birthday who have won 6 first places with competition in the Senior Novice Class, and for any handler who has progressed through the Intermediate Open level and feels that he has enough experience to compete at this level.
