These are limited entry trials, subject to judges time and covid19 protocol regulations and guidelines. Some C.K.C. covid19 options may be utilized at judges discretion.

Vaccine Passport/Card and Masking is Mandatory inside the venue. Valid Government issued Photo ID matching passport/card required.

All Official Scent Detection are offered in each trial. These are limited entry trials. Day of Trial entries are permitted so long as the limit has not been reached.

Footing is compact dirt in the arena. The exterior coral has a sand/soil base.

No Concession on site but food services with a 5 minute drive.

Entrants of Non Recognized Breeds or Mixed Breeds are welcome with a Canine Companion Number (CCN).

Dogs which have no CKC # must obtain a Temporary Competition Number prior to entering.

Entrants may not be "listed" after March 2, 2020.

### **Judging Order Below Subject to change**

#### Posted times indicate that the dogs listed after that time will not run before that time.

TEST SITE: There will be limited indoor kennelling. NO exercise pens except for giant breeds. No Grooming. Social distancing. Vaccine Passport/ Valid card and Masking is Mandatory. Government issued Photo ID matching passport/card is required. Exercising of dogs only in the Corral NW of main entrance.

Portable toilet is available. Please bring your own lunch or pick up in Aldergrove. There is a Tim Hortons and Paz fuels which has hot lunches (about 2 minutes South by car).

**REGULATIONS:** It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Scent Detection <a href="https://www.ckc.ca">www.ckc.ca</a> under forms. New version for July 1, 2021. It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind.

- The club reserves the right to remove any person(s) from the show and the show grounds. The Show Superintendent shall have full control of these shows and trials, which are governed by CANADIAN KENNEL CLUB (CKC) rules.
- Any person excused by the Trial Superintendent or Veterinarian for any reason shall not, compete in any class for any awards for the balance of the shows, trials and or events.
- The Trial committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident or misfortune to either dogs, exhibitors, spectators or vendors.
- Exhibitors may be asked by the show superintendent for proof of third party liability insurance. Failure to produce may result in dismissal from the show grounds.
- Dogs must be on the grounds 1 hour prior to the judging of their class.
- The owner of a dog entered in these shows is entirely responsible for any error in entering his/her dog regardless of how or by whom the entry was made.
- Equipment left unattended at the trial grounds is at your own risk...
- No overnight recreational units permitted
- 📦 If, because of civil disturbance or other acts beyond the control of the club, it is impossible to open or complete the show, there is no refund of entry.
- Dogs must be on leash at all times on the trial grounds.
- Schibitors are expected to maintain a clean area. Please be considerate when utilizing any facilities. No dogs are permitted in the washrooms.
- The welfare of any children is deemed to be the responsibility of the guardian or parent. Please exercise control and restraint over your child's behaviour.
- The club is not responsible for lost or stolen property from exhibitors or vendors/concessions. Check for lost property at the security desk. The club reserves the right to refuse an individuals entries, for just cause.
- Delays waiting for dogs will not be possible and handlers with several breeds must arrange for alternative handlers if judging times for their dogs
- The club reserves the right of restricting exhibitors space.
- Fire lanes in all areas will be maintained.
- All exhibitors must follow direction by Cotonfield Dog Centre owners.
- Please park neatly.

#### 6.9 Moving Up

- 6.9.1 A dog that is registered in the records of the CKC with an eligible number according to these rules and has fulfilled
  the requirements for a title in accordance with these rules <u>may be moved to the next level of competition if the schedule
  permits</u>. The transfer must be on the appropriate move-up form and submitted to the trial secretary by the owner or
  handler at least 15 minutes before the start of the class. (emphasis is mine)
- 6.9.2 The Event Secretary shall amend the judge's book and the marked catalogue, which are to be sent to the CKC with the requests attached to the appropriate entry forms.
- 6.9.3 If it is established by the CKC that a dog moved up to the next level has not completed the requirements for the lower level before moving up, then all qualifying ribbons and/or awards earned by the dog incorrectly entered shall be forfeited and cancelled by the CKC and the owner may be subject to disciplinary action.
- 6.9.4 In order for a dog to be eligible to move up, the dog must be individually registered with the CKC, have a Performance Event Number (PEN), an Event Registration Number (ERN), a Miscellaneous Certification Number (MCN) or a Canine Companion Number (CCN) before entries close. The addition of a CKC number after close of entries does not make the dog eligible and will result in referral to the Discipline Committee.
