Personal cheque or Money order for the full amount only will be accepted and should be made out to **EVANGELINE KENNEL CLUB.**

No post dated cheques accepted. Post Dated means a date later than the date on which the entry was received. Entries cannot be processed unless the date of the cheque is current. All NSF cheques will be subject to a charge of \$20.00. N.S.F. cheques are considered non-payment of entry fees and are punishable by disciplinary action and cancellation of awards. All fees must be paid before the show

No entries may be accepted, altered, canceled or substituted after the official closing date and time except for as provided in these rules.

.Attention USA exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you
