

## NAMBR OFFICIAL CLASSES

**Novice 'A'** is for dogs which have not earned the title of CD (Companion Dog) in any country. A dog that has earned a comparable title in any country is not eligible for entry in this class but may be entered in the Novice 'B' class. No trainer, person who assists in an obedience training class or any person who has previously exhibited a dog through its UD (Utility Dog) title in Canada or elsewhere shall be allowed to compete in this class but may be entered in the Novice B class. One dog only may be entered in this class by any one exhibitor, who must handle the dog in all exercises. Every dog in the class must be handled by the owner or a member of his/her immediate family.

**Novice 'B'** is for dogs which have not earned the title of NAMBR CD. A dog which has earned the title of CD or comparable title in any country must compete in the Novice 'B' class. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. The same handler who handled each dog in the first 4 exercises must handle each dog in the sit and down exercises, except where a handler has handled more than one dog in the first 4 exercises; there must be an additional handler for the Group exercise. No dog may be entered in more than one Novice class at any one trial.

**Open 'A'** is for all dogs which have earned the title of NAMBR CD but have not earned the title of CDX (Companion Dog Excellent) in any country. A dog that has earned a comparable title in any country must enter the Open 'B' Class. No trainer or any person who has previously exhibited a dog through its UD title in Canada or elsewhere is allowed to compete in this class but may enter in the Open 'B' class. One dog may be entered in this class by any one exhibitor, who must handle the dog in all the exercises. Every dog in the class must be handled by the owner or a member of his immediate family. No dog may enter both Open 'A' and Open 'B' at the same trial

**Open 'B'** is for dogs which have earned their NAMBR CD. A dog which has earned the title of CDX or comparable title in any country must compete in the Open 'B' class. Dogs in this class may be handled by the owner or any other person. Dogs eligible for entry in the Utility class may also enter the Open 'B' class at the same trial.

**Utility** is for dogs which have earned the title of NAMBR CDX. Dogs entered in this class may be handled or exhibited by the owner or any other person. Dogs eligible for, and entered in this class, may also enter the Open 'B' class at the same trial.

## NAMBR UNOFFICIAL CLASS

**Veterans** is for dogs that have earned the title of NAMBR CD and are 7 years old or older on the day of the trial.

Only those dogs (mixed and purebred) REGISTERED WITH NAMBR PRIOR TO THE CLOSING DATE of these trials may be entered. It is your responsibility to provide the Trial Secretary with your dog's NAMBR Registry # prior to the closing date or your entry will be rejected.

☞ Bitches in season are not permitted to compete in these Trials. Where a bitch comes into season after entry of the bitch has been submitted, a Veterinarian's certificate, certifying the bitch was in season within the 10 day period preceding the Trial must be reach the Trial Secretary on or before the date and time of the Trial, whereupon the entry fee will be refunded.

Entries will not be accepted unless accompanied by the appropriate fees. No post-dated cheques will be accepted. NSF cheques are subject to a \$30.00 charge. Telephone, fax, e-mail or credit card entries will not be accepted.

The host will use all reasonable care to guarantee the safety of dogs exhibited, but will not be responsible for loss or injury to any dog, exhibitor or spectator.

The Show Superintendent will have entire charge and control of the show.

All dogs must be kept on leash at all times and under control. An exercise area will be designated. Please use that area ONLY and clean up after your dog.

A listing fee of \$2.00 per entry will apply for all NAMBR Registered POD (Purebred Obedience Dog) entries. Listing fees are required to be remitted directly to the Trial Secretary along with the applicable entry fees.
