Overpayment of entry fees will be considered a donation to the club. Tendering of an NSF cheque shall be considered non-payment of entry fees and is an offence punishable by disciplinary action and cancellation of awards by the Canadian Kennel Club. A fee of \$25.00 will be charged for any returned cheque.

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to inconsistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". The banks will not clear them. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

All entries must contain complete information as required by the CKC rules. All entries must be accompanied by the entry fee, in full, and all TCN Fees where applicable. A TCN Fee as established by the CKC must accompany the entry of a dog for which a CKC individual registration number is not shown on the entry form or ERN notice.

#### NOTICE TO ALL FOREIGN EXHIBITORS – ERN NUMBERS

All foreign born and foreign owned dogs who enter Canada for the sole purpose of entering CKC events do not require a CKC registration number but will require an ERN (Event Registration Number). To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or VISA/Mastercard number (expiry date, cardholder's name and signature). Provide your complete address for return of ERN to you. Dog may initially be entered as TCN Reg No. but the ERN must be applied for within 30 days of winning CKC points, awards, or scores to avoid cancellation. #### GENERAL INFORMATION

- ENTRY FEES SHALL NOT BE REFUNDED AFTER THE CLOSING DATE in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee, or because it has been entered incorrectly. If because of riot, civil disturbance, or other acts beyond the control of the Club, it is impossible to open or complete the show, no refund of entry will be made. Overpayments will not be refunded.
- ENTRY FEES WILL BE REFUNDED WHEN A BITCH ENTERED IN OBEDIENCE COMES INTO SEASON after entry of the bitch has been submitted if a Veterinarian's certificate, (certifying that the bitch was in season within the ten-day period preceding the trial), is delivered to the Trial Secretary on or before the date of the trial.
- Entries must be typewritten or clearly printed. Owners are responsible for errors on entry forms. Cal K-9 Obedience Club of Calgary does not assume any responsibility for incorrect information or errors due to illegibility of information on any entry form.
- Make cheques payable to Cal K-9 Obedience Club of Calgary. No post-dated cheques will be accepted.
- ENTRIES WILL BE ACKNOWLEDGED AFTER CLOSING DATE. Receipts and judging schedule will be emailed. Please ensure email address is printed on your entry form. Armband numbers will be available one hour before the trials begin. **There will be NO hard copy catalogues available at the show. The same will be posted on [www.dogshow.ca](http://www.dogshow.ca) for download by the participants the day of the trial. Please bear in mind that it will be contingent on internet access for the trial secretary the morning of the trial if the same can be posted 1.5 hours prior to the trial for download. Otherwise the same will be posted for download when the trial secretary has internet access.**
- (Chapter 3, Section 3.6.1 CKC Obedience Trial Rules & Regulations). "A judge officiating at a trial held under these Rules shall not be subjected to indignities of any kind during the progress of the trial. It shall be the duty and obligation of the club holding the trial to see that this rule is effectively carried out."
- ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES. If not in competition, the dog must wear a collar and be on a leash a maximum length of six (6) feet or appropriately confined in the benching area.
- Dogs must be exercised in designated areas ONLY.
- All empty rings are to be kept free of dogs.
- An exhibitor has the right to withdraw an entry. This Notice of Withdrawal must be in writing and received by the Show Secretary on or before the official closing date and time as published in the Premium List.
- All Miscellaneous Class Dogs who do not have a Certification Number can only compete at the Novice level in Obedience Trials and must pay a TCN Fee of \$10.50. Those dogs with a certification number may proceed through all levels. Titles will only be awarded to those dogs that have been certified.
- In Transit permits will be available from the trial secretary if needed. Dogs not entered in the trials in the regular classes or exhibition only will not be permitted on the show grounds without an In Transit Permit.
- Performance Event Number (PEN) allows an unregistrable dog of a CKC recognized breed to participate in competitive events that are appropriate for the breed. For more information regarding applying for a PEN visit [www.ckc.ca](http://www.ckc.ca).
- Cal K-9 Obedience Club of Calgary, its members and volunteers will use due care and diligence for the welfare of dogs and exhibitors, BUT will not be responsible for, nor assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons.
- The Trial Superintendent has the authority to expel any dogs deemed to be a danger to other dogs or people. There will be no refund for dogs that are expelled

#### OFFICIAL CLASSES

**Pre Novice** – This is for any dog of any recognized or listed breed which has not earned the title of P.C.D (Pre-Companion Dog). Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together in the Group Exercise. A dog that has earned the title of C.D. is not eligible for this class. This class is an elective class and earning the title is not a requirement to advance to the Novice Classes.

**Novice A** - This is for any dog of any recognized or listed breed which has not earned the title of C.D. (Companion Dog). Only one dog may be entered in this class by any one exhibitor. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its C.D.X. (Companion Dog Excellent) title shall be allowed to handle a dog in this class.

**Novice B** - This is for any dog of any recognized or listed breed which has not earned the title of C.D. (Companion Dog). Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the group exercises. No dog may be entered in both the Novice A and Novice B class at any one trial.

**Novice C** – This is for any dog of any recognized or listed breed which has earned the title of C.D., C.D.X., U.D., or any Obedience Trial Championship Title prior to the closing date of the trial in which it is to be entered. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the group exercises. Dogs may compete in the Novice C class indefinitely. Scores earned by dog in the Novice C Class are not eligible for High in Trial and do not qualify a dog for any title.

**Novice Intermediate** – This is for any dog of any recognized or listed breed which has earned the title of C.D., C.D.X., U.D., or any Obedience Trial Championship. Scores earned by dogs competing in this class are not eligible for High in Trial. A person may enter more than one dog in this class. This class is an elective class and earning the title is not a requirement to enter the Open classes.

**Open HA / 18A** - This is for any dog of any recognized or listed breed which has earned the title of C.D. but has not earned the title of C.D.X. (Companion Dog Excellent). Only one dog may be entered in this class by any one exhibitor. The dog must be handled by the owner or a member of his immediate family. Any person who has previously trained or exhibited a dog that has earned a U.D. title may not handle a dog in this class.

**Open HB / 18B** - This is for any dog of any recognized or listed breed which has earned the title of C.D. in Canada. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the group exercises. No dog may be entered in both Open HA/18A and Open HB/18B at any one trial. A dog that has earned the title of C.D.X. must compete in Open B. Dogs eligible for entry in the Utility Class are also eligible for entry in this class.

**Utility A** - This is for any dog of any recognized or listed breed that has earned the title of C.D.X., but has not earned the title of U.D. The dog must be handled by the owner or a member of his immediate family. Any person who has trained or exhibited a dog that has earned a M.O.T.C.H title may not handle dogs in this class. Handlers may enter more than one dog in this class.

**Utility B** – This is for any dog of any recognized or listed breed that has earned the title of C.D.X. or U.D. Dogs in this class may be handled by the owner or any other person. Owners may enter more than one dog in this class. No dog may be entered in both Utility A and Utility B at the same trial.

# Cal K-9 Obedience Club of Calgary/Chinook Schutzhund Club COVID-19 Requirements

## General Required Practices

1. Cal K-9 members, judges and exhibitors are required to follow Federal, Provincial, Local and facility guidelines as presented below. Any changes in guidelines between the posting of this Premium List and the starting of each trial will also be followed.
2. Social distancing must be practiced. Maintain a distance of 6 feet / 2 Metres or more unless individuals are part of a family unit.
3. Masks are recommended unless running a dog in a class. Masks are to be supplied by exhibitors for their personal use.
4. Exhibitors may consider wearing disposable or washable gloves unless running a dog in a class.
5. There will be plenty of hand sanitizer around the facility for personal use and wash stations will be provided in the porta-potty area.
6. Wash hands as frequently as possible.
7. No handshakes or hugging.
8. Do not touch dogs that are not your own.
9. Bring your own pen/pencil. No common use pencils, pens or markers will be available.
10. Benching spaces must be at least 6 feet / 2 Metres apart. The benching space should be used for each exhibitor or “family” of exhibitors. Exhibitors to bring their own shade tents/screens. All tents must be pegged to the ground and dropped when leaving for the night. Leave your belongings at your own risk, there will be no security on site. Dogs are not to be left on the field overnight. No overnight (people) tenting allowed. You may bench your dogs in your vehicle if you wish ensuring you bring proper shade, ventilation, and water for your dogs. Dogs in vehicles will be monitored and dealt with appropriately if they are deemed to be in distress. You cannot bench on the Calgary Horseshoe property.
11. Exhibitor parking will be in the **paved** lot of the Calgary Horseshoe club. (See map) There will be NO parking in the gravel parking lot of the Calgary Horseshoe Club. You may also park along 78<sup>th</sup> Avenue which has easy access to the rings as well.

## **Information applicable to all participants:**

1. The trial will be limited to whatever the current provincial outdoor gathering limits will be at the time of the trial. The limit will apply to entrants, judges, Cal K-9 members and all persons present (including spouse, significant other, family members).
2. Due to COVID restrictions – the judges will be using Routine 1 for both Open and Utility. As well, we shall be utilizing Rally jump heights only to minimize the contact of ring stewards on the equipment. You will see the Rally jump heights on the entry form.
3. Score sheets may or may not be available in printed form. If they are not available, exhibitors may request the opportunity to take a photo of their sheet or have a photo of the same sent to them electronically by the steward, time permitting.
4. There will be a self-serve ribbon and prize table. Exhibitors may pick up their own ribbons, and prizes once rounds are completed. Please only touch what you are taking and be sure to maintain social distancing.
5. The trial secretary’s designated space will be considered sacred ground. Barriers will be set up using a 6 Feet / 2 Metre perimeter to protect the trial secretary. Anyone who violates the space of the trial secretary

will be asked to leave the trial grounds and may not return for the duration of the trials. No refunds for entries will be provided in this instance.

### **Trial Practices:**

1. Each exhibitor will provide a completed waiver of liability for Cal K-9 and Chinook Schutzhund Club. Waivers will be given to the trial secretary as part of your entry package before the first morning of the trials. No one will be allowed to participate who has not completed the required waiver.
2. Anyone exhibiting COVID symptoms will be asked to leave the trial grounds and will not be allowed to return. No refund will be issued.
3. Please carefully read the CKC's recommended COVID obedience protocols document carefully. There have been some temporary rule changes that will most likely affect you!
3. It is recommended all exhibitors wear a mask except when running a dog in a class or while in their personal benching area. This rule may change with the provincial/city guidelines at the time of the trial. The same might require that the wearing of a mask is mandatory at all times even when trialing your dog.
4. The gate board will be available near the rings for exhibitors to indicate they are present and running in the class. **DO NOT TOUCH THE BOARD.** A steward will mark you as present and make any run order changes that are needed. A 6 Feet / 2 Metre buffer will be marked around the gate steward.
5. Exhibitors will remove and retrieve their own leashes. A chair or other object will be placed in the ring for the leash.
6. **MAINTAIN 6 Feet / 2 Metre SPACING** at all times.
7. Equipment will be sanitized at the end of each day and if/when stewards are changed.

# Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, Federal, Provincial and Local governments and Federal / Provincial health agencies recommend social distancing and have, in many locations, imposed restrictions on the congregation of groups of people.

I understand that the risk of becoming exposed to or infected by COVID-19 at the Cal K-9 Obedience trials may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Cal K-9 members, volunteers, judges, participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my children myself, or any guests (including, but not limited to, personal injury, disability and death), illness, damage, loss, claim, liability, or expense of any kind, that I, my guests or my children may experience or incur in connection with my attendance at the Cal K-9 Obedience trials at Chinook Schutzhund Club Fields. On my behalf and on behalf of my guests and children, I hereby release, covenant not to sue, discharge, and hold harmless Cal K-9 or Chinook Schutzhund Club, its members, agents, representatives and volunteers, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes my Claims based on the actions, omissions or negligence of Cal K-9 or Chinook Schutzhund Club its members, agents, representatives and volunteers, whether a COVID-19 infection occurs before, during or after participation in any Cal K-9 Obedience event at Chinook Schutzhund Club Fields.

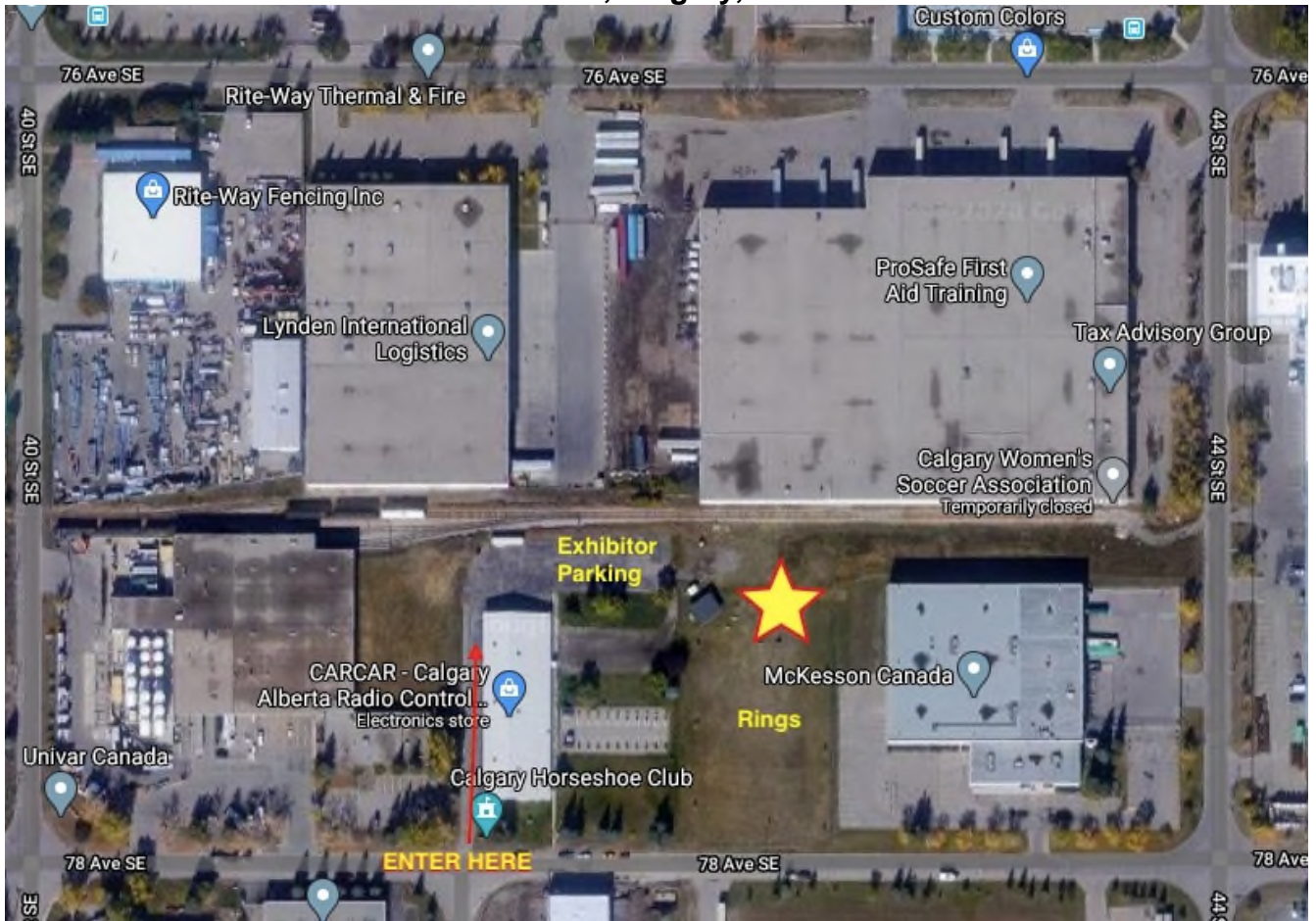

**All dogs must be on leash. There will be 2 rings, and plenty of benching space. Benching will be along the grass bordering the Calgary Horseshoe Club and the Chinook Schutzhund Club – near the rings. The surface will be grass.**

20.7 “It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.”

**Parking is in Exhibitor Parking only or along the street on 78<sup>th</sup> Avenue SE. To enter the Exhibitor Parking marked above on the map, drive into the driveway for the Calgary Horseshoe Club where it states “enter here” on the above map. Drive all the way around to the back and you will see the large paved parking lot.
