**CKC NON-MEMBER PARTICIPATION FEE:** The CKC has a tracking fee for non-members. Please refer to the information about this policy on the CKC website:

If a dog is not registered individually in the records of the CKC, it may be entered at a trial held under these rules with a Temporary Competition Number (TCN), providing that the number is obtained before the closing date of entries. Once the dog is permanently registered or has an ERN, the TCN will no longer be valid. The fee for a Temporary Competition Number is \$10 as January 1, 2023. Exhibitors will still be required to pay listing fees (\$10.50 including GST) when entering events. The request for a TCN will be self-serve; exhibitors should go to the CKC website to complete an online application and a TCN will be issued instantly. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC, or by contacting the Shows and Trials Division by telephone.

**GENERAL INFORMATION AND TEST RULES**

**CKC REGULATION:** It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**ELIGIBILITY**

Purebred or mixed-breed dogs must be at least 6 months of age and:

- (a) Are individually registered with the CKC (have a CKC registration number),
- (b) Have an Event Registration Number (ERN), (c) Have a Performance Event Number (PEN),
- (d) Eligible for registration with the CKC and have a Temporary Competition Number (TCN) - \$10
- (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion number (CCN) if it is a mixed breed

**PAYMENT:** made via Dogshow.ca

**ENTRY LIMIT:** This trial is limited entry. **If the trial fills, send your name, dog name and registration number and components requested to Event Secretary to be added to the wait list. Entries may be added from the wait list.**

**Handlers** may only enter 1 dog in each component at each level. Dogs can only be entered in Open, Excellent and Master components if they have already obtained the preceding level title or relevant component.

**MOVE UPS:** Move-ups are not available for this trial

**RIBBONS & AWARDS:**

Flat Ribbon awarded for Instinct passes, Flat ribbons for all Qualifying Scores

Rosettes awarded for Novice, Open, Excellent Titles, New Master Titles, and New Component Titles

**ALL LEVELS OFFERED**

**COMPONENTS OFFERED:** CONTAINERS only in INSTINCT; CONTAINERS, INTERIOR, and EXTERIOR in all other levels. Component order to be determined after entries are received and will be subject to change at the Judge's or Chair's discretion. **Note: 2 components may be run back-to-back**

**ODOURS BEING TESTED:**

Instinct & Novice: Wintergreen

Open: Wintergreen & Pine

Excellent: Wintergreen, Pine & Anise

Masters: Wintergreen, Pine, Anise & Clove

**EQUIPMENT:** The dog may wear a buckle, snap, or martingale collar and/or body harness in the ring.

Collars/harnesses with tags may be worn in the ring. Harnesses may have the leash attached to the front clip or on the back. Electronic training and pinch collars are not allowed on the rounds.

**SCENT DETECTION RULEBOOK:** It is up to the individual handler to have reviewed the CKC Scent Detection Rule book prior to the trial. Note: there were changes and updates to the Rule book as of July 1, 2021.

**REMINDERS:** Anyone discussing hides or revealing information on the location of hides before the end of the trial will be excused and asked to leave as per CKC rules. Please show consideration for other competitors. All dogs are to be always on leash including while in the parking lot or any areas surrounding the trial venue. A dog may be off leash only during a search at the discretion of the judge.

**BITCHES IN SEASON:** Bitches in season shall not be eligible to enter the test. If a bitch comes into season after entries have closed, the club will refund the entry fee providing the event secretary receives, on or before the event, a veterinarian's certificate declaring that the bitch was in season within the 7day period preceding the trial.

**BORDER CROSSING:** A valid rabies certificate is required to bring a dog into Canada and must be dated at least 30 days prior to entry into Canada. All participants who crossed the border will have completed 14 days of quarantine immediately prior to trial date or comply with current regulations in place at time of entry into Canada.

**REGULATIONS:** It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Scent Detection Rules & Regulations are available from the Canadian Kennel Club. Tel: 1-800-250-8040.

### **ATTENTION FOREIGN EXHIBITORS**

Please note that fees are due and payable in Canadian dollars. Due to constantly fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and co-operation is appreciated. Thank you

### **SITE INFO**

No special area will be designated for reactive dogs. These tests will be run snow, rain, or shine. All dogs must be under control and on a leash except during the trial where off leash searches are permitted. Flexi leads will not be allowed on the test site. Please, clean up after yourself and pick up after your dog. Please note: some search areas are accessed by uneven terrain.

### **SITE LOCATION:**

St. Margaret's School 1080 Lucas Avenue, Victoria, B.C. **Note that this a private school with security in place. Do not enter the premises before the appointed time and date.**

**NO CONCESSION ON SITE:** Restaurants and grocery stores are available within a 10-minute driving distance of the location. Competitors should bring food, treats and water for dog(s).

**CANCELLATION OF EVENT:** If NOSA needs to cancel the event due to Provincial or Federal regulations, all entry fees will be returned except for any fees collected by Dogshow.ca.
