All entries must be accompanied by the full entry fee. A listing fee of \$10:00 + 5% GST equaling \$10.50 total shall accompany an entry **IF** the dog does not have an individual CKC registration number or ERN number.

Running order will be determined by a draw on August 16th for the events held on the 21st and on the 21st for the events held on the 22nd. Every effort will be made if there are multiple entries by the same owner/handler to be separated unless otherwise requested.

Pigeons, ducks or pheasants may be used on land and ducks will be used in the water. Standard CKC Rosettes to all dogs qualifying in each event.

Policy Regarding Non-Members of the CKC

A non-member participation fee of \$63.90 + 5% GST=\$67.10 will be charged to a resident of Canada who is a non-member of the CKC. The non-member participation fee is paid in any year a title is earned and covers all titles and dogs wholly owned by that individual. In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.

IMPORTANT PARTICIPANT INFORMATION:

Due to COVID-19, we are implementing the following new processes for this event.

- 1. No food or drinks will be provided. Participants and volunteers must bring their own refreshments
- 2. The club will not be hosting a tailgate party.
- 3. Ribbons will be handed out after the end of each stake at the club house.
- 4. All participants and guests must follow social distancing protocols. Sanitizing areas will be available at the various stakes.
- 5. We STRONGLY recommend that all participants have been vaccinated
- 6. Participants must adhere to all Province of Saskatchewan protocols, including not attending the event if they are sick, have any COVID-19 symptoms, have been in contact with persons with COVID-19 or have travelled within the last 14 days
- 7. Washrooms will be available with sanitizing stations for before and after each use.

SCRATCHES

Scratched entries will forfeit \$10.00 per entry when trial secretary is notified at least 24hrs prior to the starting time of test. 'No shows' will forfeit full entry. Bitches in heat will be provided a full refund as they are not to be on test grounds at any WC Event.
