### GENERAL INFORMATION AND TEST RULES

#### GENERAL INFORMATION

It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event is not subject to indignities. The Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on the receipt of a report indicating that this has occurred. (See Section 19.7)

**ELIGIBILITY:** Purebred or mixed-breed dogs must be at least 6 months of age that:

- (a) Are individually registered with the CKC (have a CKC registration number),
- (b) Have an Event Registration Number (ERN),
- (c) Have a Performance Event Number (PEN),
- (d) Are eligible for registration with the CKC, or
- (e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
- (f) Have a Canine Companion number (CCN) if it is a mixed-breed.

Dogs that are eligible for a CKC or ERN number but don't yet have one should have a Temporary Competition Number (TCN). These can be obtained free of charge online from the CKC. For this event, dogs may still be run as "Listed". For more information about the TCN:

All N.S.F. cheques will be assessed a \$25.00 service charge

**ENTRY LIMIT:** These Trials are limited. **Day of trial entries will be accepted at this event between 7:30am and 8:30am with CASH payment only if space is available.** If the tests fill, waiting lists will be kept and dogs from the waiting list may be entered and added.

Handlers may only enter 1 dog in each component at each level. Dogs can only be entered in Open and Excellent if they have already obtained the preceding level title.

**MOVE UPS:** Same day move ups for the next trial are allowed. Exhibitors must already be entered at the current level to move up. Same trial move ups will not be allowed.

**PRIZES & ROSETTES:** Flat ribbons will be awarded for each qualifying component. New title rosettes will be awarded to any dog completing a title in these trials.

**ODOURS BEING TESTED:**

Instinct	Wintergreen
Novice	Wintergreen
Open	Wintergreen & Pine
Excellent	Wintergreen, Pine & Anise

**EQUIPMENT:** The dog may wear a buckle, snap or martingale collar and/or body harness in the ring. Collars/harnesses with tags may be worn in the ring. Harnesses may have the leash attached to the front clip or on the back. Electronic training and pinch collars are not allowed on the rounds.

**PENALTIES ISSUED BY THE CLUB:** Dropping food while rewarding is considered contamination. Contamination of the search area will result in a non-qualifying score and any dog that urinates or defecates or vomits within the search area will be excused from the competition. Handlers will be charged for any damage done to equipment by dogs (including urinating on items, excessive scratching or subsequent breaking of any item).

**REMINDER:** That anyone discussing hides before the end of the trial will be excused and asked to leave as per CKC rules. Please show consideration for other competitors.

**BITCHES IN SEASON:** Bitches in season are not permitted to compete. If a bitch comes into season after entries have closed, the club will refund the entry fee providing the event secretary receives, on or before the event, a veterinarian's certificate declaring that the bitch was in season within the 10 day period preceding the trial.

**BORDER CROSSING:** A valid rabies certificate is required to bring a dog into Canada and it must be dated at least 30 days prior to entry into Canada.

**TEST SITE:** No indoor kenneling. These tests will be run rain or shine. All dogs must be under control, on a leash except during the trial where off leash searches are permitted. Flexi leads will not be allowed on the test site. Remember that this is a public park used by families. Clean up after yourself and your dog.

**WASHROOM** facilities only available during class changes.

**REGULATIONS:** It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. Copies of the CKC Scent Detection Rules & Regulations are available from the Canadian Kennel Club. Tel: 1-800-250-8040.
