OUR JUDGES



Mrs. Sandy Alexander

I have bred and owned Dachshunds (Miniature Long and Smooth and now Standard Smooth) since 1974 first under the Longjohn prefix and presently under Thomashenry. Our Dachshunds have been Best in Show and Best in Specialty show winners and have placed number one in the breed and in the top five in 1995,'96,'98,'07,'08,'09'2010. We pursue Earthdog titles on our Dachshunds. We produced many top winning BIS, BISS German Shorthaired Pointers as well as the youngest GSP to finish in the USA. I have also owned and/or bred top five ranking multi- BIS, BISS, NBISS Pembroke Welsh Corgi's and a BIS Miniature Poodle. I bred multi- BIS, BISS winning Siberian Huskies and have bred Shetland Sheepdogs. I owned Chows in the past and currently Labrador Retrievers. I am a grooming salon owner by trade and handled all breeds for many years. I am licensed by the CKC to judge all Sporting breeds, Hound breeds, Working breeds, Non-Sporting breeds and Herding breeds and BIS. I am on permit for all of the toy breeds. I have judged in Canada, the USA, Australia, China, Spain and Japan including Working, Northern breed, Dachshund, Shetland Sheepdog specialties as well as the Canadian Ibizan Hound National Specialty, Alaskan Malamute National Specialty and the Dachshund National Specialty in Japan.



Mr. Thomas Alexander

I have bred German Shorthaired Pointers, Dachshunds and Labrador Retrievers under the Thomashenry Kennel name since 1980. Our kennel has produced the number one GSP, Labrador and Dachshund ML and has had many others place in the top five. We have had the Top Sporting dog & number three all breeds in South America as well as the first GSP to win the group at the World show in 1992. Our dogs have won BISS, BIS, as well as Earthdog, and WC titles. I also bred English Springer Spaniels and grew up with Irish Water Spaniels. I have judged National and Regional Specialties as well as all breeds in Canada, USA, Australia, Japan, New Zealand, Iceland, Hong Kong, Indonesia, Chile, Colombia, Manila, China and Korea. I am licensed to judge all breeds in Canada.



Ms. Karen Brearly

Karen is a recognized CKC/AKC obedience judge, CGN evaluator, St. John's Ambulance Pet Therapy evaluator and her passion is dogs. For the past 25 years, her and her dogs have achieved numerous High in Trial designations in both the Obedience and Herding arenas.

She has proven with her large breed Belgian Tervurens, smallest Pomeranians, and her current Shelties that any dog can achieve success and be an enthusiastic and happy worker!



Mr. Joseph Gregory

Joseph E. Gregory, of Louisville, Kentucky, has been a member of the dog fancy since soon after his high-school graduation in the late 1940's.

After establishing Cloverdown Kennels with his boyhood friend Burr Long, their first success came with breeding Boxers, including BIS Ch. Truce Talk of Cloverdown, handled by the late Phil Marsh.

As a professional handler, Mr. Gregory cites among his many top dogs Ch. Treceder's Painted Lady (Westminster Working Group Winner, 1963 and 1964), who retired as the top-winning Boxer bitch of all time.

Mr. Gregory has been an AKC judge since 1965 and received "all-rounder" status in 1993. He has judged in many countries throughout the years, was voted Judge of the Year by *Iam-Kennel Review* and has judged Top 20 competitions in several breeds.

He is a lifetime member of the American Boxer Club, Louisville Kennel Club, Santa Barbara Kennel Club and Morris and Essex respectfully.



MR. DAVID HADDOCK

A native of Wichita, Kansas, Mr. Haddock obtained his first purebred dog in the 1970's, during which time he owner-handled an Alaskan Malamute to an obedience title and conformation championship. He later acquired Portuguese Water Dogs, handling one of the first PWDs to achieve both Breed Championship and Utility Dog titles.

Mr. Haddock started his judging career in obedience and is approved for the Working Group, several Sporting breeds, and Best in Show. He has adjudicated domestically at over 550 shows in *(almost)* all 50 states, and internationally in Australia, China, Columbia, Finland, India, Mexico, Puerto Rico, and South Korea.

Mr. Haddock is Vice President of the Westchester Kennel Club, a member of the Santa Barbara Kennel Club, and a member of the Board of Governors and Dog Committee of the Westminster Kennel Club, serving as Obedience Trial Chairman, and overseeing the Junior Showmanship competition. He has authored several canine articles that have appeared in National publications.

A graduate of Washington & Lee University (BA, 1983) and Columbia University (MBA, 1987), Mr. Haddock was a founding partner and executive in multiple start-ups and early stage businesses and has worked internationally as a pet industry consultant.



MR. ARAMIS (JOY) LIM

I was born into the world of Dogs, as my parents were both all breed judges and breeders of German Shepherds, Boxers, Great Danes, Min Pins and Dachshunds. From a very young age I was involved in show handling these breeds.

I have been fortunate to have had invitations to judge in many countries, most of them several times. Amongst the countries I have judged are Germany, Spain, Switzerland, Sweden, Finland, San Marino, Lithuania, Croatia, Romania, Estonia, Latvia, Hungary, Poland, Slovakia, Ireland, Canada, U.S.A., Mexico, Puerto Rico, Peru, Chile, Guatemala, South Africa, Israel, Thailand, Malaysia, Indonesia, Peoples Republic of China, South Korea, India, Japan, Taiwan and the Philippines, both islands of New Zealand on numerous occasions. I regularly judge around all States and Territories of Australia.

I have been invited to judge at prestigious events like Contest of Champions and Puppy of the year events around Australia, Asia and Europe. Some of the memorable shows I have been fortunate to judge are: the FCI World Dog Show in Bratislava, Slovakia and the 2017 World Dog Show held in Leipzig, Germany. The FCI's biggest show on record. I have also judged the FCI European Winners show in Zagreb, Croatia, Dracula Show in Transylvania, Romania, FCI Centenary Anniversary Show celebrating 100 years of the FCI. In Dortmund, Germany, also the German Kennel Club's VDH-Europasieger Show. Stockholm International show in Sweden. Part of this assignment is the prestigious, Contest of Champions. Canada's biggest shows the Purina National in Toronto and the Lower Mainland Kennel club show in Vancouver. Asia's biggest show the Tokyo FCI International Show in Tokyo, Japan. The FCI Asia and the Pacific Section show held in the Philippines. The FCI section show of the Americas and the Caribbean held in Santiago, Chile.

Since moving to Australia in 1984, we have been involved in the breeding and very successful exhibiting of Shetland Sheepdogs and more recently Miniature Schnauzers.

We owned and exhibited South Australia's number one Sheltie and Working Dog for two years in a row, who has become another addition to our Grand Champions. This male Sheltie is the greatest winning Sheltie, of all time, in South Australia.

Many of our Shelties are Best in Show winners, in both All Breeds and Specialist competition. Our Miniature Schnauzers have been awarded Best in Group and Best in Show awards both at the All Breeds and Specialty shows. We are still actively involved in breeding and exhibiting our dogs.

We also have owned a Dachshund, who has performed very well for us, taking out the National Breed Specialty.

My current involvement in the dog fancy in South Australia is as an ANKC Examiner on the Judge's Training Scheme and as a committee member on the All Breeds Dog Club of South Australia, Colomeke All Breeds Kennel Club of South Australia and the South Australian Canine Association's Winter International Show".



MRS. MARIBEL SY

In 1981, we have acquired our first shih tzu and in 1983, me and my husband established Sunnyside Kennel. We have been involved in breeding, showing and handling Shih Tzus with great success. Among them are: Owner/handled the first Phil Grand Champion Shih Tzu in the country, Phil. Grand champion Ben (imp. Japan); Owner /handled the 1986,'87.' 88 and '89 Top Shih Tzu and No. 2 Top Dog in 1987.'88 Multi BIS Phil Grand/Am Champion Louwan gunning Tootsie Pop; Owner/Handled the 1995 PCCI Top Dog Multi BIS Phil Grand/Can Champion Symarun Ultimate Fantasy "Rylee"; Breeder of the No. 1 Shih Tzu in Indonesia in 2000 BIS Phil grand/ Ind Champion Sunnyside change in Time; Breeder of the No. 1 Shih Tzu in Russia Multi BIS International/Russian champion Sunnyside Wild Moment "Mork.". We have also produced several champions and grand champions both here and overseas. Handled the Top Chow chow in the Phil, Am/Br/Ind/Phil HOF Ayran Hung Red Tiger.

I have been handling/showing dogs overseas since 1990. Among the places I have handled are Thailand, Hongkong, Indonesia, Malaysia, Canada and USA (at the American Shih Tzu Club National Specialty in Minnesota). I am the only Filipina who have handled and won at the Canadian Nationals in 1993.

Conformation Show Rules and Regulations and Obedience Trial & Rally Obedience Trial Rules & Regulations are available from the Canadian Kennel Club. In Canada call toll free 1-800-250-8040, in the United States call 416-675-5511. They are also online at www.ckc.ca. The Show Superintendent will be in full charge of the show which will be governed by CKC Rules. Entries will be acknowledged after close of entries with receipt and judging schedule. This Show will be open from 7:00 am until completion of judging. Dogs must be on the show grounds one hour before the judging of their class. Judging will not commence before 8:00 am.

Owners or agents are responsible for the presence of their dogs in the judging ring. The starting time for each ring will be specified in the Judging Schedule.

PLEASE NOTE: You are responsible for cleaning up if your dog relieves itself.

The Show Committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or other misfortune, to either dogs, exhibitors, patrons, or property.

EXHIBITORS PLEASE NOTE: (Chapter 19, Section 19.7 of Conformation Show Rules and Regulations) "It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities.

Entry fees will be refunded when a bitch entered in Obedience comes into season, after the entry of the bitch has been submitted, if a Veterinarian certificate (certifying that the bitch was in season within the ten day period preceding the trial) to the Show Secretary on or before the date of the trial. Entry fees shall NOT be refunded after the closing date. Nor in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee, or because it has been entered incorrectly. If because of riot, civil disturbance or other acts beyond the control of the EKKOC it is impossible to open or complete the show, no refund of entry fees will be made.

Dogs and children must be kept under control as a courtesy to fellow exhibitors and spectators.

ATTENTION FOREIGN EXHIBITORS: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted however they are to be payable in Canadian funds. If you send a cheque in U.S. funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "payable in Canadian Funds" or "At Par". They will not be cleared by the banks. EXTRACTS FROM THE CONFORMATION SHOW RULES AND REGULATIONS

BREEDS, CLASSES, AWARDS AND STAKES 12.2.1

OFFICIAL CLASSES - CONFORMATION

All of these classes must be divided by sex. Every dog within these precincts (exceptions are IN TRANSIT AREA) must be entered in one of the Regular Official Classes or for Exhibition Only.

The following classes will be provided:

JUNIOR PUPPY	Dogs between 6 months and under 9 months on day of show
SENIOR PUPPY	Dogs between 9 months and under 12 months on day of show
12-18 MONTHS	Dogs between 12 months and under 18 months on day of show
CANADIAN BRED	Dogs born in Canada, Champions of any country are excluded.
BRED BY EXHIBITOR	Dogs <i>owned and handled in the ring by the breeder</i> for this class, but need not handle the dog for further awards.
OPEN CLASS	For all dogs
SPECIALS ONLY	For dogs who are Canadian Champions. A CKC Registration Number, ERN or MSC Number must be indicated on the entry form at time of closing.

NON-REGULAR & UNOFFICIAL CLASSES - CONFORMATION

In order for a dog to be entered in any Non-Regular or Unofficial class, dogs must also be entered in a Regular class or for Exhibition Only. Dogs may be spayed or neutered.

The following classes will be provided:

BABY PUPPY	Dogs between 3 months and under 6 months on day of show. These puppies are not eligible to compete for championship points. This class will be judged after Best Puppy in Breed, after Best Puppy in Group and BEFORE Best in Show. <u>Puppies in this category may enter and compete in Sweepstakes if a 3-6 months class is offered.</u>
VETERAN	Dogs 7 years of age or older on the day of the show. These dogs do not compete for Best of Breed. Dogs may be spayed or neutered. This class will be judged after Best Baby Puppy in Breed, after Best Baby Puppy in Group and BEFORE Best in Show.
EXHIBITION ONLY	Dogs entered in this class may not compete in any Regular class but may enter and compete in Non-Regular classes and/or Parades if provided for in this premium list.
EXHIBITION ONLY (3-6 MONTHS)	Puppies 3-6 months of age may be entered in Exhibition Only 3-6 Months provided the owner(s) has entered a dog in a Regular Official Class. <u>Puppies in this category may enter and compete in Sweepstakes if a 3-6 months class is offered.</u>

OFFICIAL CLASSES – OBEDIENCE

The following classes will be provided:

PRE NOVICE	This is for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of P.C.D (Pre-Companion Dog). Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class and must have an additional handler for each dog when they are judged together in the Group Exercise. A dog that has earned the title of C.D. is not eligible for this class. This class is an elective class and earning the title is not a requirement to advance to the Novice Classes.
NOVICE A	This is for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. (Companion Dog). Only one dog may be entered in this class by any one exhibitor. The dog must be handled by the owner or a member of his immediate family. No person who has previously trained or exhibited a dog through its C.D.X. (Companion Dog Excellent) title shall be allowed to handle a dog in this class.
NOVICE B	This is for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has not earned the title of C.D. (Companion Dog). Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the group exercises. No dog may be entered in both the Novice A and Novice B class at any one trial.
NOVICE C	This is for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D., C.D.X., U.D., or any Obedience Trial Championship Title prior to the closing date of the trial in which it is to be entered. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the group exercises. Dogs may compete in the Novice C class indefinitely. Scores earned by dog in the Novice C Class are not eligible for High in Trial and do not qualify a dog for any title.
NOVICE INTERMEDIATE	This is for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D., C.D.X., U.D., or any Obedience Trial Championship. Scores earned by dogs competing in this class are not eligible for High in Trial. A person may enter more than one dog in this class. This class is an elective class and earning the title is not a requirement to enter the Open classes.
OPEN HA & 18A	This is for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. but has not earned the title of C.D.X. (Companion Dog Excellent). Only one dog may be entered in this class by any one exhibitor. The dog must be handled by the owner or a member of his immediate family. Any person who has previously trained or exhibited a dog that has earned a U.D. title may not handle a dog in this class.
OPEN HB & 18B	This is for any dog of any recognized or listed breed, mixed breed or unrecognized breed which has earned the title of C.D. in Canada. Dogs in this class may be handled by any person. More than one dog may be entered by any handler, but each dog must have a separate handler for the group exercises. No dog may be entered in both Open A and Open B at any one trial. A dog that has earned the title of C.D.X. must compete in Open B. Dogs eligible for entry in the Utility Class are also eligible for entry in this class.
UTILITY A	This is for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of C.D.X., but has not earned the title of U.D.. The dog must be handled by the owner or a member of his immediate family. Any person who has trained or exhibited a dog that has earned a M.O.T.C.H title may not handle dogs in this class. Handlers may enter more than one dog in this class.
UTILITY B	This is for any dog of any recognized or listed breed, mixed breed or unrecognized breed that has earned the title of C.D.X. or U.D. Dogs in this class may be handled by the owner or any or any other person. Owners may enter more than one dog in this class. No dog may be entered in both Utility A and Utility B at the same trial.

UNOFFICIAL CLASSES - OBEDIENCE

The following classes will be provided (Saturday Only):

VETERAN CLASS	For any dog that has earned the title of CD or higher and is 7 years old or older on the day of the trial.
BRACE CLASS	Open to any 2 dogs of any breed that have earned the title of CD or higher.
TEAM CLASS	Open to any 4 dogs of any breed that have earned the title of CD or higher.

OFFICIAL CLASSES – RALLY OBEDIENCE

(Ring Size: 50 ft. x 70 ft.)

The following classes will be provided:

RALLY NOVICE A	Dogs entered in this class may not have won a CKC Rally Novice (RN) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner, or member of their immediate family. A person may enter more than one dog in this class. Dogs that have earned titles or are not the owners may enter in the Novice B class. All exercises are judged on leash and dogs must enter and leave the ring on leash.
RALLY NOVICE B	Any dog may compete in this class until a qualifying score in the Rally Advanced class has been earned. The owner or any person may handle dogs in this class. All exercises are judged on leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.
RALLY INTERMEDIATE	This class shall be for dogs that have earned the Rally Novice (R.N.) title. A dog completing the R.I. or any other Obedience of Rally titles may continue to compete in this class indefinitely.
RALLY ADVANCED A	This class is for dogs that have won the Rally Novice (RN) title but have not won the Rally Advanced (RA) title or any CKC Novice Obedience title. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. All exercises are judged off leash and dogs must enter and leave ring on leash. A person may enter more than one dog in this class.
RALLY ADVANCED B	This class shall be for dogs that have won the Rally Novice (RN) title. Upon completing the Rally Advanced (RA) title a dog may continue to compete in this class indefinitely. The owner or any person may handle dogs in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.
RALLY EXCELLENT A	This class shall be for dogs that have won the Rally Advanced (RA) title, but have not won the Rally Excellent (RE) title or any CKC Novice Obedience title. A dog may not be entered or exhibited in this class after official notification from the CKC that the dog has won the title (RE). No dog may be entered in both Rally Excellent A & B at any one trial. The handler of any dog in this class must be the owner, co-owner or member of their immediate family. All exercises are judge off leash and the dog must enter and leave the ring on leash. A person may enter more than one dog in this class.
RALLY EXCELLENT B	This class shall be for dogs that have won the Rally Advanced (RA) title. A dog may compete in this class indefinitely. Any person is allowed to handle a dog in this class. All exercises are judged off leash and dogs must enter and leave the ring on leash. A person may enter more than one dog in this class.
RALLY MASTER	This class will be for dogs that have earned the RE title. A dog completing the RM title may continue to compete in this class indefinitely. The owner or any other person may handle dogs in this class. A person may enter more than one dog in this class.

UNOFFICIAL CLASSES – RALLY OBEDIENCE

(Ring Size: 50 ft. x 70 ft.)

The following classes will be provided (Saturday Only):

BRACE CLASS	Open to any 2 dogs of any breed that have earned the title of RN or higher.
TEAM CLASS	Open to any 4 dogs of any breed that have earned the title of RN or higher.

For information only: Rally Advanced Excellent title -- Upon completion of the Rally Excellent title, qualifying scores may be accumulated from Rally Advanced B and Rally Excellent B to earn the Rally Advanced Excellent (RAE) title. To receive the RAE title, a dog must qualify ten (10) times in both Rally Advanced and Rally Excellent at the same trial. The title will appear at the end of the dog's name and a numeric designation will indicate the number of times the dog has met the requirements, i.e. RAE2, RAE3, etc.

To be eligible to compete in these obedience or rally obedience trials, the dog must be 6 months of age and registered or be eligible for registration with the CKC, have an ERN, PEN or a CKC Miscellaneous Certificate number. A dog may be spayed, neutered or debarked.

It is the responsibility of all exhibitors to know the CKC rules governing rally or obedience trials.
