

Rolling Inspection from arrival to Roll Call

Lure Coursing Field Trial Stakes

Open Stake – for all eligible hounds one year or older, including Field Champions. When the entry in a regular stake reaches 20 after roll call, the entry will be divided into separate stakes. **Mixed Stake** – if there are multiple breeds with entries of three or less, upon agreement of all owners, they will be combined in a **Mixed Stake**

Best In Field – Offered on Sunday all Best of Breed and Stakes winners from both days are eligible. **Puppy Stake** – 6-9, 10-12, 13-18 months – Sunday after completion of Preliminary runs **Veteran Stake** – dogs 7 years and older – Sunday after **Puppy Stake Singles Stake** – Sunday after completion of Preliminary runs

Sunday only: Puppy Stake, Veteran Stake and Singles Post Entry closes at 10:30 a.m. Roll Call 11:00 a.m.





DIRECTIONS TO THE FIELD:

From South: Hwy 21 North to Township Road 534 (First road after Hwy 16 overpass)

Turn right (east) onto Twp Rd 534 and proceed to Range Road 225 (First cross road) Turn left (north) onto Rge Rd 225. Field is 1 km north on left side of road. Entrance has SVTA in big letters over the gate

From West: Hwy 16 east to Range Road 225 (First road after Hwy 21, approx 2 km) Turn left (north) on Rge Rd 225 Field is 4 km north of Hwy 16 on left side of road. Entrance has SVTA in big letters over the gate.



EQUIPMENT AND FIELD CONDITIONS:

The field is a mown hay field, flat on the west side, sloping towards the road. An electric drag will be used. A continuous loop will be used for the Puppy, Veteran and Single stakes.

CONDITIONS AND INFORMATION:

- Saturday lunch will be a TURKEY DINNER POTLUCK! Sunday lunch will be local artisan Pizza from Nitza's Pizza (meat or vegetarian)
- Rolling inspection check in for inspection as you arrive, with your dog(s). Inspection ends ½ hour after entries close each day (roll call). It is your responsibility to take your dog for inspection prior to roll call.
- Lure Coursing is a strenuous athletic pursuit that requires your dog to be in excellent condition. Your dog relies on you to ensure this.
- All hounds will be run in trios or braces, twice, unless excused, dismissed or disqualified.
- Hounds not present at roll call will be scratched, and their entry fee will NOT be refunded. No exceptions will be made.
- All handlers MUST use a slip lead when releasing their hounds.
- Hounds may wear muzzles and/or catch collars at the owner/agent's discretion.
- Bitches in season and lame hounds will be excused and will have their entry fee returned if notice is given to the secretary prior to roll call.
- The Chair may excuse any hound from competition for any reason deemed justifiable.
- A \$10.00 fine, payable to ALCA, will be levied for any hound loose on the field at any time between Roll Call and the completion of Best in Field.
- There is limited shade and no water available, so please come PREPARED.
- ALCA, its agents, members, representatives, volunteers, etc. assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children or spectators.
- All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested in the club, or in persons to whom assignments of such rights have been made in writing by the club. 


