### REGIONAL SPECIALTY JUDGE – Sergio Pizorrno

Judged Specialty Shows in Collies, Setters, Neapolitan Mastiffs, Salukis. Has judged the Boston Terrier Club of Canada, and Peace Arch Working and Herding Association Specialty. Has judged many times all breeds and specialty shows at CC and BIS level in Uruguay, Argentina, Australia, Brazil, Ecuador, Paraguay and Sweden. Member of the examination boards for prospective judges. Specialty breed judge for Boxer, Collie, Dobermann, English Cocker Spaniel, Old English Sheepdog, Rottweiler, Setters and Siberian Husky. Handled many breeds, having obtained several national and foreign championships with Brittany's, Bull Terriers, Collies, Dachshunds, English Cocker Spaniels, Golden Retrievers, Gordon Setters, Irish Setters, Labradors, Old English Sheepdogs, Rottweilers, Siberian Huskies and Weimaraners

### REGIONAL SPECIALTY RALLY AND OBEDIENCE JUDGE - Mr. Michel Calhoun



Mike Calhoun has been a member of the Canadian Kennel Club since 1975 and was the owner of Zoon-Monere Training School for 15 years. Following an illness, he closed the school and now trains only with obedience clubs in his area. While training Dobermans, Bouvier des Flandres and German Shepherd Dogs in obedience, tracking & schutzhund, Mike also found time to offer classes in Quebec, Ontario, New York and Vermont. Mike Calhoun has been judging for 16 years, the Sport of Obedience taking him across Canada, parts of the United States and into Bermuda. During this time, he has met - Great Clubs, People and Dogs. Mike has the utmost respect for Juniors and Seniors in his ring, doing his best to help people relax so they may give their best routine on the day. Mr. Calhoun has judged Bernese Specialty Obedience Trials in Bradford, Ontario in 2004, and in Edmonton, Alberta in 2006, and in Trois Rivières, Quebec in 2006 & 2009.

Betty Osing has spent approximately twenty eight years engaged in the ownership, training, breeding, and study of all aspects of the working breeds operating as Darkstone Kennel, which is the family kennel name. Betty and her husband Byron have been engaged with the Rottweiler since 1990 adding the Cane Corso in 2002 & more recently the Tibetan Mastiff. In the past Betty Osing bred three Rottweiler litters, showing many of them to Canadian Championships. She currently owns and co-owns several Cane Corso and has bred eight litters, many of which that have gone ahead to become CKC Champions as well as AKC & CKC Grand Champions. Betty currently sits as President Of the Canadian Cane Corso Association.

Betty was the Show Chairperson and Scribe for the 2010, 2013 & 2015 Rottweiler Club of Canada National Sieger Shows held in Calgary, Alberta.

In the past, Betty served two terms as the Director of Ethics and Grievances for the AKC Parent Club (CCAA) and is an approved AKC Judges Mentor for the Cane Corso breed as well as being involved in developing the Judges Education Materials for the AKC.
