There is limited parking available. We request that you leave the trial location when your class(es) are finished.

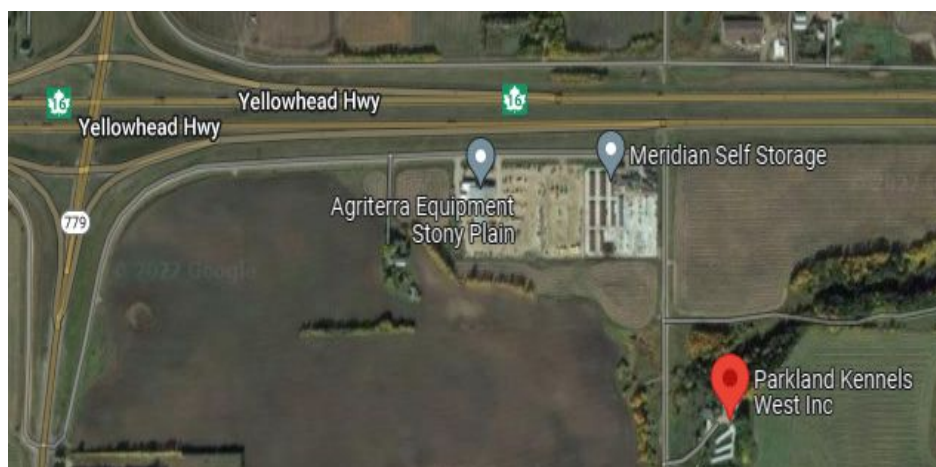
Please note: There is **NO** parking allowed in front of the Kennel Building
