### LISTING FEES:

A Listing fees of \$9.00 per dog is required for any dog which does not have a CKC registration number or ERN or PEN. All foreign dogs, if not individually registered with CKC, must provide the foreign registration, pay the required listing fee and must apply for an ERN number not later than 30 days after first entry in a trial.

# <u>Rule 14.7</u>:

"It shall be the duty and obligation of the test giving club to see that a judge, club official, volunteer or any participant at an event held under these rules, is not subject to indignities of any kind. The Working Certificate Test Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred."

### Release and Indemnification of Landowners:

24-12-3. CKC Non-member Participation Fee

- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- c) The Premium List must carry a note stating that "This only applies to dogs wholly owned by Canadian resident non-members and is not applicable to CKC members or dogs co-owned with a CKC member."
