Those exhibitors who are LISTED as EITHER THE OWNER OR THE HANDLER/AGENT on 6 or more dogs, or who are co-ordinating a group of individuals setting up together, may request that an area be reserved for them. Once the allotted area has been filled, all further requests will be returned as will any requests received after the close of entries. Requests will be acknowledged via email after the closing date and prior to the beginning of the show.

# Please note: Exercise pens <u>may</u> be restricted to 1 pen per 3 <u>entered</u> dogs, depending on the size of the entry.

In addition to the pre-assigned areas, there will also be regular first come, first served grooming space in which equipment/dogs may be left for the duration of the shows. Ex-pens are permitted in this area.

There will also be an area that will be set aside for Day of Show grooming - this will be first come, first served and all equipment MUST BE REMOVED after Best in Show each night. There will be NO exercise pens allowed in this area.

## **DOG SHOW CLASS INFORMATION**

<u>JUNIOR PUPPY CLASS</u> - This class shall be for any dog 6 months of age and under 9 months of age on the day of this Specialty

<u>SENIOR PUPPY CLASS</u> - This class shall be for any dog 9 months of age and under 12 months of age on the day of this Specialty

<u>**12 to 18 Months Class**</u> – This class shall be for dogs at least 12 mos. of age on the day of this Specialty and under 18 mos. on the day of this Specialty

<u>CANADIAN BRED CLASS</u> - This class shall be for any dog born in Canada. (Champions of any country excluded)

**BRED BY EXHIBITOR CLASS** - This class shall be for any dog owned and handled in the ring owner/breeder. The handler <u>**MUST**</u> be the owner/co-owner <u>**AND**</u> breeder/co-breeder of the dog. The owner/breeder must handle the dog at the class level, but need not handle the dog for further awards

<u>OPEN CLASS</u> - This class shall be for all dogs (Note: Divided by colour – Black, Black & Silver, Salt & Pepper)

<u>VETERANS CLASS</u> – For dogs 7 years of age and older on the day of this Show. Dogs entered in this class DO NOT COMPETE FOR POINTS (*This* class will be divided into 3 age divisions – 7 to 9 yrs, 10 & 11 yrs and 12+ yrs. Winners of each class will carry through to compete for Best of Breed) PLEASE NOTE: SPAYED OR NEUTERED DOGS MAY COMPETE IN THIS CLASS

<u>SPECIALS ONLY CLASS</u> - This class shall be for Champions of record at the time of closing of entries for this Specialty. <u>Note</u>: A Listed dog <u>MAY</u> be moved to the Specials Only Class after the closing of entries, provided the CKC Individual or Event Registration Number was received prior to the first day of the show. 

East from Vancouver, Hwy 1 take exit 116 (Lickman Road) West from Hope/Interior/Alberta, Hwy 1 take exit 116 (Lickman Road) From the United States, take either, Lynden or Sumas Border crossing, to Hwy 1 and then east of Hwy 1 to Exit 116 (Lickman Road) Heritage Park is on the South side of the freeway.



#### **RULES GOVERNING THESE SHOWS**

- 1. THE CLUB RESERVES THE RIGHT TO REMOVE ANY PERSON FROM THE SHOW. THE SHOW SUPERINTENDENT SHALL HAVE FULL CONTROL OF THESE SHOWS AND TRIALS. WHICH WILL BE GOVERNED BY CKC RULES.
- 2. ANY DOG EXCUSED BY THE SHOW SUPERINTENDENT OR VETERINARIAN FOR ANY REASON SHALL NOT, COMPETE IN ANY CLASS FOR ANY AWARDS FOR THE BALANCE OF THE SHOW.
- 3. THE SHOW COMMITTEE WILL USE DUE CARE AND DILIGENCE FOR THE WELFARE OF DOGS AND EXHIBITORS. BUT WILL NOT BE RESPONSIBLE FOR. OR ASSUME ANY LIABILITY IN THE EVENT OF ACCIDENT OR MISFORTUNE TO EITHER DOGS, EXHIBITORS, SPECTATORS OR VENDORS.
- 4. DOGS MUST BE ON THE GROUNDS 1 HOUR PRIOR TO THE JUDGING OF THEIR BREED.
- 5. THE OWNER OF A DOG ENTERED IN THESE SHOWS IS ENTIRELY RESPONSIBLE FOR ANY ERROR IN ENTERING HIS/HER DOG REGARDLESS OF HOW OR BY WHOM THE ENTRY WAS MADE.
- 6. EXHIBITORS AND HANDLERS WILL BE RESPONSIBLE FOR THEIR DOGS AND EQUIPMENT LEFT AT THE SHOW GROUNDS.
- 7. DOGS ARE TO BE EXERCISED IN DESIGNATED AREAS ONLY, NOT IN VICINITY OF SHOW RINGS
- 8. ALL REACREATIONAL UNITS WILL HAVE BUCKETS UNDERNEATH FOR THEIR SINK DRAINS. ANYONE FOUND DISCHARGING WATER ON THE GROUNDS WILL BE REMOVED BY ORDER OF THE HEALTH DEPARTMENT, AND MAY BE SUBJECT TO A FINE.
- 9. IF, BECAUSE OF CIVIL DISTURBANCE OR OTHER ACTS BEYOND THE CONTROL OF THE CLUB, IT IS IMPOSSIBLE TO OPEN OR COMPLETE THE SHOW, THERE IS NO REFUND OF ENTRY.
- 10. DOGS MUST BE ON LEASH AT ALL TIMES ON THE SHOW GROUNDS OR WITHIN THE SHOW BUILDING.

#### ALL EXHIBITORS. HANDLERS AND PATRONS ARE EXPECTED TO KNOW AND ABIDE BY THE CKC DOG SHOW RULES

SECTION #1. A dog awarded WINNERS at a Championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5), and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder. SECTION #2. The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

DOGS COMPETING*	1	2	3 to 5	6 to 9	10 to 12	13 or more
POINTS AWARDED	0	1	2	3	4	5
*includes the dog awarded W	inners					

includes the dog awarded Winners

To determine the number of points earned by a dog awarded Winners, total all dogs in competition which were defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best Opposite Sex and then consult the schedule set forth above.

A class dog awarded Best in Show at an all-breed Championship show will be credited with 5 points inclusive of any points earned at the breed or group level. In counting the number of eligible dogs in competition, a dog that is disgualified or that is dismissed, excused or ordered from the ring by the judge, shall **NOT** be included in the calculation for championship points (effective January 1, 2012) (Absentees are not to be included). In order for a dog to be recognized as a Canadian Champion it must: (1) earn at least ten championship points under at least three different judges; and (2) be individually registered in the records of the CKC or have a CKC Event Registration Number (ERN)

## **NON-REGULAR CLASSES**

EXHIBITION ONLY - All dogs entered in this class shall be listed in the catalogue with the same particulars as dogs entered in regular competition. Dogs entered in this class may not compete in any Regular class but may enter and compete in Non-Regular classes and/or Parades

**BRACE CLASS** - Shall be for two dogs (not necessarily of the same sex) (Note: effective January 1, 2006 - identical ownership NO LONGER applies) \*\*\*\*\*\*
