JUNIOR HANDLING

Junior handling in **Conformation** will be held Saturday only during the lunch break. Junior handling in **Obedience** will be held Sunday only during the lunch break. Dogs competing in junior handling must be entered in the show in one of the regular classes or on exhibition only. Registration will take place in the morning at the Secretary's table.

GENERAL INFORMATION

The Dartmouth Kennel Club will use care and diligence for the safety and welfare of the dogs and exhibitors but will not be responsible in the event of an accident to dogs, exhibitors or spectators. The Dartmouth Kennel Club will not be responsible for any equipment left on the show premises.

The building will be open an hour before judging commences.

Only dogs ENTERED in the show AND OVER 3 MONTHS OF AGE will be allowed within the show/trial precincts.

Handlers and exhibitors with several breeds must arrange for alternative handlers should judging times of different breeds conflict.

The superintendent will be in complete charge of these shows and trials.

No dogs will be allowed in the building overnight. Dogs found in an unsafe environment, distress or harm's way will be removed to safety by the appropriate authorities.

"Puppy/Dog for sale" signs will not be permitted within the precincts of the show.

It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Only a dog individually registered, or eligible to be registered, in the stud book of the Canadian Kennel Club may compete in these shows and trials.

It is the responsibility of the exhibitor/handler to clean up after their dogs outside the ring and outside the building. Please make sure your area inside and outside is clean and **all garbage is placed into the appropriate receptacle before you leave.**

If, because of civil disturbance or any other situations beyond the control of the DKC, it is impossible to open or complete the Shows/Trials, no refund of entry fees will be made.

Personal cheque or Money order for the full amount only will be accepted and should be made out to **DARTMOUTH KENNEL CLUB**.

No post dated cheques accepted. All NSF cheques will be subject to a charge of \$20.00. N.S.F. cheques are considered non-payment of entry fees and are punishable by disciplinary action and cancellation of awards. Overpayment of entries will be considered a donation to DKC Shows & Trials.

ENTRY INFORMATION

All entries must be received by the closing date and time, accompanied by the proper entry fees and submitted on an official CKC entry form or on DogShow.ca online. Please type or print clearly.

INCOMPLETE ENTRIES WILL BE RETURNED. Agents and handlers please note that full name and address of owners MUST be filled in and to whom ID's are to be returned. (Section 13.1.2, Dog Show Rules)

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom entries were made.

To comply with CKC regulations, we will be unable to accept or substitute any entry reaching the Show Secretary after the closing date and time. The Committee reserves the right to refuse any entry subject to CKC rules.

NON-MEMBER PARTICIPATION FEES ARE IN EFFECT

An annual "Non-member" participation fee for Awards and Titles will be charged to a Canadian "non-member" of the Canadian Kennel Club. This fee will match the fee charged for Event Registration Number. In order to protect the Awards and Titles earned, the "non-member" will have a choice to (a) either become a CKC member; or (b) pay the "non-member" participation fee. Failure to comply within 30 days of notification will cause All Awards and Titles to be cancelled. **Please Note: These fees only apply to dogs wholly owned by "Non-CKC" members and are not applicable to CKC members.**

Attention USA exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor.

Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank you

OBEDIENCE EXHIBITORS PLEASE NOTE:

Please designate jump height on entry forms. A bitch in season may not compete. Entry fees will be refunded only if Veterinarian's Certificate to this effect is received by the Trial Secretary before the commencement of the Trial.

RALLY CLASSES:

Novice A & B, Intermediate, Advanced A & B, Excellent A & B, Master Rally ring size is 40' by 60'.

EVENT REGISTRATION NUMBER (ERN)

All dogs that are foreign born and owned and enter Canada for the sole purpose of entering CKC events will require an Events Registration Number (ERN).

To obtain an ERN number simply do the following:

1. Send a photocopy of the dog's registration certificate reflecting current ownership, e.g., AKC Registration Certificate, with a written request for an ERN number.
2. Include with the above a cheque or money order in the amount of \$59.40 (plus GST or HST where applicable) payable to the Canadian Kennel Club.
3. Ensure that you provide us with your full return address to enable the ERN number to be sent to you.
4. Faxed requests will be accepted. Please indicate your VISA / Mastercard number, expiry date, cardholder's name and signature.

This Event Registration Number MUST be applied for within 30 days of the first day of entering a CKC event. Dogs may be entered as "Listed", however, failure to apply for an ERN number within 30 days of the first event will result in cancellation of any wins, awards, or scores.

Temporary Competition Numbers: Self-serve Online Registration for Listed Dogs

With the implementation of CKC's IT system, a new process requires all owners of unregistered, recognized breeds entering events to obtain a Temporary Competition Number (TCN). TCNs will replace the current system of entering events with "listed dogs" and will allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN). A TCN must be obtained before submitting an entry for an event and the same TCN must be used for all event entries for a dog until the dog is permanently registered. Once a dog is permanently registered or has an ERN, the TCN will be replaced with the registration number or ERN. A TCN cannot be used for Listed Breeds (MCN) or dogs that will require a (Performance Event Number) PEN or (Canine Companion Number) CCN. While there is no fee to obtain a TCN, exhibitors will still be required to pay TCN Fees (formerly called listing fees) when entering events using this number. The process of obtaining a TCN will be self-serve; exhibitors will be directed to the CKC website to complete an online application and a TCN will be issued instantly upon completion. Exhibitors may also obtain a TCN by completing a printed application and submitting it to the CKC via mail, or by contacting the Shows and Trials Division by telephone. Until March 2, 2020 dogs may still be entered into CKC events without a registration number or ERN by marking "TCN" on the entry form (or "Listed" if it is an old entry form). However, an e-mail address will be required. Before you apply for a TCN online, exhibitors are encouraged to check their dog's profiles to determine if CKC has already created a TCN for them. There will be a tab for TCN Dogs on the Owner's Portal account. Please note that if your dog does not have a registration number or ERN, and has already competed in a CKC event and earned points, scores, or awards, there is no need to apply for a TCN. CKC records will be updated accordingly.

Section 1 - a dog awarded winners at a championship show held under these rules shall be credited with a number of championship points (ranging 0-5), and the determination of the number of championship points to be credited to the dog awarded winners shall be as provided hereunder:

* includes the dog awarded winners

A class dog awarded best in show at an all breed championship show will be credited with five points inclusive of any points won at the breed or group level. In no case may a dog earn more than five points at a single show.
