KATELON BAJONA-FOX

Katelon Bajona-Fox, CMG, started breeding and showing toy poodles in 1974. She quickly fell in love with the sport and in 1980 went onto breeding Standard Poodles and later Smooth Mini Dachshunds in 1987. She also developed a liking for terriers and in 1989 started breeding Wire Fox Terriers and Mini Schnauzers. As of today she still has toy and standard poodles, along with Mini Schnauzers.



LEN HARFIELD

A dog lover always, Len was given a Labrador Retriever puppy for his 7th birthday. Soon after, one night at the movie theatre he found a Papillon puppy. His mother said it looked like a baby skunk and he'd have to return it in the morning. He took it to bed with him and kept it until it died at age 13. The fascination with canines was set for life. There was a poodle kennel two miles from his home and he liked to go there to see the dogs and the puppies. In those days the standard poodles at that kennel were somewhat guard-like and even cranky but the miniatures were outgoing.



In 1970 Len bought his first miniature Poodle and later added standards

to the kennel. Other breed involvement included hounds and toys. Miniature Poodles and and Standard Poodles under the Kasalland prefix became a lifelong journey. More than 125 champions, many Best In Show winners and several top winners came out of Kasalland and the name can be found in pedigrees around the world.

In 1991 Len started to judge dogs and eventually became all breed, taking it slowly so to learn as much about breed type as he could.

JANET LOBB

I began in Dogs in 1974, with the acquisition of our first Doberman. Along with my husband Joe, we bred our first litter in 1977 under the 'Dobenhaus' prefix and in 1988 we added the Smooth Fox Terriers which we continue to breed and exhibit on a limited basis under the "FauxPaw" prefix. We handled professionally for a limited number of clients, and over the years were provided with a continuing number of exceptional dogs, some of which achieved top rankings.



As well as Dobes and Smooth Fox we have also owned and exhibited other breeds that have added to our many successes...German

Shepherd, Bernese Mountain Dog, Bouvier, Greyhound and Black & Tan Coonhound.

I am licensed for 'All Breeds' in Canada and have also judged in the USA, China and Australia having had the honour of awarding BIS in all countries. As well, I have had both National and International assignments in Finland. I was also honoured to have officiated at the Canada's 'Show of Shows' and the 'Maritime Spectacular' events.

EVENT REGISTRATION NUMBER (ERN)

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. Fee is \$58.50 per dog after January 1, 2013 plus applicable taxes. For further information contact:

ENTRY INFORMATION

- 1. No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
- 2. Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone and telegraph entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
- 3. There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
- 4. Substitutions or cancellations of any entry after the closing date is prohibited. Moving Class Dogs to Specials is permitted. An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration can be entered. The committee reserves the right to refuse any entry subject to CKC Rules.
- 5. ENTRIES POSITIVELY CLOSE 8:00 P.M. WEDNESDAY, APRIL 3, 2013 and must be in the hands of the Show Secretary by that date.
- 6. Identification Cards and Judging Schedules will be mailed as soon as possible after the entries close. Identification Cards must be presented upon arrival at the show.
- 7. Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary action. Any N.S.F. cheques will be subject to a \$25.00 service charge.

1. The Show Superintendent will be in full charge of the show which will be governed by CKC Rules.

GENERAL INFORMATION

- 2. The Guelph & District Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- 3. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
- 4. Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused each show when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.
- 5. Judging will commence at 8 a.m. Friday, April 19, Saturday, April 20 and Sunday, April 21, 2013. A later starting time may be specified in the judging schedule. Starting time of each ring will be specified in the judging schedule.
