A CKC listing fee of \$8.82 (including GST) is payable for each entry of a dog for which a CKC or Event Registration Number (ERN) is not shown on the entry form. An ERN must be applied for within 30 days of the hunt test or all awards to the dog will be cancelled. GENERAL INFORMATION

Working Certificate Test Rules and Regulations Books are available from the Canadian Kennel Club, 200 Ronson Drive, Suite 400, Etobicoke, ON, M9W 5Z9.

1. **Entries must be typewritten or clearly printed.** Owners are responsible for errors on entry forms. The Fraser Valley Retriever Training Club does not assume any responsibility for incorrect information or errors due to illegibility of information on any entry form. No phone, faxed, emailed or late entries will be accepted.
2. Running order will be determined by draw at the home of the test secretary after time of closing.
3. Make cheques payable to Fraser Valley Retriever Training Club (FVRTC). No post-dated cheques will be accepted.
4. A separate entry form for each dog in each test is required (official CKC entry form).
5. Entry fees will not be refunded. In the event that a dog is absent, disqualified, excused by a judge or barred from competition by action of the Test Committee or the Canadian Kennel Club, or because it has been entered incorrectly, or if it is impossible to open or complete the test, no refund of entry will be made.
6. Bitches in season will not be eligible to compete and are not allowed on the test grounds.
7. Entry and listing fees paid for any dog withdrawn because of injury, illness or death shall be refunded in full. An appropriate veterinary certificate must be given to the Test Secretary BEFORE the start of the tests to qualify for a refund.
8. Dead ducks will be used.
9. **All Throwers, Judges and Competitors should wear dark or camouflage clothing. Handlers shall not wear white or light clothing at any time, but handlers may wear handling jackets for the blinds in the WCX.**
10. ERN's (Event Registration Numbers) for foreign born or foreign owned dogs can be obtained from the CKC. ERN must be applied for within 30 days of the first day of entering a CKC event.
11. The Fraser Valley Retriever Training Club, its members and the land owners will use due care and diligence for the welfare of dogs and exhibitors, **BUT will not be responsible for, nor assume any liability in the event of an accident or other misfortune to either dogs, exhibitors or patrons.**
12. Electric collars (either dummy or live), prong or pinch type collars shall not be worn by any dog on the grounds, at any time during the event.
13. There shall be no training of dogs on the test grounds, except for single training bumpers which are thrown by hand by the handler, within 24 hours of the commencement of the event or at anytime during the event.
14. There will be no concession available on the test grounds.

Trial Headquarters will be in the main parking area of the Jackman Wetland, located at 26965 - 8th Ave., Aldergrove, BC behind the OTS training school.

From Highway #1. Take exit #73 which is 264th Street and head south to 8th Ave. Turn left and go to just before 272nd St. and we're on the left.

It shall also, within twenty-one days after the test, report to the Canadian Kennel Club the nature of the alleged indignity, the names of the parties concerned and its findings. The Discipline Committee of The Canadian Kennel Club shall have the power to take such action as it deems fit on receipt of a report indicating that this rule has been violated. A copy of this rule shall be prominently placed in every premium list.

BY ATTENDING this test, competitors and spectators acknowledge that the Fraser Valley Retriever Training Club, test officials and the Landowners involved do not accept liability for any loss, damage or injury incurred by exhibitors, dogs or spectators.
