CONSTRUCTION ALERT!

Our facility at 20215 Vanneck Road can be access from the **North**, at the corner of Nairn Road. There are "Road Closed" signs in place, but it is safe to drive around the barrier and get to the Trial Site.

Alternatively, if you are coming through London, access can be made from the Old River Road and Oxford Street West. Old River Road also is indicated as closed, but it is open.
