

THINGS TO REMEMBER AS A COMPETITOR IN THIS OBEDIENCE TRIAL

As this may be your first opportunity to compete under the new Obedience rules and regulations, the following reminders may help you in your preparation:

- No dog entered in the obedience trial will be allowed off leash unless it is in the ring being judged. (6.7.4). This means that you are not able to practice off leash work outside the ring either before or after you have been judged.
- The judge will inform the first competitor in each class what the heeling pattern will be 10 minutes before that exhibitor enters the ring. This may be done verbally, by posting the pattern ringside or by demonstration. (8.1.2)
- In the Novice Intermediate, Open and Utility Classes, the dumbbell and articles shall be taken from the handler at the entrance to the ring, placed on the judges table until required, then returned before the handler leaves the ring. (8.13.6) This means that you can no longer drop off your articles or dumbbell prior to entering the ring.
- In the heel free exercise your hands and arms must either move naturally at your sides and hang naturally when stopped, or, the right hand and arm must move naturally at the side, while the left hand must be held against the front of the body, centered in the area of the waist, with the left forearm held against the body. (8.14.7)
- No food, treats or training aids shall be allowed within 3.05m (10 feet) of the ring entrance. (8.15.3)
- In all exercises where the dog is to return to the handler, while the dog is coming in and until the dog has sat in front; the handler must stand facing the dog with hands and arms hanging naturally at the sides. (8.14.6)
- Only those collars specified in (8.16.2) are permitted within the venue. As an example, prong or pinch collars are not permitted within the venue.
- When heeling (apart from in pre-novice) more than one additional command or signal to heel will result in a non-qualifying score. (10.6.9)
- > The Novice Stand for Examination is now done "off-leash" (10.7.3)
- In the Broad Jump exercise, four boards are now used for dogs with jump heights of 24 inches +. (8.21.1) Previously 4 boards were introduced for those dogs with jump heights of 25 inches +.
- The only jump heights accepted are those specified on the Entry Form. Competitors will not be able to change jump heights ringside and have different heights for Open and Utility. (6.2.2)
- The Open and Utility B classes are now mixed sequences. The sequence order will be posted ringside approximately 30 minutes before the start of the class. (12.2.8). Make sure that you study the sequence order prior to entering the ring so that you will know where you are going.
- In the Open Drop on Recall, the judge must give a signal to alert you to drop your dog. (12.7.3)
- In the Utility Seek Back exercise, heeling is now a principal feature and must include at least one right or left turn in the heeling pattern. The glove will be dropped anywhere other than the center line of the send away. (13.6.2)
