

A Prize and Rosette will be awarded to the top Junior Handler in the regular classes in conformation.

A special award will be presented to any dog finishing its Championship title at this show.

GENERAL INFORMATION

- 1. The Show Superintendent will be in full charge of the shows and trials which will be governed by CKC Rules.
- The German Shepherd Dog Club of London will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- There is no refund for duplicate cheques. Every effort will be made to find all duplicate entries, however if the entry has been processed and appears in the official catalogue, no refund will be made.
- 4. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show or trials, no refund of Entry will be made.
- 5. Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused when not required for further judging. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging.
- Judging will commence at 9 a.m. EST Saturday May 21, 2011. A later starting time may be specified in the judging schedule. Starting time for both conformation and obedience will be specified in the judging schedule.
- 7. No pinch collars will be permitted within the precincts of the Show and Trials. No cover will be provided in case of inclement weather. SHOW PRECINCTS: The Show precincts shall consist of all areas set out for rings, all shelters or facilities set aside for show officials, judges or exhibitors and handlers and 30 feet outside of the judging rings.

NON-MEMBER PARTICIPATION FEE

Effective January 1, 2011:

- a) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.
- b) In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.
- These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.

CHAMPIONS AND CHAMPIONSHIP POINTS

Chapter 15, Section 15.1.1 A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

Section 15.1.2 The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

*includes the dog awarded Winners.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge <u>SHALL</u> be included in the calculation for championship points.

To determine the number of championship points earned by a dog awarded Winners, total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed, or Best of Opposite Sex and then consult the schedule set forth above.

Section 15.1.12. In order for a dog to be recognized as a Champion and its owner provided with a Championship Certificate, the dog must have earned at least one 2 point win either at the breed or group level.

MOVING CLASS DOGS TO SPECIALS

Chapter 8, Section 8.9 of the Conformation Show Rules and Regulations has been amended to allow a dog which is individually registered in the records of the Canadian Kennel Club, and has completed the requirements for a Championship, after the Closing Date for entries for a show, may be transferred from one of the Regular Classes to "Specials Only", providing the request for a transfer is submitted to the Show Secretary in WRITING at least one hour prior to the opening of the show, by the owner or handler. Every day of a 2 or 3 day show is a separate show. Please note that this rule is effective up to one hour prior to the opening of the show, NOT one hour prior to the judging of the breed.

CONFORMATION SHOW RULES AND REGULATIONS

The Exhibitor is responsible for knowing and complying with the Conformation Show Rules and Regulations of the Canadian Kennel Club. Chapter 4-Section 4.7.3 of the Conformation Show Rules and Regulations states: A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

EVENT REGISTRATION NUMBER (ERN)

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. Fee is \$57.60 per dog after January 1, 2011 plus applicable taxes.

A Rosette will be awarded for 1st to 4th place in each class.

OBEDIENCE TRIALS TROPHY LIST

The following awards are for German Shepherd Dogs only.

A Trophy and Rosette will be awarded to the German Shepherd Dog with HIGH COMBINED SCORE (Open B and Utility). A Prize and a Rosette will be awarded to the HIGHEST SCORING VETERAN German Shepherd Dog in each trial.

THE TERRY SMITH MEMORIAL TROPHY

to be awarded to the Highest Scoring German Shepherd Dog (of the day) with a Tracking Title. Titles that will be eligible for this trophy are the following: TD, TDX, UTD, UTDX, SchH1, 2 or 3, TR1, 2 or 3.

A Prize and Rosette will be awarded to the top Junior Handler in the regular classes in obedience.

A special award will be presented to any dog finishing its Obedience title at these trials.

Awards will be given for qualifying scores only and must be picked up the day of the Show and Trial. No awards will be mailed. Eligibility for awards must be registered with the ring steward.

SPECIALTY CONFORMATION CLASSES – BOTH SEXES

OFFICIAL CLASSES:

JUNIOR PUPPY - a dog between 6 mos. & under 9 mos. on day of show. SENIOR PUPPY - a dog between 9 mos. & under 12 mos. on day of show. 12–18 MONTHS - a dog between 12 mos. & under 18 mos. on day of show. CANADIAN BRED - a dog which is born in Canada.

BRED BY EXHIBITOR - dogs owned and handled in the ring by the breeder. The handler must be the owner/co-owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class, but need not handle the dog for further awards.

OPEN CLASS - for all dogs.

VETERANS CLASS - for all dogs over seven years of age as of the date of the show. These dogs to compete for the regular placements, and the 1st place Dog and Bitch will go on to compete for Best of Breed. The winner of the Veterans Class will not compete for points but go directly into the Best of Breed competition. Dogs entered in this class may be spayed or neutered.

SPECIALS ONLY - dogs who are Canadian Champions only.
SEXUALLY ALTERED - Limited to dogs and bitches over 6 months of age which have been sexually altered by veterinarian procedure.
