Discipline re Indignities

As per CKC rules and regulations, it shall be the duty of the test-giving club to see that a judge, club official, steward, volunteer or competitor at a Draft Dog test is not subject to indignities. The Draft Dog Test Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

AS A REMINDER:

No dog may be brought onto the grounds or premises of an event if it:

- 1. Is known to have distemper, parvovirus, kennel cough or other communicable disease.
- Has recovered from distemper, parvovirus, kennel cough or other communicable disease with the last 30 days prior to the event
- 3. Has been housed within 30 days prior to the event on premises on which any of the above existed.

Clubs have the right to remove a dog from the event premises and the exhibitor may face disciplinary action if it is found that CKC rules have be contravened.

A dog that bites or attempts to bite another dog or a person may be removed from the event grounds or premises for the duration of the event by the Draft Dog Test Committee Chair. Please ensure that your dog is under control at all times. Please, no flexi-leads on the test grounds, leashes should be no longer than 6 feet.

Closing Date: 5:00 p.m. Tuesday, Oct. 3, 2023

or when the limit as outlined on front of this premium list is reached, even if official closing date for entries has not arrived. If combination of DDX/BDDX entries has not been received by the closing date these openings may be filled with additional DD/BDD entries. Entry fees will not be refunded after the closing date. If the limit is reached prior to closing date, a list of alternates will be kept to fill any vacancies created due to early (prior to closing) cancellations. Entry fees will be refunded within 10 days following the test to all withdrawals replaced by an alternate and to all alternates that did not participate in the test. Email confirmation of receipt of entry will be provided to entrants who provide a valid, legible email address on their entry form.

Foreign born/ owned dogs:

A dog not individually registered with the CKC may be entered at a test held under these regulations as a "Listed" dog, provided it has an event registration number (ERN) or obtains this from the CKC within 30 days of the first test entered otherwise scores will be cancelled. An ERN (Event Registration Number) can be obtained by contacting the Canadian Kennel Club, Show & Trails Division, 200 Ronson Drive., Suite 400, Etobicoke, Ontario M9W 5Z9. Non-member Participation Fee:

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the nonmember participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

General Information and Test Rules:

It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing.

Copies of the CKC Draft Test Regulations are available from the Canadian Kennel Club (Tel: 416-675-5511)

As per the Draft Dog Test Rules and Regulations, the group option as stated in section 11.2, may be offered at this test.

To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching the Test Secretary after the official closing date as published in the premium list or after the maximum number of entries has been received.

No Entry will be accepted unless all particulars called for on the Entry form is shown thereon. Incomplete entries will be returned.

No Entry will be accepted unless accompanied by the entry fee.

Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Cancellations of any entry after the closing day are non-refundable.

The Club reserves the right to refuse any entry, subject to CKC Rules.

Armband numbers and judging schedules will be e-mailed as soon as possible after entries close.

Eligibility: Open to all purebred CKC recognized & CKC Miscellaneous breed (MCN), and non-recognized dogs eighteen months of age or older on the day of the event. Every dog entered must be one of the following: Registered with the CKC; have an Event

Registration

Number (ERN); eligible for registration with the CKC; have a Performance Event Number (PEN); or a Canine Companion Number (CCD). Entries in the Draft Dog Excellent Test must have a CKC Draft Dog (DD) Title. Entries in the Brace Draft Dog Excellent Test must have a CKC Brace Draft Dog Title. The Judges must excuse a dog at any time during a test for lack of physical capacity.

Entry Limit: There is a limit of a combination of 10 Draft Dogs/10 Brace Draft Dogs and 5 Draft Dog Excellent/5

Brace Draft Dog Excellent entries which will be accepted on a first come, first served basis.

Entries:

Entries must be complete, signed & submitted to the Entry Line. The order of competing shall be the order that entries are received except those dogs handled by the same person will be separated when possible. No delays will be permitted for handlers entering more than one dog and entrants doing so must have an alternate handler available for the group down exercise if a conflict arises.

Bitches in Season: Bitches in season are allowed to compete but all exercises will be judged after all other dogs have been tested. Bitches in season must be kept away from the test site prior to testing.

Equipment: Each entrant must supply his or her own equipment and apparatus. The test committee will supply the freight load. DDX Entrants must provide their own backpacks and backpack weight.

Test Regulations:

All dogs entered in the Draft Dog Test must go through the basic control exercise, regardless of obedience titles held.
