

## **RELEASE AND WAIVER OF LIABILITY AND INDEMNITY OF CERTAIN LIABILITIES**

In consideration of being permitted to enter upon and use for the purpose of a dog show, referred to below as “the activity”, and for the period of Friday, September 11, 2020 through Sunday, September 13, 2020, the locations, facilities and properties described as Amigo Kennels, located at 31418, Range Road 21, Mountain View County, Alberta, and the surrounding locations, facilities and properties used in this activity, all of which are referred to below as “the grounds”,

I, \_\_\_\_\_ for myself, any minors under the age of eighteen (18) years, referred to below as “minors in my charge”, and my or their personal representatives, heirs, executors, administrators, trustees, successors, receivers or assigns, hereby acknowledge and agree that:

1. The activities at the grounds, including travel to or about the grounds, potentially involve risk to me or to minors in my charge and I agree to assume full responsibility for all such risks of any kind whatsoever for myself and any minors in my charge.
2. Neither Amigo Kennels, the Brittany Spaniel Club of Canada (BSCC), the German Shorthair Pointer Club of Canada (GSPCC) nor any landowner or tenant at the grounds is responsible for any loss, damage or injury suffered by me or by minors in my charge, for any reason whatsoever in participating in the activity on the grounds, using the grounds, or in travelling to, from, or about the grounds, including negligence on the part of Amigo Kennels, BSCC, GSPCC, their directors, officers, agents and any other representative of any of them including any volunteer, all of whom are referred to below as “representatives”, or any landowner or tenant.
3. I hereby relieve, release and waive Amigo Kennels, BSCC, GSPCC, their representatives, and any landowner or tenant, from any and all loss, liability, damage, cost, expense, charge, fine, penalty, assessment, consequential, indirect or special loss which may be suffered or incurred by me or by minors in my charge, including but without limitation, any loss or liability arising from any act, error, omission, or any negligent, wilful or wanton misconduct of Amigo Kennels, BSCC, GSPCC, or their representatives, or any landowner or tenant.
4. This release and waiver is intended to be as broad and inclusive as is permitted by the laws of the Province of Alberta and the laws of Canada applicable in Alberta and if any portion thereof is held invalid, the balance shall, notwithstanding, continue in full legal force and effect.
5. On behalf of myself and any minor in my charge, I hereby indemnify, defend and save harmless and by these presents do indemnify Amigo Kennels, BSCC, GSPCC, or their representatives, and any landowner or tenant from and against any and all loss, liability, damage, cost, expense, charge, fine, penalty, assessment consequential, indirect or special loss and reasonable legal fees on a solicitor and his own client basis, expert fees and any disbursements arising out of any act, omission or state of facts and any demand, suit, proceeding, claim, assessment, judgment, settlement or compromise, suffered or incurred by Amigo Kennels, BSCC, GSPCC, or their representatives, a landowner or tenant, including without limitation injury or death of a representative, landowner or tenant, as a direct or indirect result of, or arising in connection with or in any manner whatsoever related to:
  - a. Any failure by myself or any minor in my charge, to observe or perform or any breach or infringement by myself or any minor in my charge, of any rule, regulation, policy or

procedure of Amigo Kennels, BSCC, GSPCC, or their representatives, a landowner or tenant; and,

- b. Any act, error or omission or any negligent, wilful or wanton misconduct of myself and any minor in my charge in connection with the attendance upon or use of the grounds or property of any kind used by Amigo Kennels, BSCC, GSPCC, or their representatives in connection with the activity carried out on the grounds.
6. I understand that Amigo Kennels, BSCC, GSPCC, or their representatives accept each such indemnity in favour of Amigo Kennels, BSCC, GSPCC, or their representatives, landowners and tenants, as agent and trustee and Amigo Kennels, BSCC, GSPCC, or their representatives may enforce any indemnity contemplated herein in favour of Amigo Kennels, BSCC, GSPCC, their representatives or any, landowner or tenant on their behalf.
7. I have read this document and I am at least eighteen (18) years of age and I am signing this document on behalf of myself, and if applicable, as parent, guardian or in loco parentis of any person less than eighteen (18) years of age for whom I am responsible and who may use or be present at the grounds.
