Entries open Sept 25 at 7:00 p.m. and close Nov. 1, or when entry limit is reached Late or day of event entries are not available. Trial to trial move-ups, move-downs and lateral moves are permitted. Judges are limited to 8 hours of judging and a maximum run value, requiring this club to limit entries.

Entry fees: Instinct: \$15 per run. Novice, Open, Senior, Master & Crazy 8s: \$25 per run.

Entry fees must accompany registration. Entries will be registered in the order they are received. Club members working key positions at the trial will be given precedence.

SCHEDULE

Site opens at 8:00 a.m and closes at 7:00 p.m. every day. Check-in begins at 8:15 a.m. General briefing at 8:30 a.m. followed by class briefing. First dog on the line at 9:00 a.m.

RUN ORDER

VIPEG reserves the right to change the run order based on entries received and will send out the final class run order and judging schedule two days before the start of the trial. Blinds of 6 dogs will be used for Instinct, Novice and Open; blinds of 5 dogs for Crazy 8s, Senior and Master. Dogs handled by the same person will be in different blinds.

DIRECTIONS TO 5435 MATSON ROAD

From the Trans Canada Highway, turn west at the Cedar Road intersection (just south of Nanaimo Airport). Immediate left onto Thomas Rd. for 1 km, then very hard right onto Matson Rd. Storm Haven Acres is at the very end. Enter through the gate and **close the gate behind you** to prevent neighbour dogs entering the property.

EXHIBITOR INFORMATION

- 1. Trial will be held indoors in an unheated, partially open barn on a wood and concrete floor. Covered outdoor blind, 10' x 20'. No indoor crating.
- 2. There is limited parking near the barn and additional parking elsewhere on the property.
- 3. Smoking and vaping are not permitted anywhere on the property.
- 4. In the trial vicinity, dogs must be on lead (maximum 6', no retractable leads) or crated except when in the ring, and under control at all times. Note that dogs can become highly excited in this environment. Be proactive in managing your dog(s), give others space and respect the needs of other dogs and handlers.
- 5. Dogs may be walked on leash, extendable leash or long line in the fenced dog park next to the trial area. Watch for wildlife and livestock. Pick up after your dog!
- 6. Electronic collars, bark collars, halters and muzzles may not be used on the trial grounds. Dogs may not be brought to the ring on retractable leads. Prong collars are permitted, but must be covered and quick-release. Dogs will run naked (i.e., without collar, leash or harness) in the ring.
- 7. Bitches in season may participate, but must be kept separate from other dogs and crated in your vehicle, must wear panties at all times except when pottying, and will run last in each event for which they are entered. Advise the Trial Secretary as early as possible if you will be bringing a bitch in season.
- 8. The ring is marginally accessible. Cheerful assistance will be available for competitors with disabilities; please advise the Trial Secretary ahead of time or one of the trial officials at the trial if you need assistance.

AWARDS

Ribbons will be awarded for qualifying runs in all A and B classes, for 1st to 4th place at each height division in all A classes except Instinct, and for 1st to 4th place in B classes. Rosettes will be awarded for High in Class and new titles.

DOG AGGRESSION

Any dog behaving in a threatening or aggressive manner towards another dog or person may be dismissed from the trial at the discretion of the judge or the event committee in accordance with trial hearing guidelines and BHA rules.

SAFETY

The safety of human participants, dogs and rats is of primary concern. By entering these trials, competitors acknowledge that they are familiar with Barn Hunt rules and regulations and that their dogs are familiar with and physically able to perform all course elements. In addition, competitors commit to following all instructions and direction from the judge or trial officials. Abuse of any kind towards volunteers, dogs, rats, competitors, judges or trial committee members will not be tolerated and will result in immediate dismissal from the event.

WAIVERS

Please submit the attached waiver with your trial entry. Entries will not be accepted without the waiver.

Competitors who have not previously signed a Storm Haven Acres waiver will be required to do so on arrival.

COVID-19

The COVID situation continues to change, and we will be following the BC public health orders in effect at the time of the trial. Competitors will be advised if any specific protocols (e.g., masking) are required.

REFUND POLICY

Entry fees will be refunded if the handler is not well on the day of the trial. Otherwise, no refunds after the closing date (May 31) except for sick or injured dogs with submission of a note from a veterinarian. Submit refund request to the Trial Secretary no later than the close of the trial. Refunds will not be issued for dogs who are absent, disqualified, excused or otherwise barred from participating by the judge or the trial committee.

Every effort will be made to hold this event as scheduled. No event fee will be refunded if the event cannot open or be completed by reason of riots, civil disturbances, fire, flood, earthquake, public emergency, act of public enemy or any other case beyond the control of the event committee.
