I (we) agree that CARO Canadian Association of Rally Obedience and/or River Valley Obedience and Field Trial Club (the hosting club) has the right to refuse this entry for any cause which the organizing committee alone shall deem to be sufficient. In consideration of the acceptance of this entry, of the holding of the event, and of the opportunity to have the dog participate and/or to be judged, I (we) agree to hold the organizing committee, the hosting club, the CARO Canadian Association of Rally Obedience, including their members, officers, directors, agents and employees, sponsors of the event, and owners of the premises upon which the event is held and their employees, harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the event premises or grounds or near any entrance thereto and I (we) personally assume all responsibility for any such claim. I (we) further agree to hold the aforementioned parties harmless from any claim for loss of this dog by disappearance, theft, death or otherwise, and from any claim for damage or injury to the dog, whether such loss, disappearance, appearance, theft, damage or injury be caused or alleged to be caused by the negligence of the parties aforementioned or by the negligence of any other person or any cause or causes. I (we) hereby assume the sole responsibility for and agree to indemnify and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death resulting at any time therefore, sustained by any person or persons, including myself (ourselves) or on account of damage to property arising out of or in consequence of my (our) participation in this event howsoever such injuries, death, or damage to property may be caused and whether or not the same may have been caused or may have been alleged to have caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

#### INFORMATION

CARO encourages ALL dogs – purebred, mixed breeds, pets, companions – to participate in the fun and exciting sport of Rally Obedience.

#### **Facilities**

There will be designated crating areas for dogs inside the building. There will be a hospitality table and coffee. The canteen will be open from 10:00 a.m. until 3:00 p.m.

All dogs must be kept in an x-pen, crate or on leash when not in the ring. Any dog engaging in aggressive behaviour at any time will be required to leave the premises. In such cases, no refund of fees will be paid.

#### Trial Information

The trial is held under CARO rules and regulations.

It is CARO recognized and approved.

In order to assist CARO in the verification of titles earned, exhibitors should complete the Titles Earned Sheet (available at the check-in table on the day of trial.)

#### **Entries and Closing Date**

Closing date for registrations is 14 April 2016. No telephone, e-mail, or fax entries will be accepted as payment must accompany the entry.

Any changes to entries, including cancellations, will be accepted until 14 April 2016. Changes must be made to the Trial Secretary by telephone, e-mail, or in writing. Cancellations received after 14 April 2016 will not be eligible for a refund of fees. Appeals must be directed to the Executive of River Valley Obedience and Field Trial Club (PO Box 3216, Stn. B, Fredericton, NB E3A 5G9), must be in writing, and must be postmarked no later than 14 May 2016.

Entries may be accepted on the day of the event <u>if time constraints will allow ie. entries must be made at least 30 minutes to the start of that class.</u>

#### Check-in and Measure-in

Check-in will be at 8:30 a.m. 23 April 2016 and 24 April 2016. Registration for all classes closes at 30 minutes prior to class start – including class changes due to titles being earned. Class times are subject to change.

#### **Awards**

Qualifying ribbons will be awarded to each dog/owner team who achieves a score of 170 or better. For team events, qualifying ribbons will be awarded for a score of 180 or better. Rosettes will be awarded for 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> in each class.
