#### **ENTRY ELIGIBILITY**

- 1. Dogs must be permanently registered with UKC, or have a Temporary Listing (TL) number in order to enter. No exceptions will be made. Entries for ineligible dogs will be returned.
- 2. Dogs must be 6 months of age on the day of the event.
- 3. An unentered dog may not be substituted for an entered dog.
- 4. Temporary Listings are not available at the event.

#### **ENTRIES**

- 1. **Pre-Entries:** Licensed Classes: \$21.00 per entry, KSH members: \$18.00 per entry. E-TRANSFER, CASH or CHEQUE ONLY.
- 2. Pre-entries open October 1<sup>st</sup> and must be received by event staff before October 28<sup>th</sup>, 2024.

Entries received after October 28<sup>th</sup> will be charged Day of Show price. US competitors only – contact the Trial Secretary about using PayPal for entry fees.

3. **Day of show entries:** \$24.00 per entry, KSH members \$21.00. CASH or CHEQUE ONLY.

#### **SUBMITTING ENTRIES**

- 1. Entries must be submitted on the current Official UKC Nosework Entry Form. Downloaded copies or photocopies of these forms may be used as well. Please do not use an old version of the form.
- 2. Entries received incomplete will not be accepted.
- 3. Pre-entries may be mailed, scanned and emailed, or hand-delivered to the Event Secretary. Please do not email photos of your entries, you will be asked to scan and re-send.
- 4. **Mailed Entries** must include the entire form and be signed. Mailed entries received without fees shall not be accepted.

#### **PAYMENT**

1. Payment may be made by e-transfer, cash or cheque.

E-transfers -- address to use: **kootenayscenthounds@gmail.com** password: **nosework** Fees must be in Canadian funds. No entry will be accepted without payment. If you are paying via e-transfer, please submit payment once the Trial Secretary has confirmed your entry.

2. Make cheques payable to "Kootenay Scent Hounds".

3. Returned cheques do not constitute valid entry fees.

#### **REFUNDS**

- 1. Entry fees will be refunded up to the day before the trial begins provided that a written request is made to the Trial Secretary (e.g., text. Messenger message, or email). Should the event be cancelled, entry fees will be refunded.
- 2. Entry fees shall not be refunded in the event that a dog is absent, disqualified, excused by Judge, or barred from competition by action of Event Committee.
- 3. If, because of riots, civil disturbances, or other acts beyond the control of the host organization it is impossible to open or to complete a show or trial, no refund of entry fee will be made.
- 4. Every effort will be made to find all duplicate entries before processing. If a duplicate entry is processed, however, no refund will be made.
- 5. If, in the opinion of the host club, the wellbeing of dogs, exhibitors or spectators is at risk due to extreme weather conditions, such as, but not limited to snow storms, hurricanes, lightning, or extreme heat, the host club may cancel or stop a show or trial before completion. No refunds will be made in such cases.

#### Site Information:

There will not be indoor crating space available. Dogs must be crated in vehicles. Owners are expected to pick up after their dogs.

Food will not be available on site, restaurants and grocery stores are within a 5 min drive in Winlaw. Indoor site flooring is packed, raked dirt. Access to washroom involves several stairs and uneven ground (gravel driveway).

\*Please note that this area (including the trial site) does not have cell service.\*

#### **Driving Directions:**

From either Castlegar or Nelson, turn north onto Highway 6 North (towards Slocan City and Nakusp). Continue on Highway 6 for 27 kilometres. Turn right onto Cedar Creek Road (you will have just passed a Home Hardware on your left), and continue for 650m. The destination will be on your right.

**Hotel Information:** Several pet friendly hotels/motels are located within Castlegar, as well as within Nelson. Castlegar options include the SureStay Hotel, Canada's Best Choice, Sandman Hotel, Super 8 Hotel, and Twin Rivers Motel.

In Nelson, pet-friendly options include the Mountain Hound Inn, Alpine Inn and Suites, Best Western, and the Hume Hotel.

**Liability:** Neither KSH, L2P, nor the United Kennel Club, Inc. is responsible for the theft, loss, accident or injury to any dog, person, or property at any of their events. Absolutely no alcoholic beverages or drugs are allowed.

#### Awards to be Presented:

Kootenay Scent Hounds will award a qualifying ribbon for each element leg earned, ribbons for placements from 1<sup>st</sup> to 4<sup>th</sup>, and rosettes for Nosework Element titles and Nosework titles completed.

#### Move-Up Policy:

Participants may move up to the next level provided that the level is offered at this event. A completed Class Change form must accompany the request and the request is to be made while DOS entries are being accepted.

#### **Show Veterinarian (on-call):**

Please be aware that vet services in this region are limited. The closest 24-hour emergency vet services are located in Kelowna BC (Fairfield Animal Hospital), or in Spokane WA.

Local competitors, please be prepared to contact your regular vet for any emergencies arising during this trial.
