All times are local times. Ring stewards will adhere as closely as possible to the times indicated. There will be no waiting. Judging of the Groups will follow the judging of the breeds with BIS & BPIS following the judging of the last group. The precincts of the Show and Trials are the building and its entrances. The arena will be open each day at 6:30 a.m. and will be open Friday from 4 pm until 8 pm for those who wish to set up early. The Show/Trial Superintendent will be in complete charge of these shows and trials. RALLY SANCTION MATCH FRIDAY. REGISTRATION 5:30, STARTS AT 6 PM SATURDAY RALLY SANCTION MATCH AT COMPLETION OF OBEDIENCE JUDGING.

**Directions to the show:**

**FROM FREDERICTON** ~ take highway #8 toward Miramichi City (on some maps the town of Newcastle still appears) Just as you reach the edge of the city you will see the signs telling you the road to Sunny Corner ~ the arena is on North West Road about 10 minutes from this sign.

**FROM QUEBEC** ~ if you cross the province at the Plaster Rock ~ Renous highway you will come out at Renous Hwy #8 ~ turn left and head toward Miramichi City & follow above

**FROM BATHURST AND POINTS NORTH** ~ take highway #8 to the Miramichi ~ take the second exit after the Centennial bridge that crosses the Miramichi River follow the signs that lead to Fredericton ~ you will cross back over the river and follow Hwy 8 until you see the sign for Sunny Corner.

**FROM MONCTON ~ NOVA SCOTIA ~ PRINCE EDWARD ISLAND** ~ Take highway #11 north to the Miramichi then take the exit for Fredericton and follow Hwy 8 toward Fredericton until you see the sign for Sunny Corner. Or take Hwy 126 at Magnetic Hill to the Miramichi. After crossing the river take Hwy 8 toward Fredericton and follow directions above
