GENERAL:

- The Trial Secretary is in full charge of the Trials. Trial precincts consist of the outdoor trial area. Prong collars are NOT permitted on the property the day of the trials. Please no food, toys or clickers near the ring. Bitches in season are NOT permitted anywhere near the trial ring. Handlers in all classes may walk the course without their dog prior to the start of their class. There will be a supervised contact obstacle familiarization for Novice dogs only. Obstacles shall meet the specifications in the CKC Agility Rules & Regulations effective January 1st, 2012.
- To be eligible to compete in these trials, a dog must be 18 months of age and eligible for a registration with the CKC, have an ERN or CKC Misc. Certificate or a CKC Performance Event Number. Spayed bitches, debarked dogs and neutered males are eligible to compete.
- Bitches in season may not compete. When a bitch comes into season after the entry has closed, a Vet's certificate certifying the bitch was in season within a 10-day period preceding the trials must reach the trial secretary on or before the start of the first trial. A full refund of entry & listing fees will be given.
- No entries will be accepted, altered, cancelled or substituted after the official closing date and time for entries, except as provided in the rules. Exhibitors must abide by errors made in entering their dogs regardless of how and by whom the errors were made. Entries will be accepted only if accompanied by the correct fees. Courier entries will be accepted if no signature required. Tendering of an NSF cheque is considered non-payment of fees and is punishable by disciplinary action. A \$40 NSF service charge will be applied. Move ups will be allowed if received 1 hour prior to the trial starting or 15 minutes after the class the title was completed in. Flat carded & stringed ribbons will be awarded for qualifying scores & 1st through 4th placements. Title ribbons will be provided.
- Judging schedule will be emailed out asap after the closing date and will also be posted at www.dogranchinc.ca
- Foreign Exhibitors please note that fees are due and payable in Canadian dollars. Due to fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, in US funds. Please do not mark personal cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the bank. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.
- It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit, on receipt of a report indicating that this has occurred.
- Effective January 1st, 2011, CKC has implemented a Non-Member Participation Fee of \$57.60 + HST. This fee only applies to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of and will comply with the CKC Agility Rules and Regulations Effective Jan. 2014, a copy of which may be obtained by calling the Central Order Desk of CKC at 18002508040 (cost: \$6.00 + 13% hst)

Check in will start at 7:15 am and first dog on the line at 8:00 am

DIRECTIONS:

From the West: HWY-401 E toward **Cornwall**. Merge onto **HWY- 416 N** via **exit 721A** toward **Kemptville/Ottawa**. Take the Dilworth exit # 42. Turn left on to Dilworth Rd and drive 1 km. Turn right on to Fourth Line Road and in 8km you will reach the destination - 6361 Fourth Line Road.

From the East: HWY- 401 W toward **Kingston**. Merge onto **HWY-16 N** via **exit 721** toward **HWY- 416 N/Kemptville/Ottawa/RTE-416 N**. Take the Dilworth exit # 42. Turn left on to Dilworth Rd and drive 1 km. Turn right on to Fourth Line Road and in 8km you will reach the destination - 6361 Fourth Line Road.
