# **ERN - EVENT REGISTRATION NUMBER**

Effective Jan 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events, will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number *must* be applied for within 30 days of the first day of entering a CKC event. To obtain an ERN, mail or fax a photocopy of the dog's foreign registration certificate with cheque or Visa/MasterCard number (expiry date, cardholder's name and signature). Fee is \$58.85 per dog. #### **MORE OFFICIAL STUFF**

It shall be the duty and obligation of the show giving club to see that a judge is not subject to indignities. The Show Chair shall promptly report to the CKC any infringement of this regulation and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

#### **US CITIZENS ENTERING CANADA**

U.S. and Canadian citizens will need to present either a WHTI-compliant document (ie US passport, The Passport Card, or other acceptable travel documents), or a government-issued photo ID, such as a driver's license, **plus** proof of citizenship, such as a birth certificate. #### **NON-MEMBER PARTICIPATION FEE:** CANADIAN RESIDENTS ONLY

An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled. **These fees apply only to dogs wholly owned by non-CKC members and are not applicable to CKC members.** 

#### **CHAMPIONS & CHAMPIONSHIP POINTS**

SECTION 1: A dog awarded WINNERS of a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

Dogs Competing	1	2	3-5	6-9	10-12	13 +
POINTS ALLOCATED	0	1	2	3	4	5

indicates the dog awarded WINNERS

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for championship points.

To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex, and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder):
