## Regular Conformation Classes:

All Regular Classes, Intact & Altered, divided by sex:

6-9 months; 9-12 months; 12-15 months; 15-18 months

Novice; Canadian Bred; Bred By Exhibitor

Open Blue Merle; Open Red Merle; Open Black; Open Red

Winners: Best of Breed

Class winners to compete for Winners Dog / Winners Bitch.

Winners Dog & Winners Bitch will compete with Specials for BOB, BOS and BOW.

#### Non-Regular Conformation Classes:

2-4 month puppy; 4-6 month puppy, divided by sex. Class winners to compete for BOB Puppy & BOS Puppy.

Veterans 7–9 years & 10 years and over, divided by sex.

Class winners to compete for BOB Veteran & BOS Veteran.

#### Regular Junior Handling Classes:

Novice Junior 8-12 years; Novice Senior 13-17 years;

Open Junior 8–12 years; Open Senior 13–17 years.

Class winners to compete for Best Jr. Handler and Reserve Jr. Handler.

# Non-Regular Junior Handling Classes:

Pee Wee 3-5 years; Sub Junior 6-7 years.

Judging order for conformation: Altered; Non-Regular; Juniors; Intact

## Attention All Regular Intact and Altered Class Entries:

ALL dogs in Regular Conformation Classes must be at least 6 months of age or older on the day of the show and must be ASCA® registered.

All Pre-entries must be accompanied by a photocopy of each dog's ASCA® Registration.

Post-dated cheques are not accepted.

No entry shall be accepted for a dog or handler disqualified from the ASCA® Conformation program, a dog or handler disqualified from any ASCA® program, or a person not in good standing with ASCA®.

Entry fees will not be refunded if the dog is absent, disqualified, excused or barred from competition by the show committee, ASCA®, the show veterinarian or the judge.

Anyone having any dogs with or exposed to any communicable diseases within 30 days of these shows is NOT allowed to attend per ASCA® Rules.

A dog that is using a chip or chemical implant to lower hormone levels is not eligible to be shown in either Regular Altered or Intact classes (Sections 4.15.1 and 9.6 Show Rules)

# **COVID-19 PROTOCOLS**

**DUE TO COVID-19 REGULATIONS,** WE REQUEST THAT ATTENDANCE AT THIS SHOW IS LIMITED TO DOG OWNERS AND HANDLERS ONLY. We need to ensure that we comply with Ontario regulations.

COVID-19 WAIVER MUST BE FILLED OUT FOR EACH PERSON IN ATTENDANCE AND HANDED IN AT THE SHOW SECRETARY TABLE. Please fill in prior to coming to the secretary table; pens will not be available. Waiver must be handed in before armbands are handed out.

IF YOU CANNOT COMPLY WITH THESE RULES, DO NOT ENTER OR ATTEND! There will be a zero tolerance policy on COVID-19 violations, including not wearing a mask, not wearing a mask properly, or not social distancing when it is possible.

**Contact tracing** information must be provided for all who attend (name & phone number).

**Social Distancing** of 2 meters (6 ft.) is mandatory in the ring, in adjacent ring areas, at the Show Secretary table, and during Win Photography.

Each ring will have an Entrance, an Exit and Social Distancing Markers.

Exhibitors will pick up their placement **ribbons** as they exit the ring. NO RECYCLING of ribbons.

Exhibitors are encouraged to return to their setup after they have exhibited their dog.

Masks must be worn correctly over mouth and nose. This is mandatory.

Should COVID-19 regulations change and force cancellation of the shows, all entries will be promptly **refunded**.

Due to COVID-19 regulations, there will be **NO potluck lunch** at this event.

**Ring** will be **outdoors on grass.** Please observe parking and set up instructions at the facility.

Bring Your Own: Masks, sanitizer, popups, pens, chairs, food, drinks.

Please dispose of all your garbage in the designated containers.
