ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian Dollars. Due to the constantly fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian Funds. If you send a cheque in US Funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds. Your understanding and cooperation is appreciated. Thank You.

NON CKC MEMBER PARTICIPATION FEE - CANADIAN RESIDENTS ONLY

Effective Jan1, 2011 the CKC will be instituting a Non-Member Participation fee for all Canadian residents who participate in a CKC event but are not CKC members. In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled This applies to dogs wholly owned by non members resident in Canada and does not apply to U.S. exhibitors nor to CKC members or dogs co-owned with a CKC member

EVENT REGISTRATION NUMBER (ERN)

Effective Jan 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events, will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. MOVING UP – OBEDIENCE

CKC RULES AND REGULATIONS (EFFECTIVE JANUARY 01, 2008)

6.8.1 A dog that is registered in the records of the CKC or has a PEN, and ERN, or a MCN and has fulfilled the requirements for a title in accordance with these rules but at the time of the closing of entries for the trial has not received confirmation of the title may be moved to the next level of competition providing the request is submitted to the trial secretary on the appropriate move-up form by the owner or handler a minimum of one hour before the opening of the first trial on that day, schedule permitting.

6.8.2 When one or more trials are held on the same day in the same venue, the request for moving the dog up must be made a minimum of one hour prior to the scheduled start of the trial for which the dog is being moved up to, schedule permitting. The Trial Secretary shall amend the judge's book and the marked catalogue, which is to be sent to the CKC with the requests attached to the appropriate entry forms.

CLASSES – OBEDIENCE

Official CKC Classes Offered: Pre Novice, Novice "A", Novice "B", Novice "C" (Nov "C" only in Trial 182 & 184), Open "A", Open "B", & Utility.

Pre-Novice (Transition Class) - The Pre-Novice class shall be for dogs of any recognized or listed breed & of either sex which have not earned the title of P.C.D. (Pre-Companion Dog) in Canada

Novice "C" (Transition Class) - The Novice "C" class is open to any dog of either sex that has gained the title CD, CDX, UD or any other advanced Obedience title in Canada prior to the closing date of the trial in which it is to be entered. Exhibitors may enter more than one dog in this class but must have a separate handler for each dog in the Long Sit & The Long Down Exercises when they are judged in the same group. The Novice "C" exercises will be performed & judged as described in the official Novice Class except that exhibitors may compete in the Novice "C" Class indefinitely.

PERFORMANCE EVENT NUMBER (PEN)

Effective Jan 01, 2002, a Performance Event Number (PEN), allows an unregistrable dog of a CKC recognized breed to participate in those competitive events that are appropriate for the breed.. This restriction shall also apply to dogs with ILP numbers. Unregistrable Dog means, a dog of a recognized CKC breed that cannot be registered because of unknown parentage or the unavailability of its registration papers

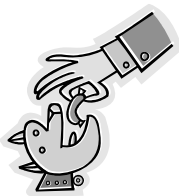

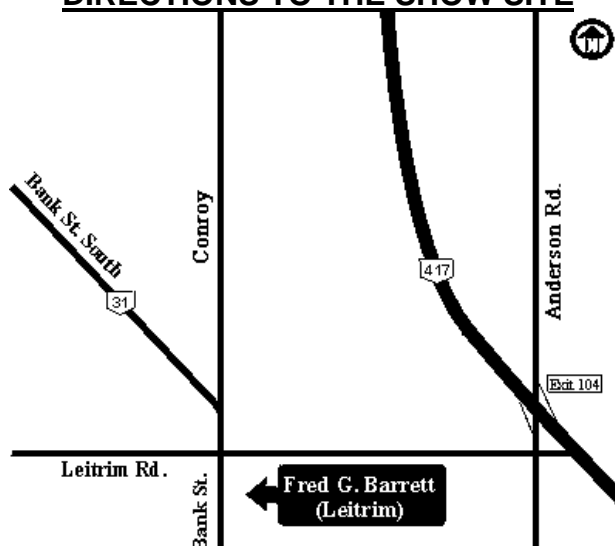
