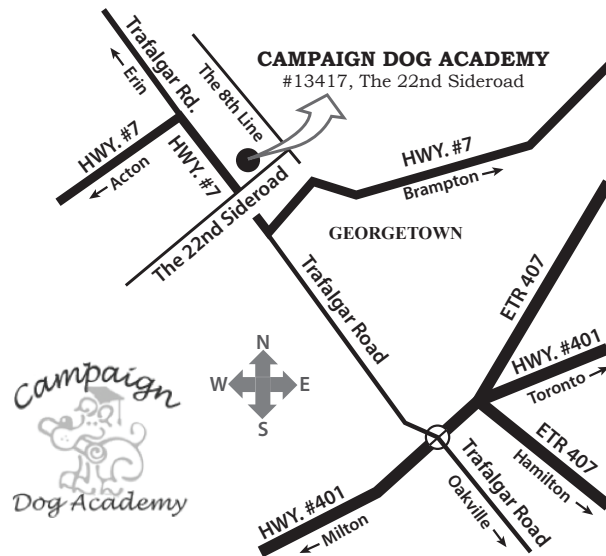

**OBEDIENCE  
TRIAL RULES AND  
REGULATIONS**

The Exhibitor is responsible for knowing and complying with the Obedience Rules and Regulations of the Canadian Kennel Club. **Chapter 19 - Section 19.7** of the Obedience Rules and Regulations states: It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward, volunteer, or competitor at an Obedience Trial held under these regulations, is not subject to indignities of any kind. The Obedience Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

**IMPORTANT  
NOTICE TO  
OBEDIENCE  
EXHIBITORS**

The Novice A Class shall be for any dog of any recognized or listed breed which has not earned the title of C.D. Only one dog per handler is allowed in this class, and that person must handle the dog in all exercises. The handler of any dog in this class must be the owner, co-owner, or a member of their immediate families, and must be eligible to handle as follows: No person who has trained or exhibited a dog that has earned a C.D.X. title shall be allowed to handle a dog in this class. The Novice B Class shall be for any dog of any recognized or listed breed which has not earned the title of C.D. Dogs in this class may be handled by the owner or any other person. A person may enter more than one dog in this class. No dog may be entered in both Novice A and Novice B Class at any one trial.

For a complete listing of Class Eligibility and Requirements, please refer to the Obedience Trial Rules and Regulations booklet.

As each handler enters the ring, the judge shall see that the dog has on either a well-fitting plain buckle (metal or plastic) collar, martingale, slip or quick release collar.

Slip collars of an appropriate single length of leather, fabric or chain with 2 rings, one on each end are acceptable.

Martingale collars may be of chain, fabric, or leather; or of the half-check type, with fabric or leather around the neck, and chain in the joining loop. Fancy collars, special training collars, or collars that are either too tight or so large that they hang down unreasonably in front of the dog, are not permitted.

There shall not be anything hanging from the collar.

**NON-MEMBER  
PARTICIPATION  
FEE**

Effective January 1, 2011:

- a) A non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC. The fee will be \$58.50 plus applicable taxes.
- b) The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
- c) In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee. Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- d) The fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

**EVENT  
REGISTRATION  
NUMBER (ERN)**

Effective Jan. 1/92, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). The ERN number MUST be applied for within 30 days of the first day of entering a CKC event. Fee is \$58.50 per dog after January 1, 2012 plus applicable taxes.

**GENERAL  
INFORMATION**

1. The Trial Superintendent will be in full charge of the trials which will be governed by CKC Rules.
2. The Cavalier King Charles Spaniel Club of Canada will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
3. If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the trials, no refund of entry will be made.
4. Judging will commence at 8 a.m. each day on Saturday and Sunday. A later starting time may be specified in the judging schedule. Starting time of each ring will be specified in the judging schedule.
5. TRIAL PRECINCTS: The trial precincts shall consist of the entire precincts of the Campaign Dog Academy building. Only those dogs entered in the Trials will be allowed within the trial precincts.
