The draw will be held in accordance with the CKC rules, January 1, 2014 (section 6.6.1.6.6.2.p 18). Cancellations prior to the draw are to be made to the Field Trial Secretary e-mail <u>savannah.st.denis@outlook.com</u> or phone 905-914-1826.

Non CKC members who are Canadian, running a wholly-owned dog, cannot win a placement unless they pay a non-member fee to the CKC. Otherwise, Awards and Titles will be cancelled. The fee will be paid directly to the CKC.

Payment: Make cheques payable to the PINE RIDGE RETRIEVER CLUB, dated no later than MAY 17, 2023. A listing fee of \$11.30 must accompany the entry form of any dog for which an individual CKC registration or ERN number is not shown.

Presentations will be made at the Tailgate, Saturday evening, Sunday and Monday upon completion of each stake. Excerpt from CKC Retriever Field Trial rules and regulations, dated 1 January 2011, 21.7 P 67 "It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Retriever Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred"
