#### **EVENT REGISTRATION NUMBER**

Effective January 1, 1992, all dogs that are foreign born and foreign owned and enter Canada for the sole purpose of entering CKC events will no longer require a CKC registration number but will require an Event Registration Number (ERN). Application for the ERN number MUST be submitted within 30 days of the first day of entering a CKC event.

#### TRACKING FEE - Non CKC Member Canadian Resident

Effective January 1, 2011 the CKC instituted a tracking fee for all Canadian residents who participate in a CKC event but are not CKC members. In order to protect any points and awards earned at any CKC event, a resident non-member can choose to become a CKC member or pay the tracking fee of \$55 for each dog. Failure to comply with 30 days of notification will cause all awards and titles to be cancelled. This applies to dogs wholly owned by non-members resident in Canada and does not apply to U.S. exhibitors nor to CKC members or dogs co-owned with a CKC member.

#### TRIAL RULES AND GENERAL INFORMATION

- No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
- Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone, e-mail and fax entries cannot be accepted.
- The club reserves the right to remove any person from the Show. The Trial Committee shall have full control of the shows & trials, which will be governed by CKC RULES.
- The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune to either dogs, exhibitors or patrons.
- Exhibitors are solely responsible for the conduct or actions of their animals while they are on the Show grounds.
- The owner of dogs entered in these shows is entirely responsible for any error in entering dogs, regardless of how or by whom the entry was made.
- For the benefit of the health of animals and the pleasure of exhibitors and spectators we insist upon keeping the grounds as clean as possible. Exhibitors are responsible for cleaning up after their dogs.
   Please exercise your dog BEFORE taking it to the ring.
- Dogs must be exercised in DESIGNATED AREAS ONLY, not in the ring areas.
- If because of riot, civil disturbance or other acts beyond control of the Club, it is impossible to open or complete the show, no refund of entry fees will be made.
- IT WILL BE THE SOLE RESPONSIBILITY OF THE EXHIBITORS TO HAVE THEIR DOGS AT RINGSIDE when necessary. There will be no paging of individual dogs.
- Dogs must be on leashes at all times on the show grounds or in the show building with the exception of the Rally-Obedience rings.
- Exhibitors are responsible for their children while at the show and will be held accountable for any damages caused by children playing unattended
- The entire show site is designated as NO SMOKING.
- Bitches in season are not permitted to compete or be in the show building during the trials. If bitches come into season after the closing date, a veterinarian's certificate stating that the bitch was in season within the ten day period before the trial must be in the Trial Secretary's hands before the start of that day's trial in order to obtain a refund of entry fees.
- All entries must be typed or distinctly printed. Owners are responsible for errors on the entry forms. The OVPC does not assume any responsibility for incorrect information or for errors due to illegibility of information on an entry submitted by the owner or agent, or for entering a dog in a class in which the dog is not eligible to enter or compete. Entries must be signed by the owner or agent or the entry will be rejected.
- As per the CKC Obedience Rules (January 1, 2012) NO food, treats or training aids shall be allowed within 2.54m (10 ft) of the ring entrance.

#### **PRIZE LIST**

Prizes will be awarded for qualifying scores only.

- A qualifying ribbon will be awarded to all dogs obtaining a qualifying score.
- A Prize and a Rosette will be awarded for the HIGHEST SCORING DOG IN EACH CLASS Ribbons will be awarded for  $2^{ND}$ ,  $3^{RD}$  AND  $4^{TH}$  PLACE IN EACH CLASS
- A Prize and a Rosette will be awarded for HIGH IN TRIAL
- The Ottawa Valley Poodle Club offers a Perpetual Trophy and a Rosette for the HIGHEST QUALIFYING OBEDIENCE POODLE in the regular classes on SUNDAY from either Trial, donated by L.A. Woods in memory of "Leeds". The Club will retain possession of the trophy with proper inscription. s

- A Rosette will be awarded for EACH NEW TITLE EARNED


