## DKC Trial Guidelines

Exhibitors will enter the venue through the door at the back of the parking lot to the rear of the building where they will check in and collect their armband. This is the only entrance that will be used in the trials as the facility is open to patrons in the front bar area on Saturday from 1-5 only.

Masks are not mandatory but please consider others if you are not normally in their company and keep your distance. Hand Sanitizer will be available throughout the venue.

Crating will be available in the large room connected to the front lobby. Please try to keep loose fur to a minimum. All dogs must be in control and on leash except during the test. Exhibitors may gather there before and after their searches.

DKC respectfully asks "hide" information not be shared with other competitors and that no posting of testing be placed on social media until the end of the trial weekend.

The only dog permitted in the trial area is the dog being tested.

### Reminders Pertaining to the Venue

Food and drink are allowed in the crating area (please remember that facility is licenced and make safe food choices). Refrigerator is available. Coffee & Tea will also be available.

Local Eateries in nearby Fall River include A&W, McDonald's, Dairy Queen, Jessey's Pizza, China Star Tim Hortons, Sobey's. All are roughly 5 mins away.
