There will be a system of rotation for running order in both stakes.

Any entry scratched after the catalogue has been printed, will require a veterinary certificate for any refund. A \$5.00 administration fee will be deducted from all refunds.

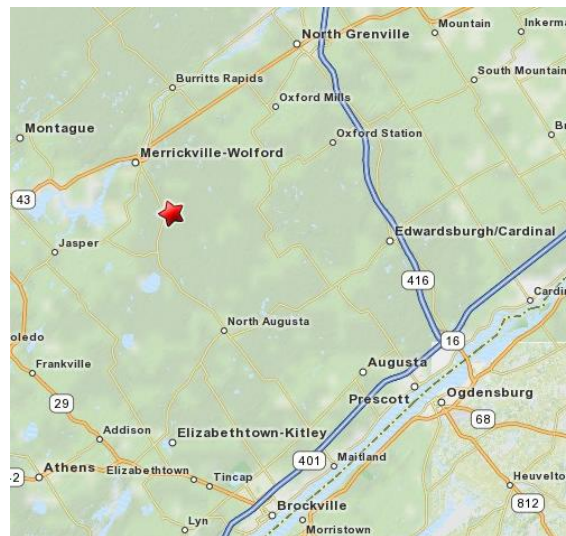
### **RELEASE AND INDEMNIFICATION OF LANDOWNERS AND OTTAWA RETRIEVER CLUB**
