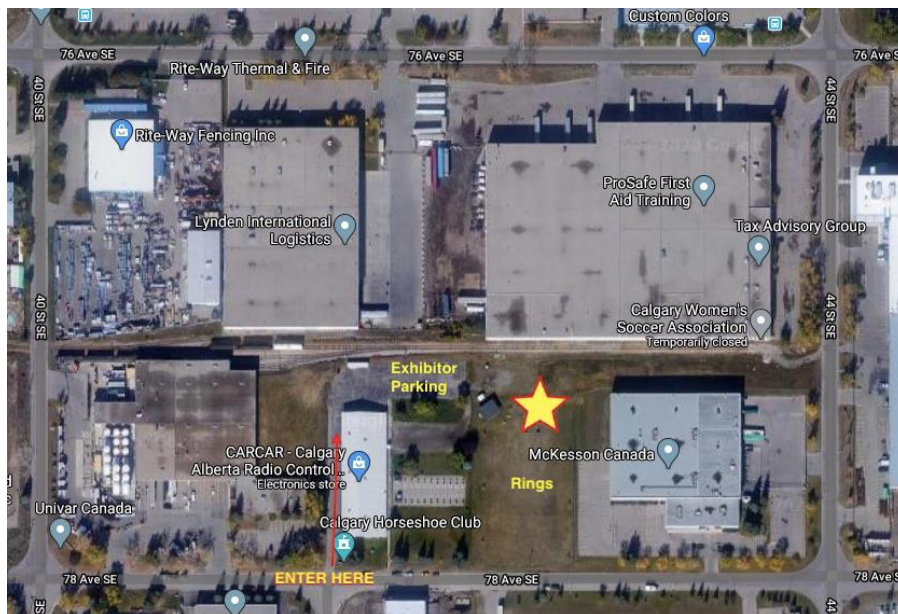
Lunch/refreshments will not be provided at this trial.
