LIMITED ENTRY

The Judging schedule is based on the formula of 8 Novice dogs/hour, 7 Open dogs/hour and 6 Utility dogs/hour .Obedience (CKC Rule 4.3.5). 20 dogs per hour Rally

When the advertised limit has been reached, all remaining entries may be assigned a position (by class) on the reserve list. The person making the entry shall be notified of his/her position on the list. In the event that the entry of a bitch in season is pulled after closing date, it may be substituted with one from the reserve list up to and including the day of the trial. Entry fees will be refunded within ten days following the trial for those on the reserve list who did not participate in the trial. (CKC Rule 4.4.2)
