GENERAL INFORMATION

- On the day of the show, the show superintendent will be in complete charge of the show.
- Receipts must be presented at the entrance of the show premises. Only dogs properly entered in the show will be admitted.
- The building will be opened 1 (one) hour before the start of the show.
- Dogs may be removed from the building when not required for further judging.
- Dogs **must not** be left in the building overnight.
- Judging will proceed without any dog not present when called by the ring steward.
- The show committee will use due care and diligence for the welfare of the dogs and the exhibitors, but will not be responsible for, or assume any liability, in the event of an accident or other misfortune to either dogs, exhibitors or patrons.
- If because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fees will be made.
- We regret that trailer hook up **will not** be available at the show site.
- It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at any event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation. The Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
- The show grounds are defined as the confines of THE S.W. MOORES MEMORIAL STADIUM, BANNERMAN STREET, HARBOUR GRACE, NL.
- The authorities of the shows may decline to accept entries for just cause, and/or refuse to receive or may remove any dog from the show building on account of viciousness or disease.
- NO SMOKING is permitted in or around this venue.
- **IT IS YOUR RESPONSIBILITY TO PICK UP AFTER YOUR DOG. IF YOU CAN IDENTIFY AN EXHIBITOR NOT CLEANING UP AFTER THEIR DOG, PLEASE NOTIFY THE SHOW SECRETARY OR SUPERINTENDENT IMMEDIATELY AND THAT EXHIBITOR WILL BE ASKED TO PROCEED OUTSIDE IMMEDIATELY AND CLEAN UP AFTER THEIR DOG. THERE IS NO EXCUSE NOT TO CLEAN UP AFTER YOUR DOG. POOP BAGS WILL BE PROVIDED AT THE ENTRANCE FOR THIS PURPOSE.**
