1. The facility will open on Saturday at 8:30am General Briefing at 8:55am First Run Starts at 9:30am
The facility will open on Sunday at 8:00am General Briefing at 8:25am First Run Starts at 9:00am
2. There will be no Late Entries nor Day of Show Entries accepted.
3. Trials will be held indoors in the Owl Barn at Swamp Dog Farm on rubber matted concrete floors. Outdoor blind of 10' x 20' will be used. No indoor crating is available. Classes will be alternating between 2 rings.
4. Parking is near the barn and will be designated
5. There is no kitchen or kitchen area at the trial site. Morning tea and coffee will be made available and we are planning a potluck for Saturday lunch and reserving for dinner at the Driftwood Restaurant. Sunday lunch we are planning on a sandwich bar. More information will be forthcoming.
6. The site is wheelchair accessible. There are two portable toilets outside the barn, and one is wheelchair accessible

8. Competitors with multiple dogs will run in different staging groups.
