Caro Rules

This event adheres to CARO rules and regulations. CARO is open to all breeds of dogs and mixed dog breeds. Dogs must be at least six (6) months of age to compete in a CARO event. Bitches in season, dogs with injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans may not participate.
