# **Rules and Regulations:**

#### GENERAL INFORMATION AND REGULATIONS

- 1. Dogs must be kept on a leash at all times on the show grounds or within the show building.
- 2. The Club reserves the right to remove any person from the show. The Show Superintendent shall have full control of these shows and trials, which will be governed by CKC rules.
- 3. ANYONE PARKING IN THE FIRE LANES OR OTHER AREAS DESIGNATED AS "OFF LIMITS" WILL BE REMOVED FROM THE SHOW
- 4. All recreational units must have buckets underneath for their drains. Those discharging of any water on the grounds will be removed by order of the health department and subject to a fine.
- 5. A judge officiating at this show held under CKC rules shall not be subjected to any indignities of any kind during the progress of the show. (4.7.1)
- 6. A show-giving club will be held responsible during the show for the conduct of exhibitors and spectators. Any person acting in an abusive or objectionable manner must be removed from the show on complaint to the Show Superintendent (5.1.6)
- 7. There is to be NO SMOKING in the large show tent, nor entrances to it, and NO SMOKING is allowed in the show building.
- 8. Dogs must be on the show grounds 1 hour prior to judging of their breed.
- 9. All vehicles are left on the show grounds at your own risk. No security is provided.

#### 10. No abuse of parking personnel, NACA members or volunteers will be tolerated!!

11. RV's will not be allowed to travel on the show grounds when judging is occurring. Under special circumstances (in case of emergency) the show superintendent will stop the show and parking personnel will assist in the safe removal of vehicle.

#### EXTRACTS FROM THE DOG SHOW RULES - BREEDS, CLASSES, AWARDS AND STAKES

#### **CONFORMATION CLASSES OFFERED:**

12.2.1 Regular official classes at a CKC conformation show shall be as described in this section. All classes must be divided by sex (except for Specials Only). Only dogs entered in one of the regular, non-regular, or unofficial classes shall be allowed within the show precincts.

JUNIOR PUPPY: shall be for dogs at least six months of age and under nine months of age on the day of the show.

**SENIOR PUPPY**: shall be for dogs 9 months of age and under twelve (12) months of age on the day of the show.

12-18 MONTH - for dogs over 12 months of age but under 18 months of age.

CANADIAN BRED: shall be for dogs born in Canada, Champions of any country excluded

**BRED BY EXHIBITOR**: shall be for dogs owned and handled in the ring by the Breeder. The handler must be the owner/co-owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class, but need not handle the dog for further awards. **OPEN CLASS**: shall be for all dogs.

**VETERANS CLASS**: for all dogs over 7 years of age on day of show. These dogs will compete for regular placements and the winner of this class will go on to compete for Best of Breed. Dogs competing in the Veteran Class **may be spayed/neutered**. This class may, at the discretion of the club, be divided by age into not more than three age divided classes.

**SPECIALS ONLY**: is for dogs which have a recorded CKC Registration or Event Registration Number and have attained the required points for Championship status including at least one 2 point win either at the breed or group level. Should a dog which is entered in this class be found either not to be registered or has not completed the requirements for Championship status, all awards earned at the show will be cancelled. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy if eligible.

**BABY PUPPY** Dogs 3 months of age and under 6 months of age on the day of the show. The award for this class are: Best Baby Male and Best Baby Female Best Baby Puppy in Breed Best Baby Puppy in Group Best Baby Puppy in Show

#### JUDGES

SECTION 19.7 It shall be the duty and obligation of the show-giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.

Attention Foreign Exhibitors: Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you pay by credit card, bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated.

#### Entries sent by Greyhound must be sent prepaid;

To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching our Show Secretary after the closing time and date.

### Please allow ample time for delays in the mail.

**Exhibitors Please Note:** An exhibitor has the right to withdraw an entry at any time up to the closing date and time as published in the premium list. This may be done by telephone but **written or electronic notification must be received by the show secretary not later than closing date and time.** If written or electronic notification is not received, the dog will remain entered in the show.

There will be no refunds on duplicate entries or overpayments.



# **Extracts From CKC Dog Show Rules**

#### Chapter 8 Entries and End of Show Section

**8.2.5** An error in an age specified class, date of birth or sex may be amended on the entry form up to one hour before the start of the show.

**Section 8.3.1** Entries: Every dog entered in a Championship show must be one of the following:

- a) registered with the CKC,
- b) have an Event Registration Number,
- c) be eligible for registration with the CKC, or
- d) if it belongs to a listed breed, it must have a Miscellaneous Certification Number (MCN).

**Section 8.4.1** Listed Dogs: If a dog is not registered as in 8.3.1 (a) or (b) but is eligible for registration with the CKC, it may be entered at a show as a listed dog provided:

- b) that if born in Canada, it is eligible for individual registration;
- c) that if not born in Canada, is eligible for registration in the records of the CKC.
  d) that if it is a foreign born and owned dog, an Event Registration Number or CKC registration number is obtain from the CKC within 30 days of the first show entered. Section 8 4.2 Entry of a listed dog at a show must be accompanied by a listing fee as set by the Board in addition to the regular entry fee.

**Section 8.5.1** Acceptance of Entries: If indicated in the premium list, an electronically transmitted entry may be accepted provided the entry is accompanied by a credit card charge authorization.

**Section 8.5.3** No entry shall be accepted from or on behalf of any person who is officially known to be expelled, deprived of privileges, debarred or suspended by the CKC or any other registering body for pure bred dogs.

**Section 8.5.4** After entries close, no further entries may be accepted, cancelled or substituted other than as otherwise stated in this section or as provided for in case of a postal strike.

Section 8.6.1 Refusal of Entries: The authorities of any show may:

- a) decline to accept entries for just cause, and/or
- b) refuse to receive or may remove any dog from the show building on account of disease or viciousness.
- c) in the case of non-acceptance, refund the fee with the reason for non-acceptance. Section 8.8.2 Fees: Tendering of a dishonoured cheque or declined credit card in payment of an entry fee shall be considered non-payment of said fee and is an offense punishable by disciplinary action and cancellation of awards.

Section 8.9.1 Moving a Dog to Specials: A dog which is individually registered in the records of the CKC or that has a Miscellaneous Certification Number (MCN) and has completed the requirements for a Championship in accordance with these rules but at the time of the closing of entries for a show has not received confirmation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in writing by the owner or handler at least one hour prior to the opening of the show.

**Section 8.9.2** If it is established that a dog transferred to Specials Only has not completed the Championship requirements, all awards will be canceled and all ribbons and prizes won shall be forfeited. The owner may also be subject to disciplinary action.

**Section 8.9.3** When one or more All-Breed and/or Specialty Shows are held on the same day, in the same venue, the moving of class dogs to Specials must be made prior to the scheduled opening of the first show.

Chapter 4 Judges Section 4.1.3 A judge officiating at a show held under these rules shall not be subjected to indignities of any kind during the progress of the show. It shall be the duty and obligation of the club holding the show to see that this rule is effectively carried out.

**Section 4.1.6** No person may approach a judge either directly or otherwise, orally or in writing, to favor his entry. Disciplinary action will be taken against any person who violates this rule or against a judge who fails to report any contravention of this rule to the CKC within 14 days of the act.

# Chapter 14 Disqualifying or Excusing Dogs

Section 14.1.2 (a) At his discretion, a judge shall have the authority to excuse or disqualify a dog which menaces, threatens, attempts to bite or bites the judge, another person, or another dog in the ring. When a dog is twice excused on this account, it shall have the status of a disqualified dog.

(b) At his discretion, a judge shall have the authority to permanently disqualify a dog which bites the judge or another person in the ring. Dogs disqualified under this provision will not be eligible for reinstatement. The decision to permanently disqualify a dog must be clearly indicated on the Judge's Disqualification Form. Section 14.1.4 Once a dog has been disqualified for any reason at a conformation show, it may not be entered or shown at another show until

the dog has been reinstated by the CKC. All awards earned by a dog shown in violation of this section will be cancelled by the CKC and the owner of the dog is subject to disciplinary action. A dog disqualified under section 14.1.2 (b) is not eligible for reinstatement.

Section 14.1.5 Any dog that is disqualified under section 14.1.2(a) shall automatically be disqualified from entering in any CKC event in any other discipline until such time as the dog is officially reinstated, if the dog is eligible for reinstatement.

#### **Championship Points and Cancellations**

**Section 15.1.1** A dog awarded Winners at a conformation show shall be credited with a number of championship points (ranging from 0 to 5) and the number of championship points credited to a dog awarded Winners shall be as provided hereunder.

Section 15.1.2 The schedule to be employed in the determination of the number of points awarded Winners shall be as follows:

points awarded winners shan be as follows.						
Dogs competing*	1	2	3 -5	6-9	10-12	13 & more
Points allocated	0	1	2	3	4	5

\*Includes the dog awarded Winners.

In counting the number of eligible dogs in competition, a dog that is disqualified, dismissed, excused or ordered from the ring by the judge shall NOT be included in the calculation for championship points.

Section 15.1.3 If a Dog awarded Winners was also awarded Best of Breed then at the show all dogs competing in the breed, including Specials Only, shall be included the total.

**Section 15.1.4** If a Dog awarded Winners is also awarded Best of Opposite Sex to Best of Breed, then all dogs of the same sex including those competing for Specials Only shall be included in the total.

Section 15.1.5 If a Dog awarded Winners is also awarded Best of Winners, then all dogs defeated directly or indirectly in the breed shall be included in the total.

Section 15.1.6 If a dog is awarded Winners only, then all the dogs of the same sex in the class competition shall be included in the total.

**Section 15.1.7** The number of championship points to be credited to a dog awarded Winners shall be determined by the highest award earned and calculated as per this section.

**Clarification:** Example of directly or indirectly defeating: If the Winners Bitch is awarded Best of Opposite Sex but not Best of Winners, the Best of Winners Male shall be deemed to have indirectly defeated the Specials Bitches, and is thus entitled to add them to the number of dogs and bitches defeated.

Section 15.1.8 In addition to championship points allocated at the breed level, a dog awarded Winners which also places in the regular Group competition shall be credited with the following additional points provided that the dog was defeated at the Group level.

Section 15.1.9 A dog may not be credited with more than 5 championship points in a single show:

Section 15.1.10 A breed or class shall not be allowed more than 2 sets of championship points per sex on any day in the same venue.

**Section 15.1.11** A dog awarded Winners which also places Best in Show at an allbreed conformation show shall be credited with 5 championship points inclusive of any points earned at the breed and group level.

Section 15.1.12 In order for a dog to be recognized as a Champion and its owner provided with a Championship certificate, the dog must:

- (a) earn at least 10 championship points under at least 3 judges; and,
- (c) have earned at least one 2 point win either at the breed or group level.
