## ELIGIBLE ENTRIES

- Open to the following breeds: Afghan Hounds, Azawakhs, Basenjis, Borzois, Deerhounds (Scottish), Greyhounds, Ibizan Hounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Whippets and (Irish) Wolfhounds that are one year old or older on the day of the trial.
- Listed breeds designated as Sighthounds are eligible to enter provided they have a Miscellaneous Certification Number (MCN)
- All entrants must be registered, or eligible for registration, with the Canadian Kennel Club or have an Event Registration # (ERN), Performance Event # (PEN), Miscellaneous Certificate Number (MCN) or a Temporary Competition Number (TCN).
- Hounds presently disqualified under any jurisdiction cannot compete. Hounds with breed disqualifications, altered, or neutered are eligible to enter the lure coursing trial.
- Hounds must be pre-qualified before entering their first trial in Canada. The original signed certificate must be submitted to the Field Trial Secretary with the entry form.

## Running Order

Both Days: Breeds will be run in the order of Basenjis, Italian Greyhounds, (Irish) Wolfhounds, Rhodesian Ridgebacks, Pharaoh Hounds, Ibizans, Deerhounds (Scottish), Afghan Hounds, Azawakhs, Borzois, Greyhounds, Salukis, Whippets, Mixed, Singles, with Unofficial classes to follow.

## **AWARDS**

<b>3rd place</b> -	2 X number competing to a total of <b>20 points</b>
<b>4th place</b> -	1 X number competing to a total of <b>10 points</b>
<b>NBQ</b> -	No Points

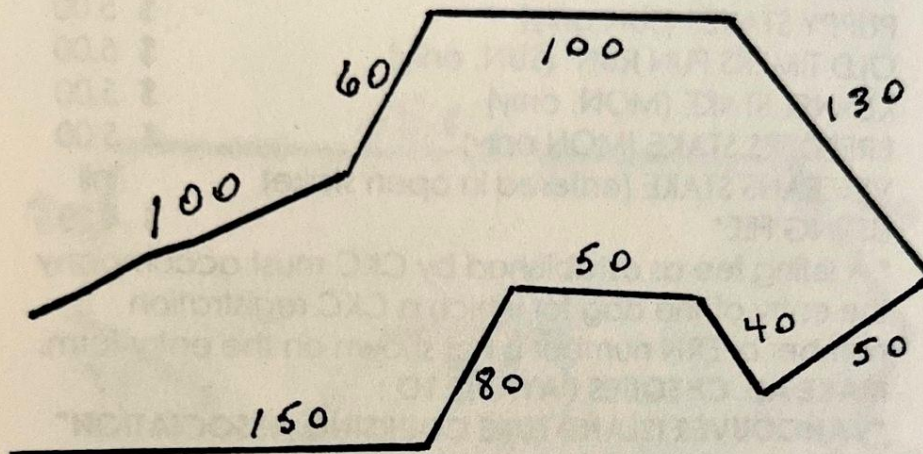
**TCN fee (per show/per dog) \$ 10.50.** TCNs are replacing the current system of entering events with dogs as "listed" and allow dogs to temporarily participate in CKC events while they pursue permanent registration or an Event Registration Number (ERN).

**All owners of unregistered, CKC-recognized breeds entering events are required to obtain a *Temporary Competition Number (TCN)*. [TCN instructions.](#)**

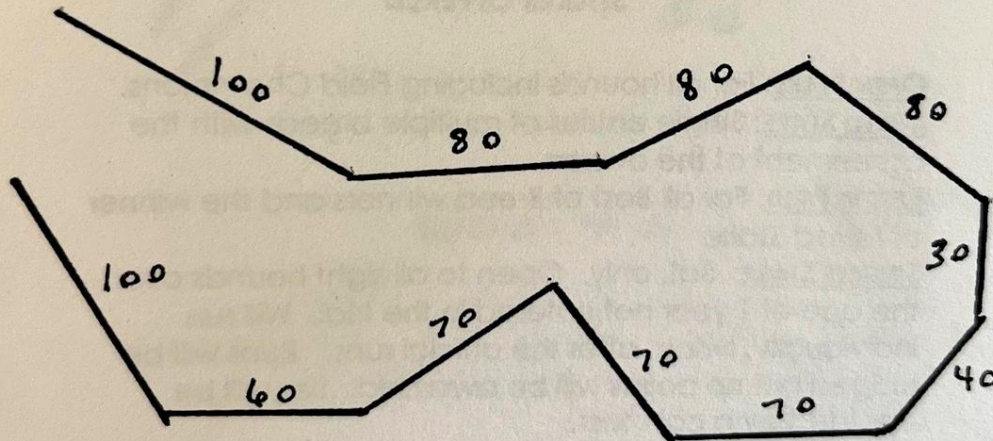
## COURSE PLANS

### Directions to Cuthbert Farms

From South Island: Drive north on the Island Hwy, through Ladysmith. Turn right onto Cedar Road then turn left on Adshead road.

From North Island: Drive south along the Island Hwy, past the Nanaimo (Cassidy) Airport. Turn left onto Cedar Rd and left on Adshead road.

**Look for VILCA signs along Adshead road directing you to the correct field as the exact field location depends on the harvesting schedule. Follow signs and please do not stop at the farm to ask directions.**

### Non-Member Participation Fee (April 2011)

- Non-member participation fee will be charged to a resident of Canada who is a non-member of the CKC.
  - The non-member participation fee is paid in any year a title is earned and covers all titles and dogs owned by that individual.
  - In order for the title to be awarded, the non-member will have a choice to either become a CKC member or pay the non-member participation fee.
- Failure to comply within 30 days of notification will result in the title being withheld and the dog cannot be moved up to the next level.
- All Premium Lists will carry a note stating the fee applies only to dogs wholly owned by non-member residents of Canada and is not applicable to CKC members.

### STAKES OFFERED

**OPEN STAKE:** All hounds including Field Champions.

(**New Rule 9.1.3**) The following description applies to individual breed stakes:

*The trial-giving club must, when the entry in the regular stake reaches 20 or more present after roll call, divide the stake as evenly as possible. There should be a minimum of 10 in each stake.*

**MIXED STAKE:** Multiple breeds with 3 or less with the agreement of the owners.

**SINGLES STAKE:** Hounds run alone. The title of Single Novice Courser will be awarded to any hound who attains 3 qualifying scores under 3 different judges. Open to ineligible/uncertified hounds. A hound entered in the Singles stake shall be barred from competition in the Open or Veteran stakes at the same trial. Entry may be **limited** on Saturday.

**VETERAN HIGHEST SCORE:** Saturday and Sunday, Hounds designated as veterans on entry form and entered in Open or Mixed Stake will be eligible for a prize.

**PUPPY FUN RUN Sunday:** For puppies whose age on the day of the trial is six months, but less than 18 months and who are not entered in the trial. Puppies will run once individually on a shortened course and scored. Placements of first through NBQ may be awarded but will not count for points. This stake may be divided by age.

**OLD TIMERS FUN RUN Sunday:** For any hound seven years of age or older the day of the trial and not entered in the trial. Old Timers will be run once individually on a shortened course and will be scored. Handicap of 2 pts will be added for each year over seven. (8 years = judges score + 2 pts)

## ADDITIONAL INFORMATION

“It shall be the duty and obligation of the trial-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Field Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the CKC shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.”

An opportunity to certify your Hound may be pre-booked **for Friday afternoon**. You will need a coursing jacket for your hound for certification. Please do not ask to certify a hound that has never seen the lure before – our suggestion is that you enter your hound in singles

## RULES GOVERNING THESE EVENTS

1. **Unless coursing, hounds must be leashed at all times AND NO FLEXI-LEASHES. A \$10.00 fee will be levied for any hound loose on-site property.**
2. **Please pick up after your hound. Bags are available on site. Leave the field site just as you found it – clean. We would like to be able to use the field in the future.**
3. Stakes will be split if the entry of a breed reaches 20 or more at Roll Call.
4. Bitches in season or lame hounds will have their entries refunded provided notice is given at, or before Roll Call.
5. Hounds not present at Roll Call will be scratched and their entry fee will not be refunded.
6. A valid rabies certificate is required to bring a dog into Canada.
7. U.S. cheques cannot be discounted. To take advantage of the exchange, please pay with a Canadian money order.
8. Paper entry forms not same size and format as the official CKC entry form, will be rejected. You will be asked to complete a new one. Please use the forms provided.
9. A toilet facility will be provided on the Cowichan Exhibition grounds.
10. Please bring water for your dogs as water is not guaranteed to be available on all sites.
11. Please bring your own shade/rain cover as the Club doesn't provide.
12. **Park in designated areas only to minimize damage to the field**

### RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

By signing this document you will waive certain legal rights, including the right to sue or claim compensation following an accident. Please read this document carefully.

In consideration of the acceptance of the entry and the opportunity to have the dog judged and to win a ribbon at the Lure Coursing Trials held on September 30 & October 1, 2023,

I agree:

1. To hold the Vancouver Island Lure Coursing Association including their members, directors, officers and employees (collectively defined as VILCA), as well as the owner and lessor of the real property on which the event is held, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of myself or my dog(s) while in or about the event premises or grounds near the entrance thereto and I assume all responsibility and liability for any such claim.
2. To hold VILCA harmless from any claim for loss of this/these dog(s) by disappearance, theft, death or otherwise and from any claim for damage or injury, even if such loss or damage/injury was caused or alleged to be caused by the negligence of the VILCA or any other person(s).
3. Assume the sole responsibility for and agree to indemnify, defend and save the VILCA harmless from any and all loss and expense, including legal fees, by reason of the liability imposed by law upon the VILCA for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person(s), including myself or on account of damage to property, arising out of or in consequence of my participation in the event, however such injuries, death or property damage may be caused and whether or not the same may have been caused or alleged to have been caused by the negligence of the VILCA or any other person(s).
4. That any cause of action, controversy or claim arising out of or related to the attendance at the event between the VILCA and myself or as to the construction, interpretation and effect of this waiver shall be settled by arbitration in the province of British Columbia; and
5. That VILCA has the right to refuse this entry for cause, which the VILCA will deem sufficient.

## HOUND CERTIFICATION

Rules effective (26-06-2010), Chapter 7, Section 7.1.1 (a). A hound must be tested with another dog, of the same breed or a breed with a similar running style, preferably not a kennel mate, and certified running clean by a licensed judge. Hounds must be a minimum of 11 months old prior to being certified and must run a course of at least 600 yards in order to be certified.

**Please complete the bottom half of this form and attach it to the entry form for the hound's first entry in a trial. Remember to keep a copy for yourself.**

**Waiver of Requirement:** This requirement will be waived for a hound that has earned a lure coursing title from another organization if such title required competition, and if a waiver for such title has been approved by the Canadian Kennel Club. If your hound qualifies for a waiver complete the top half of this form and attach to your entry form,

- All hounds must be a minimum of 11 months of age prior to being certified.
- All hounds must run a normal course of 600 yards in order to be certified.
